## The situation concerning the Democratic Republic of the Congo

Eighth report of the Secretary-General on the United Nations Organization Mission in the Democratic Republic of the Congo (S/2001/572)

**The President:** The Security Council will now begin its consideration of the item on its agenda.

The Security Council is meeting in accordance with the understanding reached in its prior consultations.

Members of the Council have before them the eighth report of the Secretary-General on the United Nations Organization Mission in the Democratic Republic of the Congo, document S/2001/572, and the report of the Security Council mission to the Great Lakes region, 15-26 May 2001, documents S/2001/521 and S/2001/521/Add.1.

Members of the Council also have before them document S/2001/587, which contains the text of a

draft resolution prepared in the course of the Council's prior consultations.

It is my understanding that the Security Council is ready to proceed to the vote on the draft resolution before it. If I hear no objection, I shall now put the draft resolution to the vote.

There being no objection, it is so decided.
