Letter dated 1 August 2001 from the Permanent Representative of the Democratic Republic of the Congo to the United Nations addressed to the President of the Security Council

On instructions from my Government, I have the honour to transmit to you a press release issued by the Government of the Democratic Republic of the Congo on 31 July 2001 denouncing the decision by the Executive Committee of the Rassemblement congolais pour la démocratie (RCD-Goma) to establish so-called "federalism" in Congolese territories under Rwandan and Ugandan occupation (see annex).

The Security Council may also like to follow up the submission by my Government concerning the expansionist ambitions of Rwanda and RCD-Goma for the establishment of a secessionist State in the eastern provinces of the Democratic Republic of the Congo (S/2001/694).

My Government would again like to focus the full attention of the Security Council on this fresh violation of the founding principles of the charter of the Organization of African Unity regarding the inviolability of the borders that emerged from decolonization, which is also a violation of the purposes and principles of the Charter of the United Nations, and the relevant provisions of all the Security Council resolutions reaffirming the sovereignty, territorial integrity and political independence of the Democratic Republic of the Congo and of all the States of the region.

My Government calls on the Security Council:

- 1. To condemn emphatically this fresh attempt by Rwanda and RCD-Goma to establish a "State" in the occupied provinces;
- 2. To demand that all the States of the region respect the sovereignty, territorial integrity and political independence of the Democratic Republic of the Congo, by, inter alia, refraining from any action incompatible with the purposes of the United Nations, including action likely to bring about secession and partition in the Democratic Republic of the Congo;
- 3. Also to demand, under Chapter VII of the Charter of the United Nations, the immediate and unconditional withdrawal of Ugandan and Rwandan forces from the territory of the Democratic Republic of the Congo, in accordance with the relevant provisions of the Security Council resolutions on the situation in the Democratic Republic of the Congo;

4. To take enforcement action against Rwanda and RCD-Goma so as to deter them from moving ahead with their disastrous and ill-fated operation to Balkanize and dismember Congolese territory in order to satisfy Rwanda's expansionist ambitions.

I should be grateful if you would have this letter and its annex circulated as a Security Council document.

Government press release

Government denounces attempts to partition the country by Rwanda and its allies in the Rassemblement congolais pour la démocratie

The Government of the Democratic Republic of the Congo denounces in the most emphatic manner the decision by the rebel movement Rassemblement congolais pour la démocratie (RCD) to establish so-called federalism in the territories occupied by Rwanda and Uganda in the Democratic Republic of the Congo. This decision represents yet another attempt by the aggressors to torpedo the peace process and undermine chances for the prompt holding of inter-Congolese dialogue. By their repeated actions, the Rwandan aggressors and their RCD allies are seeking pretexts for a resumption of hostilities.

Having failed in their campaign to give credence to the idea that the Congolese Government was responsible for the resumption of fighting behind their positions, the rebel leaders on the payroll of the Rwandans and Ugandans are thus devising another trick so as to sow confusion and not only perpetuate the presence of their sponsors and backers on our soil, but also give them extra space according to their hidden agenda. As far as the Congolese Government is concerned, the decision to establish federalism in the occupied territories barely conceals Rwanda's annexationist designs on Kivu.

The Congolese Government, remaining committed to the principles and resolutions related to the Lusaka peace process, reaffirms that the Democratic Republic of the Congo is, in its present form, a unitary State and that any major decision affecting the form of that State comes under the exclusive sovereignty of the people.

The Government calls on all Congolese patriots, and on foreign Powers, to defeat this attempt by the occupying forces to Balkanize and dismember Congolese territory in order to satisfy the expansionist ambitions of Rwanda and Uganda.

The Congolese Government, for its part, gives the assurance that it continues to respect the Lusaka Ceasefire Agreement and will not sanction any obstacles to that Agreement. It calls on all the people of the Republic, wherever they may be, to resist this threat so as to safeguard the territorial integrity and sovereignty of the Democratic Republic of the Congo, in accordance with the Charter of the United Nations and all the relevant resolutions of the Security Council, especially resolutions 1234 (1999), 1304 (2000) and 1355 (2001).

The Government of the Democratic Republic of the Congo calls on the United Nations, the Organization of African Unity, the Southern African Development Community and all peace- and justice-loving States to take note of this blatant

violation of the integrity of Congolese territory by Rwanda and Uganda. It calls for an urgent meeting of the United Nations Security Council to address this question.
