on the work programme of the Institute for 2002****Note by the Secretary-General***Summary*

In accordance with the provisions of the statute of the United Nations Institute for Disarmament Research (UNIDIR) (see General Assembly resolution 39/148 H, annex, art. VIII, para. 3), the recommendation of the Board of Trustees of UNIDIR for a subvention of \$213,000 for the year 2002 from the regular budget of the United Nations is hereby transmitted to the General Assembly for approval. A related provision to finance this subvention has already been incorporated into section 4, Disarmament, of the proposed programme budget for the biennium 2002-2003 (A/56/6 (Sect. 4)).



1. As stated in the report of the Director of the United Nations Institute for Disarmament Research (UNIDIR) transmitted by the Secretary-General to the General Assembly at its fifty-sixth session (A/56/359), the Advisory Board on Disarmament Matters, in its capacity as the Board of Trustees of the Institute, approved the Institute's programme of work and estimated resource requirements for 2001 and 2002. The present report, reflecting the updated estimates that have since been provided by the Institute to the Advisory Committee on Administrative and Budgetary Questions, is submitted to the Assembly in the context of its consideration of a subvention of \$213,000 from the regular budget of the United Nations for 2002.

2. The Board also examined the financial arrangements for UNIDIR and congratulated the Institute's staff, particularly its Director, for effective fund-raising.

3. The proposed programme budget of the United Nations for the biennium 2002-2003, under section 4, Disarmament (A/56/6 (Sect. 4)), contains a provision of \$426,000 representing the United Nations subvention to UNIDIR for 2002-2003 (para. A.4.10). Notwithstanding the inclusion of the necessary provision in the proposed programme budget for the biennium 2002-2003, a formal request for a subvention of \$213,000 for the year 2002 is submitted to the General Assembly, in keeping with established procedure.

4. Under section IV of General Assembly resolution 44/201 B of 21 December 1989, entitled "Subvention from the regular budget to the United Nations Institute for Disarmament Research", the Secretary-General is required to report annually to the Assembly on the situation of the Institute. In this context, it is reported that the financial situation of the Institute is as follows:

(a) Funds available at the beginning of 2001 amounted to \$850,600. This figure includes an amount of \$162,300, required as operating cash reserve for 2001;

(b) Total income for 2001 is estimated at \$2,036,000, from the following sources: voluntary contributions and public donations (\$1,695,000), interest income (\$60,000), other inter-organizational contributions (\$58,000), the subvention from the United Nations regular budget (\$213,000) and miscellaneous income (\$10,000). It is also estimated that of total voluntary contributions and public donations, approximately 64 per cent will be used for special projects and 36 per cent for other purposes, including administrative costs. The details of the revised estimated contributions from voluntary sources for 2001 and 2002 are provided in annexes I and II respectively;

(c) Total 2001 revised estimated expenditure is \$1,349,300, including a provision of \$54,100 for programme support costs. Requirements for 2002 are estimated at \$1,400,600, inclusive of \$56,600 for programme support costs. The breakdown of 2001 revised estimated expenditures and of estimated resource requirements for 2002 is provided in annex III;

(d) Available funds at the beginning of 2002 are estimated at \$1,537,300, including an amount of \$169,700 that would be required as operating cash reserve.

5. Should the General Assembly decide to approve the recommendation of the Board of Trustees of UNIDIR, no additional provision would be required under section 4 of the proposed programme budget for the biennium 2002-2003.
