1. ADOPTION OF THE AGENDA

At its sixty-third session (13-15 February 2001), the Inland Transport Committee adopted the report of the Working Party on its fifty-sixth session.

To date the following States have become Parties to the Agreement: Austria; Azerbaijan; Belarus; Belgium; Bosnia and Herzegovina; Bulgaria; Croatia; Czech Republic; Denmark; Estonia; Finland; France; Georgia; Germany; Greece; Hungary; Ireland; Italy; Kazakhstan; Lithuania; Luxembourg; Morocco; Netherlands; Norway; Poland; Portugal; Romania; Russian Federation; Slovakia; Slovenia, Spain; Sweden; The former Yugoslav Republic of Macedonia; United Kingdom; United States of America; Uzbekistan; Yugoslavia.

Switzerland signed the Agreement without ratification.

(b) <u>Test stations officially designated by the competent authorities of countries Parties to ATP</u> and whose test reports might be used for the issue of the ATP certificates

The Working Party may wish to invite the Governments of Contracting Parties to transmit additional information concerning the competent authorities issuing certificates of conformity, the officially recognized testing stations and the addresses of bodies to contact in the event of any problems with a view to updating document TRANS/WP.11/2001/1.

(c) Exchange of information among Parties under Article 6 of ATP

The Working Party will be informed about any information transmitted by the Contracting Parties under Article 6 of ATP.

The Working Party will be informed of the amendments to ATP which have entered into force since the last session.

8. PROCEDURES FOR THE APPROVAL OF MULTI-COMPARTMENT MULTI-TEMPERATURE VEHICLES

Following the Krakow meeting, the Working Party may wish to consider the procedures for the approval of multi-compartment multi-temperature vehicles. For information, Germany submitted for the last session documents TRANS/WP.11/2000/1 and TRANS/WP.11/2000/2 (on a model of certificate for this vehicle) (see TRANS/WP.11/202, paras. 38-43).

9. REVISION OF THE ANNEXES TO ATP

The Working Party may wish to consider a proposal of the new version of the revised Annexes (TRANS/WP.11/2000/8; TRANS/WP.11/2000/11) elaborated by a consultant. Delegations may wish to transmit comments on TRANS/WP.11/2000/8.

Models of Test reports in the French proposal (TRANS/WP.11/2001/4) could be considered under this item.

10. ATP HANDBOOK

The Working Party may wish to consider the report of the Informal Group held in Roskilde (Denmark), 14-15 March 2001 (TRANS/WP.11/2001/2) and proposals submitted by France (TRANS/WP.11/2000/10 and TRANS/WP.11/2001/4).

The Working Party may also wish to consider a draft ATP Handbook prepared by the secretariat (TRANS/WP.11/2001/3).

11. FACILITATION OF TRANSPORT OF PERISHABLE FOODSTUFFS

The Working Party will be informed on the decisions taken by the Administrative Committee of the "International Convention on the Harmonization of Frontier Controls of Goods", relating to the draft annex on facilitation of international transport of perishable foodstuffs.

12. SCOPE OF ATP

At its last session, the Working Party considered a proposal from the Russian Federation (TRANS/WP.11/2000/12) for the inclusion in ATP of a new Annex 4 on temperature conditions to be observed in the transport of certain fresh fruit and vegetables (see TRANS/WP.11/202, paras. 70-77).

The Working Party decided to keep this item on the agenda.

It was decided to keep this item on the agenda.

14. PROCEDURES FOR DETERMINING THE EFFICIENCY OF EUTECTIC BATTERY REFRIGERATION APPLIANCES

16. STATISTICS CONCERNING ATP

The Working Party decided to keep this item on the agenda for the present session.

The Working Party may wish to consider a draft programme of work prepared by the secretariat (TRANS/WP.11/2001/5).
