## **Appointment of members of the International Civil Service Commission**

#### Note by the Secretary-General

- 1. As indicated in document A/56/106, it will be necessary for the General Assembly, during its current session, to appoint five persons to fill vacancies that will occur in the membership of the International Civil Service Commission, beginning on 1 January 2002.
- 2. The members of the Commission whose terms of office expire on 31 December 2001 are:

Mario Bettati (France);

João Augusto de Médicis (Brazil);

Lucretia F. Myers (United States of America);

Alexis **Stephanou** (Greece);

Ku Tashiro (Japan).

Thus, the members to be appointed should come from the following regions:

One member from the Asian States;

One member from the Latin American and Caribbean States;

Three members from the Western European and Other States.

- 4. The appointment of the members of the Commission is governed by the provisions of articles 3, 4 and 5 of its statute. Pursuant to those provisions, and in accordance with paragraphs 3 and 4 of section II of General Assembly resolution 43/226 of 21 December 1988, the Secretary-General has undertaken consultations with Member States, through the Chairmen of the various regional groups, with the executive heads of the other organizations, with staff representatives through the Federation of International Civil Servants' Associations and the Coordinating Committee for International Staff Unions and Associations of the United Nations System and with the Advisory Committee on Administrative and Budgetary Questions.
- 5. Regarding consultations with Member States, Minoru Endo has been endorsed by the Asian States, João Augusto de Médicis has been endorsed by the Latin American and Caribbean States and Mario Bettati, Lucretia Myers and Alexis Stephanou have been endorsed by the Western European and Other States.

#### **Lucretia F. Myers (United States of America)**

Lucretia F. Myers is currently a Commissioner on the 15-member International Civil Service Commission that regulates the conditions of service for employees of the United Nations and other international organizations. She was first appointed to the Commission in 1992 and was re-elected for two four-year terms that began in January 1994 and January 1998.

Ms. Myers retired from the United States Federal Civil Service in February 1998. At the time of her retirement, she was the Senior Policy Advisor for retirement, health and life insurance at the United States Office of Personnel Management.

Prior to serving as the Senior Policy Advisor, Ms. Myers was the Assistant Director for Insurance Programs at the United States Office of Personnel Management. As the Assistant Director, she oversaw the health and life insurance programmes for federal employees, retirees and their families. The Federal Employees Health Benefits Program is the largest employer-sponsored health insurance programme in the United States of America. It covers about 10 million lives, with 375 health insurance companies receiving annual premiums of nearly \$16 billion. The office also collected more than \$1.6 billion in premiums and paid \$1.5 billion in benefits annually for the Federal Employees Life Insurance Program.

From January 1987 to August 1993, Ms. Myers served as the Executive Director of the United States Merit Systems Protection Board, where she managed the programmes and operations of the Board and its 11 regional offices. The Board is a quasi-judicial agency that protects employees against abuses by agency management and conducts studies of the United States federal civil service to ensure that employment practices are based on merit.

Prior to her appointment to the Board, Ms. Myers served in a variety of positions at the United States Office of Personnel Management. Positions held include: Deputy Associate Director for Administration, where she was responsible for the agency's fiscal, administrative, information management and human resources management functions; Deputy Associate Director for Compliance and Investigations, where she managed one of the civilian sector's largest background investigations programmes, as well as the federal Government's personnel management evaluation and workforce information programmes; and Assistant Director for Retirement Programs and subsequently Assistant Director for Pay and Benefits Policy, where she was in charge of administering the Government's fourth largest entitlement programme and directing the policy for one of the world's largest pay and benefits programmes.

Ms. Myers joined the United States personnel agency in 1979 and soon thereafter was appointed Director for Personnel and Equal Employment Opportunity. She came to the Office of Personnel Management from the Department of the Air Force, where she held a variety of positions in human resource management at several geographical locations. Her background includes being a practitioner, manager or executive in virtually all functional areas of human resource management, including position classification and pay administration, labour management and employee relations, recruitment and staffing, training and development.

Ms. Myers served on the Military Health Care Advisory Board of the Department of Defense and was the liaison for the United States Office of Personnel Management to the Board of Directors for the Foundation for Accountability. She was appointed to the Senior Executive Service in 1980 and is a 1983 graduate of the Senior Executive Fellows Program at the John F. Kennedy School of Government at Harvard. During her service with the United States Federal Civil Service, she received numerous awards in recognition of her outstanding performance and executive excellence, including the Presidential Rank Award of Distinguished Executive.
