PROVISIONAL AGENDA AND ANNOTATIONS

Note by the Executive Secretary

I. INTRODUCTION

1. Arrangements have been made for the fifteenth session of the Subsidiary Body for Implementation (SBI) to be held at the Palais des Congrès, Marrakesh, Morocco, in the period from 30 October to 6 November 2001. The session of the SBI is scheduled to be opened by the Chairman at 11 a.m. on Tuesday, 30 October 2001.

II. PROVISIONAL AGENDA

- 2. The provisional agenda for the fifteenth session of the SBI, proposed after consultation with the Chairman, is as follows:

III. ANNOTATIONS TO THE PROVISIONAL AGENDA

1. Opening of the session

3. The fifteenth session of the SBI is scheduled to be opened by the Chairman at 11 a.m. on Tuesday, 30 October 2001.

2. Organizational matters

(a) Adoption of the agenda

4. The provisional agenda for the fifteenth session of the SBI will be presented for adoption.

(b) Organization of the work of the session

- 5. Parties are invited to refer to the annotations of the provisional agenda of the seventh session of the COP for information on the general schedule. Parties may also wish to consult the Daily Programme, published prior to and during the session, for a more detailed and updated schedule of work of the SBI.
- 6. Parties may wish to note that due to the short period between the fourteenth and the fifteenth sessions of the SBI, there is a likelihood of delay in the availability of some documents in all six official languages of the United Nations prior to the session.

(c) <u>Election of officers other than the Chairman</u>

7. Pursuant to rule 27 of the draft rules of procedure being applied, the SBI is expected to elect its own Vice-Chairman and Rapporteur. The Chairman will continue consultations initiated at the fourteenth session with the coordinators of the regional groups with a view to electing the

other officers. Early agreement on the nominations by the regional groups will enable the SBI to elect the remaining officers and to continue its substantive work in an efficient manner. The current officers of the Subsidiary Body for Implementation will remain in office until their successors are elected.

- 8. The President of the seventh session of the COP is expected to hold consultations on the election of the Bureau of the COP, including the election of the Chairman of the SBI. These consultations could be expanded to encompass the election of the Vice-Chairmen and Rapporteurs of the subsidiary bodies, if it is so decided.
- 9. **Action:** The SBI will be invited to elect its Vice-Chairman and Rapporteur.
 - 3. <u>Matters referred to the Subsidiary Body for Implementation</u> by the Conference of the Parties

(a) Input to the World Summit on Sustainable Development

- 10. **Background:** At its twelfth session, the SBI requested the secretariat to prepare elements of a draft input on the UNFCCC process to the World Summit on Sustainable Development (WSSD), to be held in Johannesburg in 2002, for consideration at its fourteenth session, with a view to recommending a draft decision for adoption by COP 7 (FCCC/SBI/2000/5, para. 43 (h)). At its fourteenth session, the SBI agreed that this matter would be taken up at its fifteenth session (FCCC/SBI/2001/9, para. 3).
- 11. The General Assembly, in its decision 55/443, requested the Executive Secretary of the UNFCCC to present the report of the COP to the Preparatory Committee for the World Summit on Sustainable Development. The note prepared by the secretariat in response to the above requests is contained in document FCCC/SBI/2001/11.
- 12. **Action:** Further to a decision taken by the Bureau at its meeting in Marrakesh, 10 September, it is proposed that this item be dealt with by the COP. No action by the SBI is therefore envisaged.

(b) Report of the Global Environment Facility to the Conference of the Parties

- 13. **Background:** The Memorandum of Understanding between the COP and the Council of the Global Environment Facility (GEF), annexed to decision 12/CP.2, provides, *inter alia*, that the GEF will make available to the COP annual reports which should include specific information on how the GEF has applied the guidance and decisions of the COP in its work relating to the Convention. The latest report is contained in document FCCC/CP/2001/8.
- 14. **Action:** The SBI may wish to consider the report of the GEF and to recommend draft conclusions or a draft decision, as appropriate, to the Conference of the Parties for its consideration and adoption.

(c) Proposal to amend the lists in Annexes I and II to the Convention

- (i) Proposal to amend the lists in Annexes I and II to the Convention by removing the name of Turkey: review of information and possible decisions under Article 4, paragraph 2 (f)
- 15. **Background:** The Conference of the Parties, at the first part of its sixth session, considered a new proposal submitted by Turkey to have its name removed from the lists of Parties included in Annexes I and II to the Convention. The initial request by Turkey to remove its name from Annexes I and II to the Convention was first submitted to the third session of the Conference of the Parties in 1997, and has been considered by successive Conferences of the Parties since. The Conference of the Parties, at the first part of its sixth session, agreed, on the proposal of its President, that the new proposal from Turkey (contained in FCCC/CP/2001/5/Add.1, paras. 84-85), should be referred to the SBI for consideration, with a view to making a recommendation to COP 7 for consideration and definitive action.
- 16. **Action:** The SBI may wish to consider the new proposal submitted by Turkey and to submit a recommendation to the Conference of the Parties at its seventh session for its consideration and definitive action.
 - (ii) Amendment proposed by Kazakhstan to add its name to the list in Annex I
- 17. **Background:** Article 15, paragraph 1, provides that "any Party may propose amendments to the Convention". Article 15, paragraph 2, provides that "amendments to the Convention shall be adopted at an ordinary session of the Conference of the Parties. The text of any proposed amendment to the Convention shall be communicated to the Parties by the secretariat at least six months before the meeting at which it is proposed for adoption. The secretariat shall also communicate proposed amendments to the signatories to the Convention and, for information, to the Depository." Article 16 relates, *inter alia*, to the amendment of annexes to the Convention by application of the procedures set out in Article 15.
- 18. In accordance with these provisions, Kazakhstan submitted a note dated 24 April 1999 proposing the inclusion of its name in the list of Parties included in Annex I to the Convention (FCCC/CP/1999/2). This proposal was communicated to all Parties, signatories, and for information, to the Depository, in a note verbale dated 3 May 1999. The proposal has also been made available in all six official languages of the United Nations.
- 19. The Conference of the Parties at its fifth session considered this proposal and agreed to consider the amendment by Kazakhstan at its sixth session, with a view to taking action thereon. In a note verbale dated 13 June 2000, Kazakhstan requested that its proposed amendment be withdrawn from the provisional agenda of COP 6. This item has now been included in the provisional agenda of COP 7 for consideration by the Conference at the request of Kazakhstan.
- 20. **Action:** The SBI is invited to consider the proposal submitted by Kazakhstan and to forward conclusions or a draft decision to the COP for consideration and adoption.

(d) <u>Arrangements for intergovernmental meetings</u>

- (i) Date and venue of the eighth session of the Conference of the Parties
- 21. **Background:** Rule 3 of the draft rules of procedure being applied states that the "sessions of the Conference of the Parties shall take place at the seat of the secretariat, unless the Conference of the Parties decides otherwise or other appropriate arrangements are made by the secretariat in consultation with the Parties" (FCCC/CP/1996/2). The dates for COP 8 were established by COP 5 and are 28 October to 8 November 2002. To date, no offer has been received by the secretariat from a Party wishing to host COP 8. Parties wishing to host COP 8 are invited to submit their offers as soon as possible.
- 22. **Action:** The SBI, after considering any offers, may wish to recommend, for adoption by COP 7, a decision on the date and venue for COP 8, and also to request the secretariat to start planning for COP 8 with the designated host country and enter into the necessary agreement. A decision on this matter must be taken by COP 7.
 - (ii) <u>Calendar of meetings of Convention bodies</u>, 2005-2007
- 23. **Background**: At its ninth plenary meeting, on 25 November 2000, the sixth session of the Conference of the Parties adopted the calendar of meetings for the period 2001-2004. In order to enable the secretariat to book facilities in time for the sessions of the Convention bodies, the SBI will have before it a suggestion for a calendar of meetings for 2005-2007. The suggested dates to be approved by the COP are as follows:
- First sessional period in 2005: from 16 May to 27 May 2005;
- Second sessional period in 2005: from 14 to 25 November 2005;
- First sessional period in 2006: from 15 May to 26 May 2006;
- Second sessional period in 2006: from 6 to 17 November 2006;
- First sessional period in 2007: from 7 May to 18 May 2007;
- Second sessional period in 2007: from 5 October to 16 November 2007.
- 24. In the light of a very crowded international conference calendar, and the difficulties of booking facilities for a large conference, early decisions on dates are increasingly important.
- 25. **Action:** The SBI may wish to endorse the proposed dates and recommend them to the COP for adoption as the calendar of meetings for the Convention bodies.
- (e) Programme budget for the biennium 2002-2003
- 26. **Background:** At its fourteenth session, the SBI considered the programme budget for the biennium 2002-2003 proposed by the Executive Secretary, and agreed to recommend a total budget of US \$32,837,100 including contingencies. It also authorized the Executive Secretary to notify Parties of their 2002 contributions on this basis after drawing US \$5,000,000 from the

unspent balance or contributions (carry-over) from previous financial periods. Meanwhile, the SBI requested the Executive Secretary to propose a revised programme budget including a revised staffing table, taking into account the budgetary implications of decisions taken by the COP at its sixth session (see FCCC/SBI/2001/17 and Add.1).

27. **Action:** The SBI is invited to consider the revised programme budget for 2002-2003 and to recommend it for adoption by the COP at its seventh session.

(f) Any other matters

28. Any matters other than those listed above which have been referred by the COP at its seventh session to the SBI for consideration at its fifteenth session will be taken up under this item.

4. Matters relating to the least developed countries

- 29. **Background:** The SBI, at its fourteenth session, requested the secretariat to organize a workshop to assist the least developed country Parties in preparing for negotiations at COP 7, and in further developing the guidelines for the preparation of national adaptation programmes of action. This workshop is scheduled to be held in Maldives from 2 to 4 October 2001. An oral report on the workshop will be provided by the spokesperson of the group of least developed countries. At the request of the Conference of the Parties, at the second part of its sixth session, the subsidiary bodies would consider the recommendations relating to the guidelines for the preparation of national adaptation programmes of action (see FCCC/SBI/2001/7) and would forward, as appropriate, a draft decision for consideration by COP 7.
- 30. At the request of the Conference of the Parties, at the second part of its sixth session, the SBI, at its fifteenth session, would consider the compilation of submissions from least developed country Parties on their financial needs for the preparation of national adaptation programmes of action (see document FCCC/CP/2001/5; Part three). This compilation is contained in document FCCC/SBI/2001/MISC.1.
- 31. **Action:** The SBI may wish to recommend, for consideration and adoption by COP 7, a draft decision containing guidelines for the preparation of national adaptation programmes of action. The SBI may also wish to take note of document FCCC/SBI/2001/MISC.1.
 - 5. National communications from Parties included in Annex I to the Convention
- (a) Ongoing activities on reporting and review of greenhouse gas inventories in Parties included in Annex I to the Convention (implementing decisions 3/CP.5 and 6/CP.5)
- 32. **Background:** The COP, by its decision 3/CP.5, adopted guidelines to be used for reporting inventories from Parties included in Annex I to the Convention beginning in 2000. The COP, by its decision 6/CP.5, adopted guidelines for the technical review of greenhouse gas inventories from Annex I Parties. A progress report on the ongoing activities related to the technical review of greenhouse gas inventories is contained in document FCCC/SBI/2001/12.

33. **Action:** The SBI may wish to consider referring this item to the SBSTA for consideration at its fifteenth session.

(b) Feasibility of developing guidelines for the review of national communications

- 34. **Background:** The SBI at its twelfth session took note of document FCCC/SBI/2000/3 on the experience with the review of second national communications of Annex I Parties and the information contained in document FCCC/SBI/2000/INF.6 on the progress made with in-depth reviews of second national communications.
- 35. At the same session, the SBI concluded that it would consider at its fourteenth session the issue of developing guidelines for the review of national communications under the Convention, taking into account the guidelines to be developed for the review of national communications under Article 8 of the Kyoto Protocol. In view of the limited time available at the fourteenth session of the SBI, this issue is to be considered at the fifteenth session of the SBI.
- 36. The SBI at its twelfth session requested the secretariat to organize in 2001 a workshop on exchanging information among Annex I Parties on preparations for third national communications and on ways of ensuring expertise in the review process. The report on the workshop is available in document FCCC/SBI/2001/INF.4.
- 37. **Action:** When considering the feasibility of developing the review guidelines for the national communications under the Convention, the SBI may wish to refer to documents FCCC/SBI/2000/3 and FCCC/SBI/2001/INF.4 as well as to take into account developments relating to reporting and review of information under the Kyoto protocol resulting from COP 6, part 2.
- 38. The SBI may also wish to note that according to decision 11/CP.4, Annex I Parties should submit their third national communications to the secretariat by 30 November 2001. These communications are expected to be subject to in-depth reviews in the period 2002-2003, which makes the time factor especially relevant for consideration of the feasibility of developing guidelines for the review of non inventory-related information at this stage.

(c) Third national communications: review and the roster of experts

39. **Background:** The Conference of the Parties, at its second session, by its decision 9/CP.2, requested the secretariat to conduct the review process of the second national communications in applying procedures for review, including in-depth reviews, as defined in decision 2/CP.1. The results of the in-depth review of second national communications are summarized in document FCCC/SBI/2001/INF.7. National inventory data for the period 1990-1999, including information on trends in emissions, are contained in document FCCC/SBI/2001/13.

- 40. According to decision 9/CP.2, reviews should be carried out by expert review teams and coordinated by the secretariat. It is assumed that in-depth reviews of national communications due by 30 November 2001 (decision 11/CP.4) will start in 2002 and will include the preparation of a compilation and synthesis report.
- 41. Experts participating in the in-depth reviews should be nominated by Parties and intergovernmental organizations. The last update of the roster of experts took place in 1998 and many of the government-nominated experts may have changed their positions since. Updating the roster would allow the secretariat to ensure the proper conduct of in-depth reviews of the national communications due by 30 November 2001.
- 42. **Action:** The SBI may wish to take note of the results of the review of second national communications and inventory data for the period 1990-1999. It may wish to recommend to the COP a draft decision on the timing of in-depth reviews of national communications due in November 2001, including compilation and synthesis. The SBI may also wish to invite Parties to nominate experts to the roster no later than 30 November 2001 using the form in document FCCC/SBI/2001/INF.6.
 - 6. National communications from Parties not included in Annex I to the Convention
- (a) Third compilation and synthesis of initial national communications from Parties not included in Annex I to the Convention
- 43. **Background:** The COP, by its decision 3/CP.6, requested the secretariat to prepare the third compilation and synthesis of initial national communications from non-Annex I Parties, based on the national communications received from these Parties by 1 June 2001, and to make that report available to the subsidiary bodies at their fifteenth sessions, and to the Conference of the Parties at its seventh session. The secretariat was also requested to include in the compilation and synthesis report information on issues, constraints and problems encountered by non-Annex I Parties in using the UNFCCC guidelines for the preparation of initial national communications, and on other issues raised by non-Annex I Parties. The third compilation and synthesis report based on 52 initial national communications, including an executive summary, is contained in document FCCC/SBI/2001/14.
- 44. **Action:** The SBI may wish to consider the compilation and synthesis report and to forward any conclusions and/or recommendations to COP 7 for its consideration and action.

(b) Report of the Consultative Group of Experts to the subsidiary bodies

45. **Background:** The COP, by its decision 8/CP.5, established a Consultative Group of Experts on National Communications from Parties not included in Annex I to the Convention (CGE) with the objective of improving the national communications of these Parties. The terms of reference of the CGE, which are annexed to decision 8/CP.5, mandate the CGE to hold meetings and workshops and also to examine the national communications, in order to identify analytical and methodological issues, and technical problems relating to the use of the IPCC

Guidelines and the UNFCCC reporting guidelines contained in the annex to decision 10/CP.2. The CGE was further mandated to consider other information apart from that relating to national inventories of greenhouse gases and to forward its recommendations in a report to the subsidiary bodies for their consideration. The CGE presented to the fourteenth session of the SBI its preliminary report (FCCC/SBI/2001/8) containing recommendations for financial and technical support, improvement of the UNFCCC reporting guidelines, as well as improvement of the IPCC and other methodologies. The SBI at its fourteenth session invited Parties to submit views by 15 September 2001 on (i) the preliminary report of the CGE, and on (ii) the current progress of the process aimed at improving the guidelines for national communications from non-Annex I Parties, in accordance with decision 8/CP.5. The SBI further requested the secretariat to compile these submissions as a miscellaneous document (FCCC/SBI/2001/MISC.2) and to prepare a consolidated report (FCCC/SBI/2001/INF.11) on the views of Parties on these issues for consideration at its fifteenth session. In the period between the fourteenth and fifteenth sessions, the CGE finalized its report, which is available in document FCCC/SBI/2001/15.

46. **Action:** The SBI may wish to take note of (i) the recommendations contained in document FCCC/SBI/2001/15, and (ii) information contained in documents FCCC/SBI/2001/MISC.2 and FCCC/SBI/2001/INF.11, with a view to recommending a draft decision on the extension of the mandate of the CGE. The SBI may also wish to consider ways and means of continuing to advance the process of reviewing the UNFCCC guidelines for the preparation of national communications from non-Annex I Parties and to forward the relevant conclusions for consideration by the COP at its seventh session with a view to adopting revised guidelines at COP 8.

(c) Provision of financial and technical support

- 47. **Background:** The secretariat is mandated by Article 8.2(c) of the Convention to facilitate the provision of financial and technical support to developing countries, in particular for the preparation of national communications. The secretariat regularly updates information on the provision of financial support through the analysis of responses to a questionnaire administered to non-Annex I Parties on the status of preparation of their national communications (see FCCC/SBI/2001/INF 8). A table on the current status of preparation of national communications from Parties not included in Annex I to the Convention is posted on the secretariat web site (http://www.unfccc.int/program/nai/ncweb01.html). The information contained in this table is regularly updated and is made available to Parties in hard copy on request.
- 48. Document FCCC/SBI/2001/INF.9 contains information received from the GEF secretariat on the financial support to non-Annex I Parties for the preparation of their communications, including projects proposed by each Party, the funding decisions and the date of first disbursement, and the total amount of funds made available to the Party in accordance with decision 10/CP.2, paragraph 1 (b).
- 49. In response to the request contained in decision 12/CP.4, the secretariat has made available on the UNFCCC web site a list of projects, submitted by non-Annex I Parties, which aim to reduce emissions or to increase removals by sinks of greenhouse gases in accordance with Article 12.4 of the Convention (http://www.unfccc.int/program/nai/ncweb02.pdf). This list is

regularly updated, based on new information provided by Parties in their national communications. It is available to Parties in hard copy on request.

50. **Action:** The SBI may wish to take note of the above-mentioned documents and to provide further guidance to the secretariat on facilitating assistance to non-Annex I Parties in the preparation of their national communications.

7. Administrative and financial matters

(a) <u>Interim financial performance for 2000-2001</u>

- 51. **Background:** The financial procedures of the Convention stipulate that "an interim statement of accounts for the first year of the financial period shall be provided to the Conference of the Parties during the second year of the period" (FCCC/CP/1995/7/Add.1). Document FCCC/SBI/2001/INF.5 contains the unaudited interim financial statements for the biennium 2000-2001 as at 31 December 2000.
- 52. Income and expenditures in 2000-2001 as at 30 June 2001 are provided in document FCCC/SBI/2001/16. This document also addresses programme delivery, personnel matters and developments in administrative arrangements of the secretariat.
- 53. Information on the latest status (as at 15 October 2001) of contributions by Parties to the core budget, the Trust Fund for Participation in the UNFCCC Process and the Trust Fund for Supplementary Activities of the UNFCCC is contained in document FCCC/SBI/2001/INF.10.
- 54. **Action:** The SBI may wish to take note of these reports and express its appreciation to the Parties that have made timely contributions to the core budget, and especially to those that have made voluntary contributions to the other trust funds. Meanwhile, the SBI may urge Parties which have not made their contributions to do so in a timely manner. The SBI may wish to recommend a draft decision on this item as part of the omnibus decision on administrative and financial matters for adoption by COP 7.

(b) Possible options to respond to late payment of contributions

- 55. **Background:** Upon considering the report by the Executive Secretary on the "late payment of contributions: response options", the SBI, at its twelfth session, prepared a draft decision for consideration at its thirteenth session (FCCC/SBI/2000/6/Add.1). However, the SBI postponed discussion on this item until after COP 6.
- 56. **Action:** The SBI may wish to recommend a draft decision as referred to above, for adoption by the Conference of the Parties at its seventh session.

(c) <u>Implementation of the Headquarters Agreement</u>

- 57. **Background:** At its previous sessions, the SBI considered the implementation of the Headquarters Agreement, specifically with respect to office space, visas for delegations, and with regard to visas, residence status and work permits for family members of the secretariat. It requested the host Government and the Executive Secretary to report on progress at its next sessions.
- 58. **Action:** A representative of the host Government and the Executive Secretary will make oral presentations on further progress made. The SBI may wish to consider the information provided and take any action it deems necessary.

8. Other matters

59. Other matters may be considered as they arise during the session. Information on issues not covered by the previously listed agenda items may be made available as appropriate.

9. Report on the session

60. The SBI may wish to adopt conclusions and authorize the Rapporteur to complete the report after the session with the guidance of the Chairman and with the assistance of the secretariat. Subject to the availability of sufficient time for their translation, conclusions will be made available in all six official United Nations languages.
