DECREE NO. 122 OF 10 MAY 1984

AMENDMENT TO SUPREME DECREE NO. 535 OF 1973

Ministry of Health
Amendment to Supreme Decree No. 535 of 1973
Decree No. 122 of 10 May 1984

(Santiago)

Considering: letter Res. No. 1394 of 26 April 1984 from the management of the Chilean Institute of Public Health, the provisions of the Health Code; and the provisions of Law No. 17,934, article 1, and its regulatory provisions as approved under Supreme Decree No. 535, of 11 July 1973, of this Ministry; and by virtue of the powers vested in me under article 32, paragraph 8, of the Political Constitution of the Republic of Chile

I decree:

Article 1. Supreme Decree No. 535, of 11 July 1973, of the former Ministry of Public Health, which approves the regulations for the purposes set forth in the final paragraph of article 1 of Law No. 17,934 ^{1/} on the suppression of the illicit traffic in narcotic drugs is amended, with the following substances to be added to the list contained in its article 2:

Alobarbital	Chloralodol
Aprobarbital	Chloralose
Brallobarbital	Chlorfentermine
Butalbital	Dextromethorfan
Hexobarbital	Phenylethynylcarbinol carbamate
Mefobarbital	Heptabarbo
Methabarbital	Chloral hydrate
Proxibarbal	Femproporex
Secbutabarbital	Methylpentinol
Acecarbromal	Pemoline
Bromisoval	Probarbital
Butallylonal	Tranilcipromine
Butetal (Butobarbitone)	Prolintan
Carbromal	and the salts of the substances
Chlorbenzorex	listed in article 2.

Article 2. The present modification shall enter into force sixty (60) days following its publication in the Official Gazette.
