At the thirty-fourth session, the General Assembly will have before it the report of the Secretary-General called for under resolution 33/133 (A/34/432) (see also item 60).

### Role of the public sector in promoting the economic development of developing countries

At its second regular session of 1979, the Economic and Social Council recommended that the report of the Secretary-General (E/1979/66) be transmitted to the General Assembly, in accordance with Assembly resolution 32/179; requested the Secretary-General to submit a further progress report to the Council at its second regular session of 1981; further recommended that the General Assembly should review at its thirty-fourth session the report mentioned above in order to determine which aspects of the role of the public sector required further in-depth study, as indicated in that report; and invited the appropriate organizations within the United Nations system to give due attention in their studies to the relevant aspects of the role of the public sector in promoting the economic and social development of the developing countries (resolution 1979/48).

### Transport and Communications Decade in Africa

At its second regular session of 1979, the Economic and Social Council recommended to the General Assembly the adoption of a draft resolution in which the Assembly would take note of the general strategy for the implementation of the programme for the Transport and Communications Decade in Africa, as adopted by the Conference of African Ministers of Transport, Communications, Information and Planning held at Addis Ababa from 9 to 12 May 1979; would note that the estimated cost for the implementation of the programme approved by the Conference for the first phase of the Decade, 1980-1983, was approximately \$8 billion; would request the Secretary-General to continue his work of organizing a pledging conference of donors, with a view to mobilizing the financial resources necessary for implementing the programme for the first phase of the Decade; and would request the Secretary-General to provide the Economic Commission for Africa with the necessary resources in order to enable it to play fully and effectively its role as "lead agency" for the Decade (resolution 1979/61).

At the thirty-fourth session, the General Assembly will have before it the progress report of the Secretary-General called for under resolution 32/160 (E/1979/77).

### Regional co-operation and development

At its second regular session of 1979, the Economic and Social Council took note of the progress report of the Secretary-General on the implementation of Council resolution 1978/74 (E/1979/32 and Corr.1), the report of the Secretary-General on the meetings of the Executive Secretaries of the regional Commissions (E/1979/76 and Add.1), and the relevant sections of the first progress report of the Secretary-General for 1979 on the restructuring of the economic and social sectors of United Nations system (E/1979/81); invited the Secretary-General to pursue actively the process of decentralization to the regional commissions on the basis of the relevant provisions of section IV of the annex to General Assembly resolution 32/197 and in the light of the recommendations contained in Council resolution 1978/74 and section V of Assembly resolution 33/202; invited the Secretary-General in particular to expedite the decentralization of activities, including the redeployment of the necessary and appropriate resources in the priority programme areas identified at the meetings of the Executive Secretaries and to report the outcome to the Assembly at its thirty-fourth session; welcomed the intention of the Secretary-General to submit to the Assembly at its thirty-fourth session a comprehensive statement of the administrative and financial implications of the provisions of resolutions 32/197 and 33/202, calling for decentralization and the strengthening of the regional commissions; and invited the Committee for Programme and Co-ordination to undertake at its twentieth session a full review of policy and programme issues relating to the distribution of tasks and responsibilities between the regional commissions and other United Nations units, programmes and organs concerned, in preparation, *inter alia*, for the elaboration of the next programme budget and medium-term plan, and to report thereon to the Council and the Assembly in 1980 (resolution 1979/64).

At the thirty-fourth session, the General Assembly will have before it the documents referred to above.

### Assistance to the Palestinian people

In compliance with Economic and Social Council resolution 2100 (LXIII), adopted in 1977, concerning assistance to the Palestinian people, the Secretary-General submits to the Council an annual report on the action taken to implement the provisions of that resolution.

At its thirty-third session, the General Assembly endorsed the resolutions of the Economic and Social Council concerning assistance to the Palestinian people and called upon the United Nations Development Programme, in consultation with the specialized agencies and other organizations within the United Nations system, to intensify its efforts, in co-ordination with the Economic Commission for Western Asia, to implement the relevant resolutions of the Council in order to improve the social and economic conditions of the Palestinian people by identifying their social and economic needs and by establishing concrete projects to that end, without prejudice to the sovereignty of the respective Arab host countries, and to provide adequate funds for that purpose (resolution 33/147).

At its second regular session of 1979, the Economic and Social Council took note of the report of the Secretary-General on assistance to the Palestinian people (E/1979/61 and Add.1) and decided to transmit it to the General Assembly at its thirty-fourth session (decision 1979/53).

At the thirty-fourth session, the General Assembly will have before it the report referred to above.

#### World Conference on Agrarian Reform and Rural Development

The World Conference on Agrarian Reform and Rural Development was held in Rome from 12 to 23 July 1979.

At its second regular session of 1979, the Economic and Social Council took note with satisfaction of the statement made by the Secretary-General of the Conference (E/1979/SR.37) and of the statements made by delegations; and decided to invite the Director-General of the Food and Agriculture Organization of the United Nations to submit the report of the Conference to the General Assembly and to the Preparatory Committee for the New International Development Strategy (decision 1979/50).

At the thirty-fourth session, the General Assembly will have before it the report of the Conference (see A/34/485).

#### Charter of Economic Rights and Duties of States

At its second regular session of 1979, the Economic and Social Council took note of and decided to transmit to the General Assembly at its thirty-fourth session the report of the Secretary-General (E/1979/74) on the implementation of the Charter of Economic Rights and Duties of States (decision 1979/51).

At the thirty-fourth session, the General Assembly will have before it the report referred to above.

#### Transnational corporations

The Council also requested the Secretary-General to invite the International Labour Organisation, the United Nations Educational, Scientific and Cultural Organization, the World Health Organization and other interested United Nations bodies to continue their co-operation towards the preparation by the General Assembly of an international convention on protection of the rights of all migrant workers in accordance with the relevant recommendations contained in the Programme of Action adopted by the World Conference to Combat Racism and Racial Discrimination and to submit at its first regular session of 1980 a report on the results of this co-operation covering the activities being conducted by them in their respective spheres of competence; and requested the Secretary-General to communicate to Member States at the thirty-fourth session of the General Assembly the results of the consultations which the Assembly had requested him to undertake pursuant to Assembly resolution 33/163 in order to explore the possibility of drawing up an international convention on the rights of migrant workers (resolution 1979/13).

In a letter dated 17 August 1979 (A/34/191), Indonesia, Malaysia, the Philippines, Singapore and Thailand requested the inclusion of the above-mentioned supplementary item in the agenda of the thirty-fourth session.

At its 4th plenary meeting, on 21 September 1979, the General Assembly decided, on the recommendation of the General Committee (A/34/250), to include this item in the agenda and to consider it directly in plenary meeting.

124. Assistance for the reconstruction of Nicaragua

In a letter dated 4 September 1979 (A/34/241), Panama requested the inclusion of the above-mentioned additional item in the agenda of the thirty-fourth session.

At its 4th plenary meeting, on 21 September 1979, the General Assembly decided, on the recommendation of the General Committee (A/34/250), to include this item in the agenda and to allocate it to the Second Committee.

125. Measure to assist the Dominican Republic and Dominica following the severe disasters caused in those countries by hurricane "David" and hurricane "Frederic"

In a letter dated 17 September 1979 (A/34/242), Panama requested the inclusion of the above-mentioned additional item in the agenda of the thirty-fourth session.

At its 4th plenary meeting, on 21 September 1979, the General Assembly decided, on the recommendation of the General Committee (A/34/250), to include this item in the agenda and to allocate it to the Second Committee.
