Item 3: Country cooperation frameworks and related matters

Note by the Administrator

The present note contains information on the extensions of country cooperation frameworks for Bahrain, Cameroon, Cape Verde, Central African Republic, Democratic Republic of the Congo, People's Republic of the Congo, Côte d'Ivoire, Djibouti, Dominican Republic, Libya, Malaysia, Niger, Nigeria, and Seychelles.

The Executive Board may wish to take note of the country cooperation frameworks listed in table 1 and approve the extensions of those listed in table 2.



Introduction

1. As part of the ongoing measures to streamline documentation, the present note contains information on the extensions of all country cooperation frameworks to be considered by the Board at its current session. The Administrator seeks the views of the Board on the note, particularly regarding the amount of information presented and on ways to improve its presentation.
2. All extensions of country cooperation frameworks are requested by the Government concerned; the Administrator approves the first one-year extension of CCFs while the Executive Board approves the second year or two-year extensions. In table 1, the Administrator presents information on those extensions he has approved since the second regular session 2001. In table 2, he presents information on those extensions that the Board is called upon to approve.

Malaysia	1997-2001		The United Nations Team will undertake an assessment of the role of the United Nations in relation to the development priorities of Malaysia in early 2002. This will be based in part on the newly released Eighth Development Plan. The Government of Malaysia will conduct a review of the SRF immediately following the Country Team's assessment. This will form the basis for dialogue on the objectives and scope of the next UNDP Country Programme.	
Nigeria	1997-2001			Initial implementation of the CCF was delayed and continued at a slow pace. The mid-term review of the present CCF, which took place in September 2000, confirmed that its strategy and thematic areas (the poverty level at 70 per cent) remain relevant to the priorities of the Government and recommended a transition period for fuller combination of grass-roots/downstream activities and policy/upstream activities. UNDP will join the agreed United Nations harmonization cycle in 2003.
