Report of the Second Committee

I. Introduction

1. At its 3rd plenary meeting, on 19 September 2001, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its fifty-sixth session the item entitled "Report of the Economic and Social Council" and to allocate it to the Second Committee.

2. The Second Committee considered the item at its 27th, 28th, 30th, 35th, 36th, 37th and 40th meetings, on 19, 20, 21 and 30 November and on 4, 7 and 12 December 2001. An account of the Committee's discussion of the item is contained in the relevant summary records (A/C.2/56/SR.27, 28, 30, 35, 36, 37 and 40). Attention is also drawn to the general debate held by the Committee at its 3rd to 8th meetings, from 1 to 3 October (see A/C.2/56/SR.3-8).

3. For its consideration of the item, the Committee had before it the following documents:

4. At the 27th meeting, on 19 November, the Chief of the Policy Coordination Branch and the Director of the Division for Public Economics and Public Administration of the Department of Economic and Social Affairs made introductory statements (see A/C.2/56/SR.27).

5. At the same meeting, the representative of the World Tourism Organization made a statement (see A/C.2/56/SR.27).

II. Consideration of proposals

A. Draft resolution A/C.2/56/L.27

6. At the 28th meeting, on 20 November, the representative of Japan introduced a draft resolution entitled “Integrated and coordinated implementation of and follow-up to the outcomes of the major United Nations conferences and summits in the economic and social fields” (A/C.2/56/L.27).

7. At the 36th meeting, on 4 December, the Vice-Chairman of the Committee, Felix Mbayu (Cameroon), informed the Committee of the outcome of the informal consultations held on the draft resolution, and orally amended the text by inserting, in paragraph 1, after the words “United Nations conferences and summits”, the words “of the 1990s”.

8. At the same meeting, the Committee adopted draft resolution A/C.2/56/L.27, as orally amended (see para. 23, draft resolution I).

B. Draft resolution contained in document A/C.2/56/L.7

9. By its resolution 2001/37 of 26 July 2001, the Economic and Social Council recommended to the General Assembly the adoption of a draft resolution entitled “Global Code of Ethics for Tourism”, which was transmitted to the Committee in a note by the Secretariat (A/C.2/56/L.7).

10. At the 30th meeting, on 21 November, the Vice-Chairman of the Committee, Felix Mbayu (Cameroon), informed the Committee of the outcome of the informal consultations held on the draft resolution.

11. At the same meeting, on the proposal of the Vice-Chairman, the Committee adopted the draft resolution contained in document A/C.2/56/L.7 (see para. 23, draft resolution II).

C. Draft resolution A/C.2/56/L.42

12. At the 35th meeting, on 30 November, the representative of the Islamic Republic of Iran, on behalf of the States Members of the United Nations that are members of the Group of 77 and China, introduced a draft resolution entitled “Public administration and development” (A/C.2/56/L.42).

13. At the 37th meeting, on 7 December, the Vice-Chairman of the Committee, Felix Mbayu (Cameroon), informed the Committee of the outcome of the informal consultations held on the draft resolution.

14. At the same meeting, the Committee adopted draft resolution A/C.2/56/L.42 (see para. 23, draft resolution III).

D. Draft decision contained in document A/C.2/56/L.6

15. By its decision 2001/319 of 24 October 2001, the Economic and Social Council recommended to the General Assembly the adoption of a draft decision

entitled "Office of the President of the Economic and Social Council", which was transmitted to the Committee in a note by the Secretariat (A/C.2/56/L.6).

16. At the 30th meeting, on 21 November, the Vice-Chairman of the Committee, Felix Mbayu (Cameroon), informed the Committee of the outcome of the informal consultations held on the draft decision.

17. The Secretary of the Committee made a statement regarding the programme budget implications of the draft decision (see A/C.2/56/SR.30).

18. At the same meeting, on the proposal of the Vice-Chairman, the Committee adopted the draft decision contained in document A/C.2/56/L.6 (see para. 24, draft decision I).

E. Documents relating to the report of the Economic and Social Council

19. At its 40th meeting, on 12 December, on the proposal of the Chairman, the Committee decided to recommend to the General Assembly that it take note of documents before it under the item (see para. 24, draft decision II).

F. Biennial programme of work of the Second Committee

20. At the 40th meeting, on 12 December, the Chief of the Documentation Programming and Monitoring Unit introduced and orally revised the draft biennial programme of work of the Second Committee for 2002-2003 (see A/C.2/56/L.60).

21. At the same meeting, the representatives of the Islamic Republic of Iran (on behalf of the States Members of the United Nations that are members of the Group of 77 and China), Belgium (on behalf of the States Members of the United Nations that are members of the European Union), the United States of America and Cameroon made statements (see A/C.2/56/SR.40).

22. Also at the same meeting, the Committee adopted the draft biennial programme of work of the Second Committee for 2002-2003, as orally revised (see para. 24, draft decision III).

III. Recommendations of the Second Committee

23. The Second Committee recommends to the General Assembly the adoption of the following draft resolutions:

Draft resolution I

Integrated and coordinated implementation of and follow-up to the outcomes of the major United Nations conferences and summits in the economic and social fields

The General Assembly,

Welcoming Economic and Social Council resolution 2001/21 of 26 July 2001,

1. *Decides* to examine how best to address the reviews of the implementation of the outcomes of the major United Nations conferences and summits of the 1990s, in the economic and social fields, including their format and periodicity;

2. *Also decides* to include in the provisional agenda of its fifty-seventh session an item entitled “Integrated and coordinated implementation of and follow-up to the outcomes of the major United Nations conferences and summits in the economic and social fields”;

3. *Requests* the Secretary-General to make available to the Assembly the report requested by the Economic and Social Council for consideration at its substantive session of 2002 on the implementation of Council resolution 2001/21.

Draft resolution II Global Code of Ethics for Tourism

The General Assembly,

Recalling its resolution 32/156 of 19 December 1977, by which it approved the Agreement on Cooperation and Relationships between the United Nations and the World Tourism Organization,

Reaffirming paragraph 5 of its resolution 36/41 of 19 November 1981, in which it decided that the World Tourism Organization might participate, on a continuing basis, in the work of the General Assembly in areas of concern to that organization,

Also recalling the Manila Declaration on World Tourism of 10 October 1980 adopted under the auspices of the World Tourism Organization,² the Rio Declaration on Environment and Development³ and Agenda 21⁴ adopted at the United Nations Conference on Environment and Development on 14 June 1992 as well as the Amman Declaration on Peace through Tourism,⁵

Considering that the Commission on Sustainable Development, at its seventh session, held in April 1999, expressed interest in a global code of ethics for tourism and invited the World Tourism Organization to consider informed major groups’ participation in the development, implementation and monitoring of its global code of ethics for tourism,⁶

Further recalling its resolution 53/200 of 15 December 1998 on the proclamation of 2002 as the International Year of Ecotourism, in which, inter alia, it reaffirmed Economic and Social Council resolution 1998/40 of 30 July 1998, recognizing the support of the World Tourism Organization for the importance of ecotourism, particularly the designation of the year 2002 as the International Year of Ecotourism, in fostering better understanding among peoples everywhere, in leading to greater awareness of the rich heritage of various civilizations and in bringing about a better appreciation of the inherent values of different cultures, thereby contributing to the strengthening of world peace,

Recognizing the important dimension and role of tourism as a positive instrument towards the alleviation of poverty and the improvement of the quality of life for all people, its potential to make a contribution to economic and social development, especially of the developing countries, and its emergence as a vital force for the promotion of international understanding, peace and prosperity,

1. *Takes note with interest* of the Global Code of Ethics for Tourism adopted at the thirteenth session of the General Assembly of the World Tourism Organization, which outlines principles to guide tourism development and to serve as a frame of reference for the different stakeholders in the tourism sector, with the objective of minimizing the negative impact of tourism on environment and on cultural heritage while maximizing the benefits of tourism in promoting sustainable development and poverty alleviation as well as understanding among nations;

2. *Emphasizes* the need for the promotion of a responsible and sustainable tourism that could be beneficial to all sectors of society;

3. *Invites* Governments and other stakeholders in the tourism sector to consider introducing, as appropriate, the contents of the Global Code of Ethics for Tourism in relevant laws, regulations and professional practices, and in this regard recognizes with appreciation the efforts made and measures already undertaken by some States;

4. *Encourages* the World Tourism Organization to promote effective follow-up of the Global Code of Ethics for Tourism, with the involvement of relevant stakeholders in the tourism sector;

5. *Requests* the Secretary-General to follow up developments related to the implementation of the present resolution based on the reports of the World Tourism Organization and to report thereon to the General Assembly at its fifty-ninth session.

Draft resolution III

Public administration and development

The General Assembly,

Recalling its resolution 50/225 of 19 April 1996, adopted on the occasion of the resumed fiftieth session on the theme “Public administration and development”,

Recognizing that efficient, effective and transparent public administration, at both the national and international levels, has a pivotal role to play in the

implementation of the key objectives of the United Nations Millennium Declaration,⁷

1. *Welcomes* the establishment of the United Nations Public Administration Online Network as a powerful tool made available to Member States for the exchange of information and experience in public administration;

2. *Recommends* that the Network be expanded to strengthen the capacity of national ministries and institutions of public administration, to access information, experience and practice in public administration, and to receive online training;

3. *Requests* the Secretary-General to continue to assist Member States, particularly developing countries and countries with economies in transition, upon their request, in their process of reform, by fostering information-sharing, as appropriate, and the exchange of experience; assisting in building essential capacity and essential skills; providing assistance in institution-building; and improving the coordination of development assistance in this field;

4. *Also requests* the Secretary-General to study the possibility of periodically bringing together high-level policy makers responsible for public administration reform, under the auspices of the United Nations, to discuss issues of common interest and share valuable experience and practice, and to report the results of that study to the General Assembly at its fifty-seventh session;

5. *Further requests* the Secretary-General to keep under constant review the developments in this field in Member States and to highlight changes and trends as well as successes in this area, with particular emphasis on the role of public administration in the implementation of the United Nations Millennium Declaration,⁷ and to summarize his findings in a report to be submitted to the General Assembly at its fifty-seventh session through the Economic and Social Council.

24. The Second Committee also recommends to the General Assembly the adoption of the following draft decisions:

Draft decision I **Office of the President of the Economic and Social Council**

The General Assembly, recognizing the important functions entrusted to the Economic and Social Council in the Charter of the United Nations and reaffirming the United Nations Millennium Declaration,⁸ in which the General Assembly called, inter alia, for the further strengthening of the Council, building on its recent achievements, to help in fulfilling the role ascribed to it in the Charter, decides that the Office of the President of the Economic and Social Council should be provided with the means to carry out its important functions, taking into account the different

arrangements made for the principal organs of the United Nations listed in Article 7, paragraph 1, of the Charter.
