I. Introduction

1. At its 3rd plenary meeting, on 19 September 2001, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its fifty-sixth session the item entitled:

“Operational activities for development:

“(a) Triennial policy review of operational activities for development of the United Nations system;

“(b) Economic and technical cooperation among developing countries”

and to allocate it to the Second Committee.

2. The Second Committee considered the item at its 14th to 16th, 22nd and 38th to 40th meetings, on 25 and 26 October, 5 November and 10 to 12 December 2001. An account of the Committee’s discussion of the item is contained in the relevant summary records (A/C.2/56/SR.14-16, 22 and 38-40). Attention is also drawn to the general debate held by the Committee at its 3rd to 8th meetings, from 1 to 3 October (see A/C.2/56/SR.3-8).
