## Annex

### Annual note by the United Nations Administrative Tribunal

1. At its third plenary session, held in Paris on 20 December 1951, the Administrative Tribunal decided to submit a note each year to the President of the General Assembly. In accordance with this decision, the following note is submitted in respect of the year 2001.

#### A. Appointment of members of the Tribunal by the General Assembly

2. At its 51st plenary meeting, on 3 November 2000, the General Assembly, on the recommendation of the Fifth Committee (see A/55/105), appointed Omer Yousif Bireedo, Spyridon Flogaitis and Brigitte Stern as members of the United Nations Administrative Tribunal for a three-year term of office beginning on 1 January 2001.
