Summary statement by the Secretary-General on matters of which the Security Council is seized and on the stage reached in their consideration

Addendum

Pursuant to rule 11 of the provisional rules of procedure of the Security Council, the Secretary-General is submitting the following summary statement.

During the week ending 27 October 2001, the Security Council took action on the following items:

Meeting of the Security Council with the Troop-Contributing Countries to the United Nations Organization Mission in the Democratic Republic of the Congo pursuant to resolution 1353 (2001), annex II, section A (*see* S/2001/15/Add.42; *see also* S/1996/15/Add.43-45; S/1997/40/Add.5, 7, 9, 13, 16, 17 and 21; S/1998/44/Add.28, 35, and 49; S/1999/25/Add.10, 13, 24, 30, 43, 47 and 49; S/2000/40/Add.3, 7, 16, 17, 19, 21, 23, 30, 33, 40, 47 and 49; and S/2001/15/Add.5, 8, 18, 24, 30, 35 and 36)

On 22 October 2001, the 4391st (private) meeting was resumed, having been suspended on 18 October 2001.

At the close of the meeting, in accordance with rule 55 of the provisional rules of procedure of the Security Council, the following communiqué was issued through the Secretary-General in place of a verbatim record:

"On 18 and 22 October 2001, the Security Council, pursuant to annex II, section A, of resolution 1353 (2001), held its 4391st meeting in private with the troop-contributing countries to the United Nations Organization Mission in the Democratic Republic of the Congo (MONUC).



"The Security Council and the troop-contributing countries heard briefings under rule 39 of its provisional rules of procedure by Mr. A. Namanga Ngongi, Special Representative of the Secretary-General for the Democratic Republic of the Congo, and by Major-General Mountaga Diallo, Force Commander of MONUC.

"The members of the Council had a constructive exchange of views with representatives of participating troop-contributing countries.

"Mr. Ngongi responded to comments and questions posed by members of the Council and representatives of troop-contributing countries."

General issues relating to sanctions (see S/2000/40/Add.15)

The Security Council resumed its consideration of the item at its 4394th meeting, held on 22 and 25 October 2001 in accordance with the understanding reached in its prior consultations. There was one suspension and one resumption of the meeting.

On 22 October 2001, the President, with the consent of the Council, invited the representatives of Germany and Sweden, at their request, to participate in the discussion without the right to vote.

In the absence of objection, the President, with the consent of the Council, extended an invitation to the Permanent Observer of Switzerland to the United Nations to participate in the discussion, without the right to vote.

In accordance with the understanding reached in the Council's prior consultations, the President, with the consent of the Council, extended an invitation under rule 39 of the Council's provisional rules of procedure to Ibrahima Fall, Assistant Secretary-General for Political Affairs.

The situation concerning the Democratic Republic of the Congo (see

The Security Council resumed its consideration of the item at its 4395th and 4396th meetings, held on 24 October 2001 in accordance with the understanding reached in its prior consultations, having before it the ninth report of the Secretary-General on the United Nations Organization Mission in the Democratic Republic of the Congo (S/2001/970).

At the 4395th meeting, the President, with the consent of the Council, invited the representatives of Belgium, the Democratic Republic of the Congo, Mozambique, Namibia, Zambia and Zimbabwe, at their request, to participate in the discussion without the right to vote.

In accordance with the understanding reached in the Council's prior consultations, the President, with the consent of the Council, extended an invitation under rule 39 of the Council's provisional rules of procedure to Amos Namanga Ngongi, Special Representative of the Secretary-General for the Democratic Republic of the Congo. At the 4396th meeting, the President stated that, following consultations of the Council, he had been authorized to make a statement on behalf of the Council and read out the text of that statement (for the text, see S/PRST/2001/29; to be issued in *Official Records of the Security Council, Fifty-sixth Year, Resolutions and Decisions of the Security Council, 2001*).

Meeting of the Security Council with the Troop-Contributing Countries to the United Nations Transitional Administration in East Timor (UNTAET) pursuant to resolution 1353 (2001), annex II, section A (see also S/11593/Add.50 and 51; S/11935/Add.15 and 16; S/1999/25/Add.17, 22, 25, 30, 33-36, 42 and 50; S/2000/40/Add.4, 11, 16, 20, 25, 29, 30, 34, 35, 37, 38, 40, 46, 47 and 48; and S/2001/15/Add.4, 5, 14, 20, 31, 34 and 37)

The Security Council met to consider the item at its 4397th (private) meeting, held on 25 October 2001 in accordance with the understanding reached in its prior consultations.

At the close of the meeting, in accordance with rule 55 of the provisional rules of procedure of the Security Council, the following communiqué was issued through the Secretary-General in place of a verbatim record:

"On 25 October 2001, the Security Council, pursuant to annex II, section A, of resolution 1353 (2001), held its 4397th meeting in private with the troopcontributing countries to the United Nations Transitional Administration in East Timor (UNTAET).

"The Security Council and the troop-contributing countries heard a briefing under rule 39 of its provisional rules of procedure by Mr. Hédi Annabi, Assistant Secretary-General for Peacekeeping Operations.

"The members of the Council had a constructive exchange of views with representatives of participating troop-contributing countries."
