## Election of 20 members of the Commission on Human Settlements

## Note by the Secretary-General

1. Pursuant to General Assembly resolutions 32/162 of 19 December 1977, 40/202 of 17 December 1985 and 45/264 of 13 May 1991, the Economic and Social Council is to elect, at its resumed organizational session for 2002, 20 members of the Commission on Human Settlements, for a four-year term beginning on 1 January 2003, to fill the vacancies created by the expiration on 31 December 2002 of the terms of the following members: Argentina, Bolivia, Brazil, Cameroon, Chile, Democratic Republic of the Congo, Finland, Gabon, Gambia, Iran (Islamic Republic of), Japan, Lithuania, Mali, Pakistan, Russian Federation, Senegal, Turkey, United Kingdom of Great Britain and Northern Ireland, United States of America and Viet Nam.
2. In accordance with paragraph 1 of section II of General Assembly resolution $32 / 162$, the 20 members are to be elected on the following basis:

Six seats for African States;
Four seats for Asian States;
Two seats for Eastern European States;
Four seats for Latin American and Caribbean States;
Four seats for Western European and other States.
