Programme budget for the biennium 2002-2003

Utilization of the provision for special political missions under section 3, Political affairs

Note by the Secretary-General

1. The General Assembly, in its resolution 56/254 A of 24 December 2001, appropriated under section 3, Political affairs, of the programme budget for the biennium 2002-2003 an amount of \$98,338,700 for special political missions.
2. As described in paragraph 3.46 of the proposed programme budget for the biennium 2002-2003, the utilization of the amount would be subject to individual legislative mandates and approval by the General Assembly as and when the Security Council and/or the Assembly establish or renew such mandates.
3. By its resolution 56/255 of 24 December 2001, the General Assembly approved charges amounting to \$11,113,400 for special political missions relating to matters of which the Security Council is seized. By adopting resolutions 56/220 A and B of 21 December 2001 concerning the situation in Afghanistan; 56/223 of 24 December 2001 on the United Nations Verification Mission in Guatemala; 56/224 of 24 December 2001 concerning the situation in Central America; and 56/231 of 24 December 2001 concerning the situation of human rights in Myanmar, the Assembly further approved charges amounting to \$22,576,900 for special missions authorized by the Assembly.
4. During the first part of the resumed fifty-sixth session, the General Assembly will have approved, in the context of estimates pertaining to matters of which the Security Council is seized, additional charges totalling \$30,345,100 against the provision of \$98,338,700 for special political missions, as detailed in the annex to the present report.
5. The Fifth Committee may wish to take note that an unallocated balance of \$34,303,300 remains against the provision of \$98,338,700 for special political missions for 2002-2003.
