Item 1 Adoption of the agenda

Item 2 Matters of interest arising since the forty-eighth session

Document for this session: TRADE/WP.7/GE.2/2002/2

Document -/2002/2 sums up relevant outcome of fifty-seventh session of the Working Party on Standardization of Perishable Produce and Quality Development.

Item 3 Revision of UN/ECE standards

(a) Inshell Walnuts

Document for this session: TRADE/WP.7/GE.2/2002/3 (Secretariat) - text of the revised standard

A number of editorial changes had been decided at the last session of the Specialized Section. The present document contains the revision of the standard which should be transmitted to the Working Party for adoption.

(b) Walnut Kernels

Background document: TRADE/WP.7/2001/9/Add.8 (Secretariat) - *Text of the standard in force*

The standard was adopted by the Working Party. The colour chart has not been printed yet because some more editorial issues had to be clarified (inclusion of a lemon coloured kernel, separation/ new text for the black kernel).

Because the chart was urgently needed in trade it was decided to form an editorial group consisting of the delegations of France and the United States, the Chairman of the Specialized Section and the secretariat, who would review the new draft to be provided by INC before deciding to have the 1,000 copies printed. Should INC not be able to print the chart, the OECD Scheme might be approached to undertake this work.
