**Administrative and budgetary aspects of the financing of the
United Nations peacekeeping operations**

Approved budgetary levels for peacekeeping operations for the period from 1 July 2001 to 30 June 2002

Note by the Secretary-General

1. Pursuant to section 1, paragraph 8, of General Assembly resolution 49/233 A of 23 December 1994, information on the initial estimated budgetary requirements of all current peacekeeping operations, inclusive of requirements for the support account for peacekeeping operations and the United Nations Logistics Base at Brindisi, Italy, during the period from 1 July 2001 to 30 June 2002, was provided in the note by the Secretary-General dated 31 May 2001 (A/C.5/55/43).
2. In accordance with established practice, the present note has been prepared taking into account further financing actions by the General Assembly during its fifty-sixth regular session in respect of the United Nations Interim Force in Lebanon, the United Nations Transitional Administration in East Timor, the United Nations Mission in Sierra Leone, the United Nations Mission in Ethiopia and Eritrea, the United Nations Organization Mission in the Democratic Republic of the Congo and the support account for peacekeeping operations. The additional financing authorized by the General Assembly for the support account for peacekeeping operations has been apportioned among the five missions for which further financing actions were approved by the General Assembly at its fifty-sixth session.
3. Further financing action was taken by the General Assembly during its resumed fifty-sixth session in respect of the United Nations Organization Mission in the Democratic Republic of the Congo (MONUC), requiring that the budgetary information contained in A/C.5/56/36 be updated. The changes are reflected in the MONUC column of the attached annex.
4. The Fifth Committee is requested to take note of these amounts.
