Note by the Secretary-General

- 1. The International Covenant on Economic, Social and Cultural Rights, adopted by the General Assembly in resolution 2200 A (XXI) of 16 December 1966 entered into force on 3 January 1976, three months after the date of the deposit with the Secretary-General of the United Nations of the thirty-fifth instrument of ratification, as provided for in article 27 of the Covenant.
- 2. As at 1 January 2002 the Covenant had been ratified or acceded to by 145 States. A list of States parties as well as information on the status of the submission of reports by States parties, is to be found in the annex to the present document.
