### **Election to fill a vacancy on the Finance Committee in accordance with section 9, paragraph 5, of the annex to the Agreement relating to the implementation of Part XI of the United Nations Convention on the Law of the Sea**

#### **Note by the Secretary-General**

1. The Assembly is invited to note that Paul McKell (United Kingdom of Great Britain and Northern Ireland) has resigned from the Finance Committee with effect from 23 May 2002. Mr. McKell was elected as a member of the Finance Committee in July 2001 for a term of five years.
2. Section 9, paragraph 5, of the annex to the Agreement relating to the implementation of Part XI of the United Nations Convention on the Law of the Sea, provides that in the event of the death, incapacity or resignation of a member of the Finance Committee prior to the expiration of the term of the office, the Assembly shall elect for the remainder of the term a member from the same geographical region or group of States.
3. In accordance with section 9 of the Agreement, the Finance Committee shall be composed of 15 members with appropriate qualifications relevant to financial matters. Members of the Finance Committee shall be elected by the Assembly.
4. By a letter dated 22 May 2002, the United Kingdom informed the Secretariat of the Authority of the nomination of Michael C. Wood, Legal Adviser to the Foreign and Commonwealth Office, to fill the vacant seat on the Finance Committee. The curriculum vitae of Mr. Wood appears in the annex to the present document.<sup>1</sup>
