Number 21 of 1999

The Minister of Health and Population:

- After perusal of Law 127 of 1955 on the practice of the profession of pharmacy and its implementing regulations;
- And of Law 182 of 1960 on combating narcotic drugs and regulating their use and trade therein, as amended by Law 122 of 1989;¹
- And of Ministerial Decree 487 of 1985 on the regulation of the circulation of certain pharmaceutical substances and preparation affecting the psychological condition;²
- And of Ministerial Decree 89 of 1989 on the addition of Flunitrazepam and its preparations to Schedule 3 of Law 182 of 1960, referred to above;
- And on the basis of a submission by the Head of the Central Administration for Pharmaceutical Affairs;

Has decided

Article 1. Flunitrazepam 5-(O-FLUOROPHENYL)-1-3-DIHYDRO-1-METHYL-7-NITRO-2H-1,4BENZODIAZEPIN-2-ONE and its preparations shall be added to the second section of Schedule 1 attached to Law 182 of 1960, to which reference is made.

Article 2. Flunitrazepam and its preparations, to which reference is made in the preceding article, shall be deleted from paragraph (d) of Schedule 3 attached to Law 182 of 1960 on combating narcotic drugs, as amended by Law 122 of 1989.

Article 3. This Decree shall be published in the Official Gazette and shall come into force on the day following its publication.

Decree by the Minister of Health and Population

Number 195 of 1999

On the addition of a number of narcotic substances to
the Schedules attached to Law 182 of 1960

The Minister of Health and Population:

- After perusal of Law 182 of 1960 on combating narcotic drugs and regulating their use and trade therein, as amended by Law 122 of 1989;¹
- And of the Single Convention on Narcotic Drugs of 1961, the Convention of Psychotropic Substances of 1971 and the United Nations Convention against Illicit Traffic in Narcotic Drugs and Psychotropic Substances of 1988;
- And of Decree 487 of 1985 by the Minister of Health on the regulation of the circulation of certain pharmaceutical substances and preparations affecting the psychological condition;²
- And on the basis of a submission by the Head of the Central Administration for Pharmaceutical Affairs;

Has decided

Article 1. The following substances shall be added to the second section of Schedule 1 attached to Law 182 of 1960:

(a) Dihydroetorphine 7, 8-dihydro- 7 - - [1- (R)-hydroxy - 1- methylbutyl] -6.14 - endo ethanotetrahydrooripavine;

(b) Remifentanil 1-(2- methoxycarbonyl-ethyl)- 4- (phenylpropionylamino) - piperidine -4 -carboxylicacidmethyl ester;

(c) The isomers of all substances listed in Schedule 1;

(d) The esters and ethers of all substances listed in Schedule 1;

(e) The salts of all substances listed in Schedule 1, including the salts of esters and ethers and isomers whenever these salts exist;

(f) The stereoisomers of all the substances listed in Schedule 1.

Article 2. This Decree shall be published in the Official Gazette and shall come into force from the date of its publication.
