EXPLANATORY NOTES

The Intergovernmental Working Group to draw up a legally binding instrument on civil liability for transboundary damage caused by hazardous activities, within the scope of the UNECE Conventions on the Protection and Use of Transboundary Watercourses and International Lakes (Water Convention) and on the Transboundary Effects of Industrial Accidents (Industrial Accidents Convention) was established by the Parties to both Conventions at their joint special session at Geneva on 2-3 July 2001 (ECE/MP.WAT/7 - ECE/CP.TEIA/5). Its first meeting took place at Geneva on 21-23 November 2001 (MP.WAT/AC.3/2001/2 - CP.TEIA/AC.1/2001/2), its second meeting on 4-6 February 2002 (MP.WAT/AC.3/2002/3 - CP.TEIA/AC.1/2002/3), and its third meeting on 6-8 May 2002 (MP.WAT/AC.3/2002/6 - CP.TEIA/AC.1/2002/6).
