COMMISSION ON HUMAN RIGHTS Sub-Commission on the Promotion and Protection of Human Rights Fifty-fourth session Item 1 of the provisional agenda

ORGANIZATION OF WORK

Note by the secretariat*

- 1. At its forty-ninth session, the Sub-Commission, in its decision 1997/113, decided not to adopt resolutions or decisions henceforth under its agenda item entitled "Question of the violation of human rights and fundamental freedoms, including policies of racial discrimination and segregation and of apartheid, in all countries, with particular reference to colonial and other dependent countries and territories: report of the Sub-Commission under Commission on Human Rights resolution 8 (XXIII)" in respect of human rights situations which the Commission on Human Rights was considering under the public procedures for dealing with human rights violations.
- 2. In its resolution 2002/66, entitled "Work of the Sub-Commission on the Promotion and Protection of Human Rights", the Commission on Human Rights reiterated and reaffirmed:
- (a) Its decision that the Sub-Commission should not adopt country-specific resolutions or decisions and, in negotiating and adopting thematic resolutions or decisions, should refrain from including references to specific countries; and

- (b) That the Sub-Commission should continue to be able to debate country situations not being dealt with in the Commission, as well as urgent matters involving serious violations of human rights in any country, and that its discussions would be reflected in the summary records of its debates, which should continue to be forwarded to the Commission.
- 3. In order to assist the Sub-Commission, the secretariat has prepared a list of the human rights situations currently under consideration by the Commission under public procedures for dealing with human rights violations (annex I) and a list of country situations currently being considered by the Commission under the agenda items entitled "Organization of the work of the session", "Report of the United Nations High Commissioner for Human Rights and follow-up to the World Conference on Human Rights", "The right of peoples to self-determination and its application to peoples under colonial or alien domination or foreign occupation" and "Advisory services and technical cooperation in the field of human rights" (annex II).
