My Dear President,

In reply to your kind letter of 8 May, in which you call my attention to the fact that 13 May is the date the Commission for Conventional Armaments is to report to the Security Council the proposals which the Commission may be in a position to recommend, I regret to inform you that the Sub-Committee of five members which was charged by the Commission at the meeting on 9 April to submit a plan of work, has met only once under my chairmanship, owing to a series of unexpected circumstances and is therefore not in a position to submit any definite proposals to the Commission. I am, however, calling a meeting of the Sub-Committee for the evening of next Tuesday, 13 May, which seems to be the earliest available date convenient to all its members. I shall inform you, without delay, of the result of the meeting.

Mr. Chairman,

Under the resolution of 13 February 1947, by which the Security Council created the Commission for Conventional Armaments this Commission is instructed to submit within the space of not more than three months, such proposals as it may be in a position to formulate.

At its meeting hold on 9 April, the Commission asked a Sub-Committee under your Chairmanship to prepare a plan of work for submission to the Security Council in accordance with the latter's resolution.

Since the time limit of three menths is about to expire, I should be obliged if you could let me have a statement, for communication to the Commission for Conventional Armaments and, if necessary, to the President of the Security Council, of progress of the work being done by the Sub-Committee and of the steps contemplated by it with a view to enabling the Commission to comply with the instructions it has received from the Security Council.
