SUMMARY STATEMENT BY THE SECRETARY-GENERAL OF MATTERS OF WHICH THE SECURITY COUNCIL IS SEIZED AND OF THE STAGE REACHED IN THEIR CONSIDERATION

At the request of the Acting Mediator, the Security Council hold its 378th and 379th meetings in private on 9 and 10 November to hear his views on the truce situation in Palestire and to consider the best possibilities for a more permanent arrangement. The Acting Mediator submitted certain suggestions which were put in the form of a draft resolution for purposes of convenience (S/1076). After an exchange of views among the representatives on the Council, during which the USSR representative submitted amendments to the Acting Mediator's draft resolution, the Council decided to resume public /mostilla đđ



meetings for further consideration of this matter.
