A. Introduction

1. The Executive Director presents in this report a summary of the financial situation of the United Nations Population Fund (UNFPA) for the year ended 31 December 2001.
2. The financial items in this report have been presented in accordance with recommendations by the United Nations Board of Auditors (A/53/217) as well as with Executive Board decision 97/6 on the harmonization of the budgets of UNDP, UNICEF and UNFPA. The information provided in table 1 is consistent with the current presentation of UNFPA financial statements for the biennium ended 31 December 2001.

B. Overview

3. As shown in table 1 "Income and expenditure for the year ended 31 December 2001", income to UNFPA from all sources totalled \$396.4 million (2000: \$414.1 million). This is made up of \$268.6 million of Regular Funds and \$127.8 million from Other Funds. Expenditure totalled \$254.2 million for Regular Funds and \$123.5 million for Other Funds. This resulted in a net surplus of \$14.4 million to Regular Funds and of \$4.3 million to Other Funds. As discussed in more detail below, the \$14.4 million surplus in Regular Funds will be fully utilized in programme expenditures in 2002. The surplus of \$4.3 million in Other Funds relates mostly to trust-fund projects intended to last for more than one year.

C. Income to Regular Funds

4. Income to Regular Funds remained largely unchanged at \$268.6 million, compared to \$264.0 million in the previous year (re-stated to include savings on prior year obligations).
5. The United States dollar continued to strengthen in 2001 serving to hide the underlying trend in Regular Funds which was for substantial increases in donor contributions. As table 3 shows, had exchange rates remained at 2000 levels, Regular Funds contributions would have been \$9.0 million higher. In local currency terms, donors increased their funding for UNFPA by \$10.8 million.
6. The largest single increase was from Germany: an increase of \$3.8 million. The Netherlands, Norway and Belgium all made increases to their contributions of over \$2 million. Of a total of 17 donors giving more than \$1 million in 2001 (an increase of 1 compared to 2000), 7 increased their contributions, 3 decreased and 7 remained unchanged.

7. The total number of donors continued to rise, increasing by 20 per cent to 121 in 2001. Coupled with the increase in contributions, the trend to give multi-year pledges continued with 25 donors pledging for more than one year¹.

D. Status of reserves and unspent Regular Funds

8. Table 7 shows the status of the operational reserve, the reserve for field accommodation, and unspent funds for the period 1992 to 2001. The operational reserve, as mandated by the Governing Council in decision 91/36, is set at 20 per cent of Regular Fund income for that year. The operational reserve is considered necessary to provide a sufficient level of working capital.

9. The reserve for field accommodation was created by the Governing Council in decision 91/36 for financing the Fund's share of construction costs of common field office premises with other United Nations organizations. As outlined in paragraphs 35 and 36 of document DP/FPA/1999/11 and as noted in Executive Board decision 99/21, this reserve is being used in the current biennium to cover the Fund's share of costs associated with the United Nations House programme.

10. Unspent funds are the balance of Regular Funds in excess of the Operational Reserve and reserve for field accommodation. When such funds exist, they are largely utilized for programme expenditure in the following year.

11. As Table 7 shows, there was no transfer required to or from the operational reserve in 2001. This reflects the consistency in income from 2000 to 2001 in United States dollar terms.

E. Expenditure from Regular Funds

12. Project expenditure increased by 35 per cent to \$171.7 million in 2001 compared to \$127.5 million in 2000. Country ceilings were set higher in 2001 than in 2000 to facilitate higher programme expenditure.

13. Figure 7 shows the proportion of project expenditure by country category for 1998-2001. Funds expended in category A countries continued to increase in 2001 both in absolute and percentage terms. The proportion spent on category A countries moved closer to the target share of 67-69 per cent endorsed in Executive Board decision 2000/19, rising from 62.5 per cent in 1998 to 66.5 per cent in 2001. The proportion spent on category B countries moved to just below the target share of 19-21 per cent, falling from 27.5 per cent in 1998 to 18.8 per cent in 2001. (The endorsed target share for category B countries in the resource allocation system

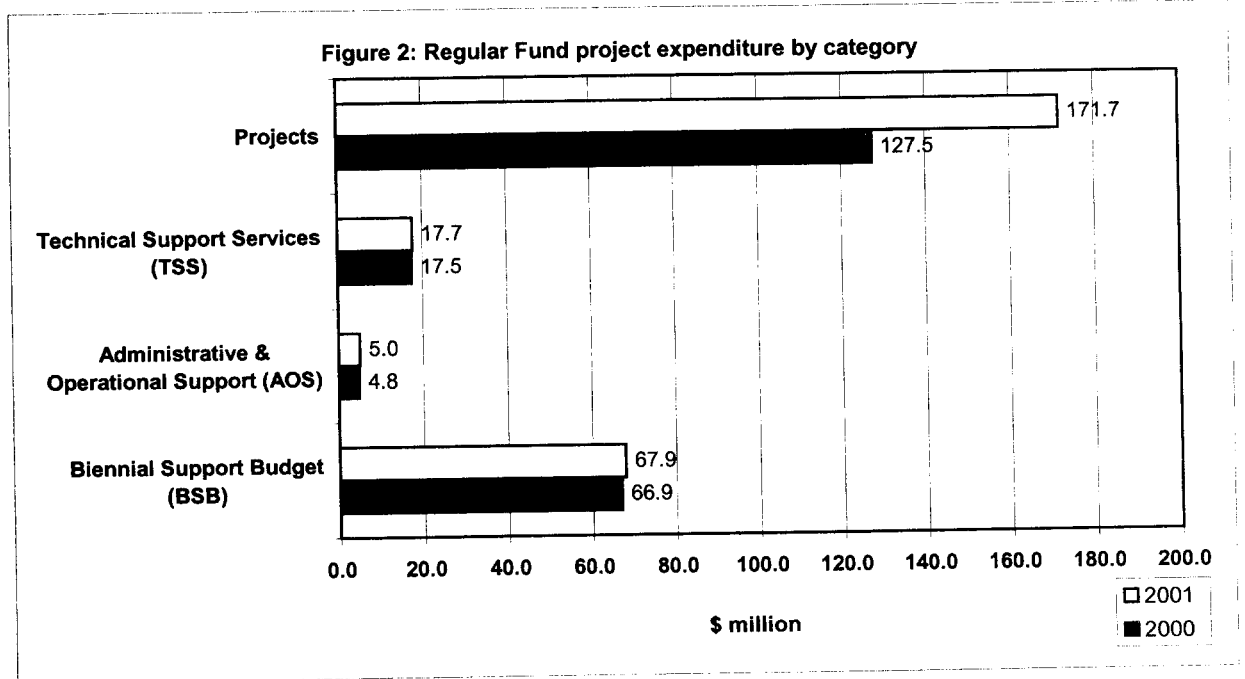
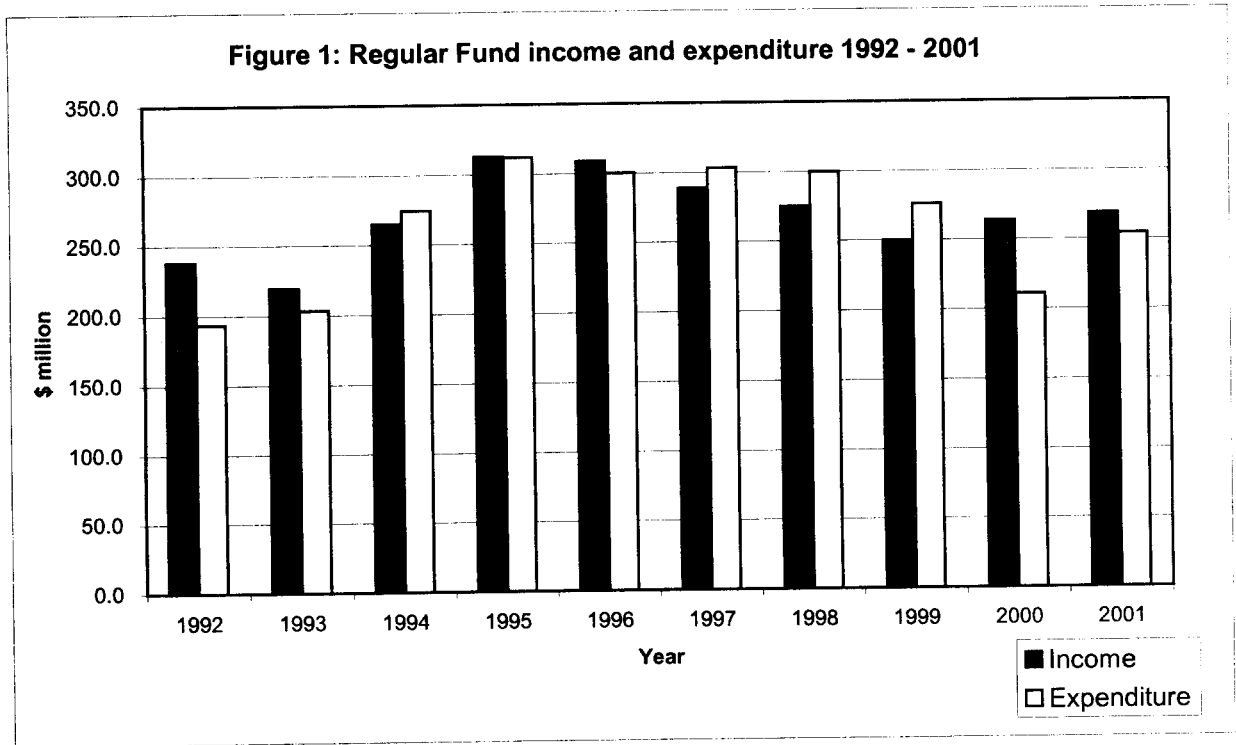


Figure 3: Regular Fund project expenditure by executing agency

approved by the Executive Board in 1996 had been 22-24 per cent.) The proportions spent on category C, T and O countries also moved closer to the target shares endorsed in decision 2000/19 (7-9 per cent, 3-4 per cent, and 1.5 per cent, respectively). Expenditure by region was in line with the previous year, as shown in figure 6. The largest increases in terms of executing agency were in UNFPA and government execution, as shown in figure 3.

14. The large increase in project expenditure resulted in a reduction in the level of transfers to unspent funds from \$53.2 million in 2000 to \$14.4 million in 2001. This is shown in table 7. The balance of \$39.6 million in unspent funds as at 31 December 2001 has been programmed for expenditure in 2002 and will be fully utilized in that year. The transfer from unspent funds to programme activities in 2002 is especially timely given the funding restrictions UNFPA is currently operating under.

F. Biennial support budget

15. Table 9 analyses the biennial support budget (BSB) by cost and compares this with total income and expenditure. The net BSB remained largely unchanged in 2001, rising slightly from \$56.4 million in 2000 to \$57.1 million in 2001. This reflects the Fund's aim of containing administrative costs so as to maximise project expenditure.

16. As both income and the net BSB remained constant, the net BSB as a percentage of income stayed at 21 per cent. The large increase in project expenditure meant that the BSB as a percentage of expenditure fell from 27 per cent to 23 per cent.

17. Income to the BSB consists of overheads charged to projects supported by Regular and Other Funds, and fees charged for commodity procurement services. Table 10 shows the increase in this income from \$10.5 million in 2000 to \$10.8 million in 2001.

18. Table 10 also provides an analysis of the BSB by type of cost for 2000 and 2001. The breakdown for 2001 is, as would be expected, broadly in line with the previous year.

G. Other Funds

19. Income to Other Funds fell from \$143.1 million in 2000 to \$123.5 million in 2001. It was noted in the previous review (DP/FPA/2002/11) that a contribution of \$40.8 million from the Netherlands was received at the end of 2000. This contribution accounted for the significant increase in income to Other Funds in 2000 (compared to 1999) and accounts for the comparative decrease in 2001. The underlying trend in other fund income remains upwards. Table 8 provides an analysis of the major categories of Other Funds.

20. Trust funds represent contributions made with restrictions imposed by the donor as to their use. Contributions under trust fund agreements totalled \$109.6 million in 2001 compared with \$91.2 million in 2000.

21. Other trust funds are funds put in trust by UNFPA for specific purposes such as the Rafael M. Salas Lecture series and the Global Contraceptive Commodity Programme (GCCP), a fund used to supply contraceptives and other goods at short notice in emergency situations. The balance of other trust funds totalled \$8.3 million at the end of 2001 compared with \$8.6 million at the end of 2000.

22. Cost-sharing funds are the final major category within Other Funds. These funds consist of contributions from Governments to individual Regular Fund projects rather than to UNFPA Regular Funds in general. Whereas trust funds are used to finance projects that are separate and distinct from Regular Fund projects, cost-sharing projects are an extension of existing Regular Fund projects using an alternative source of funding. This source of income continued to grow, increasing by 6.5 per cent from \$11.8 million in 2000 to \$12.5 million in 2001.

H. Assets and liabilities

23. Net assets rose from \$82.2 million in 2000 to \$96.6 million in 2001 mainly due to the rise in unspent funds, all of which are budgeted for use in 2002.

24. Cash balances are held by UNDP on behalf of UNFPA. These funds are invested in United States dollar, high-interest, bid deposit accounts. Interest is credited back to individual funds unless otherwise agreed with the donor.

I. Conclusion

25. **UNFPA ended 2001 as it did 2000, in a strong financial position. While the reduction in funding in 2002 will adversely affect programmes, the financially healthy position at the end of 2001 will help to alleviate some of the negative effects of these decreases in income.**

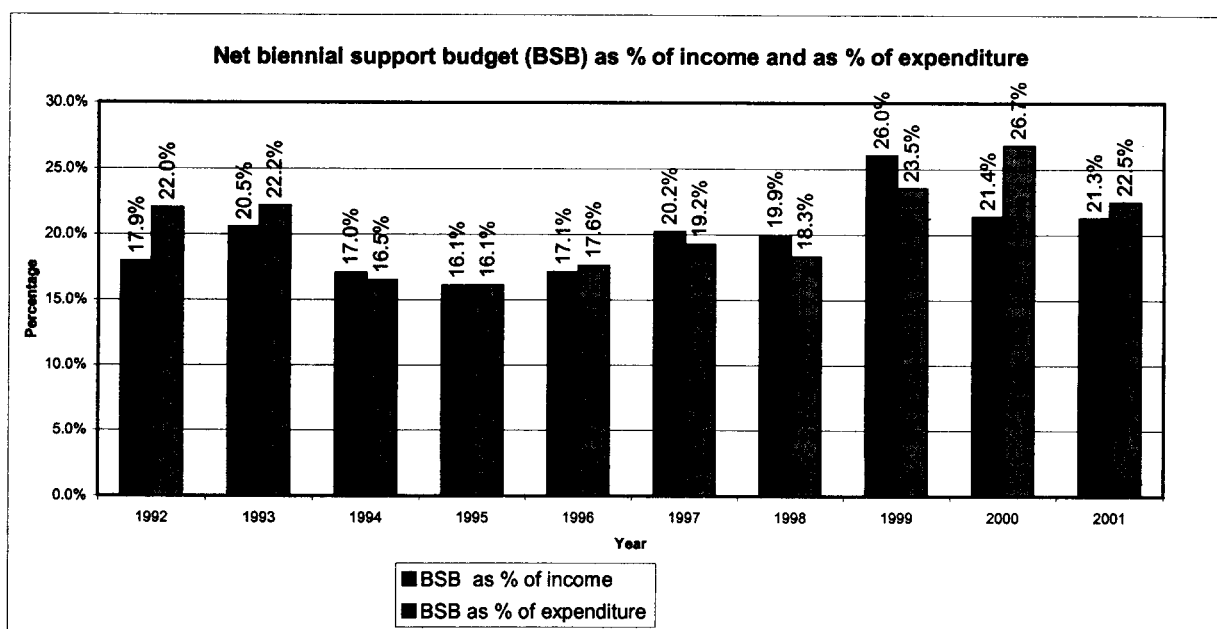

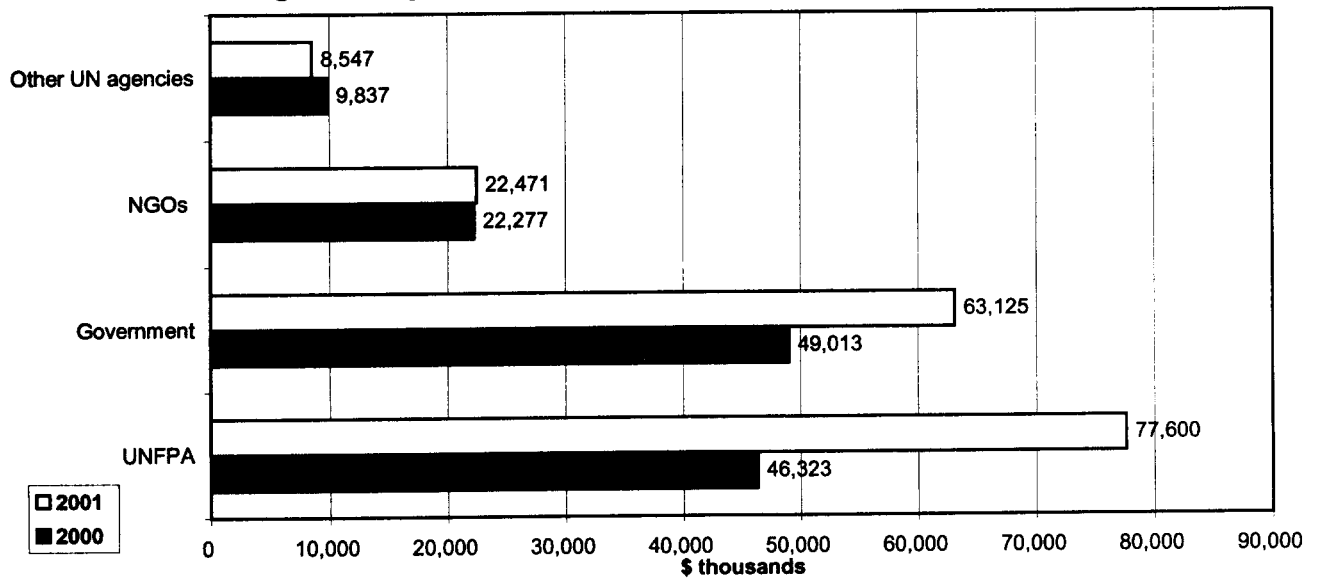
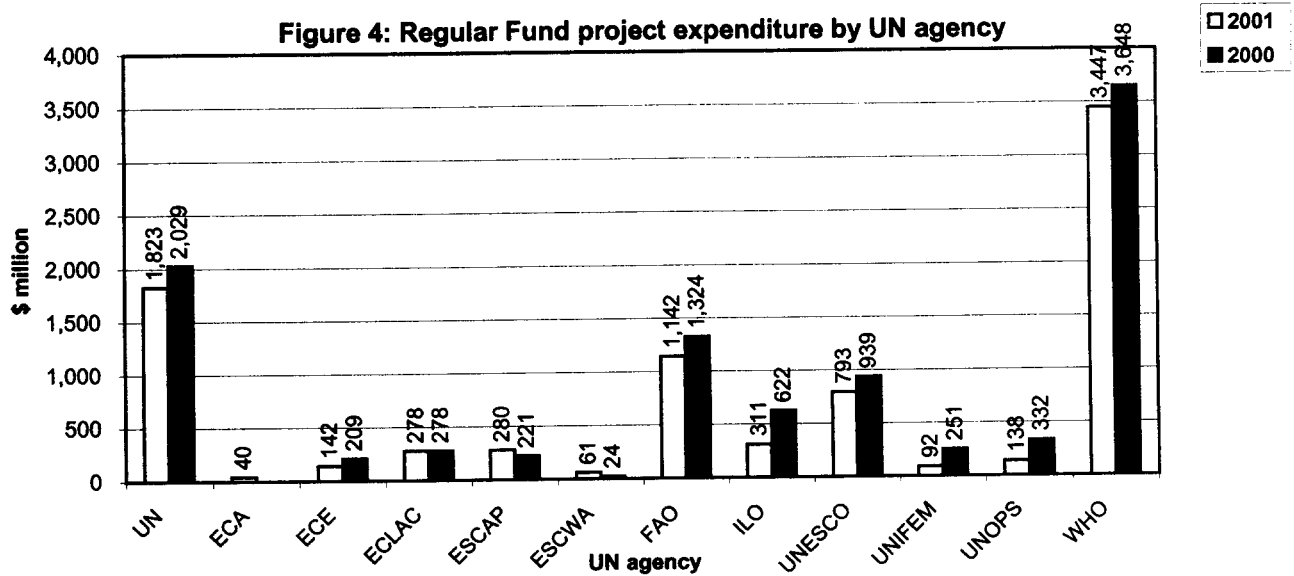


Figure 4: Regular Fund project expenditure by UN agency



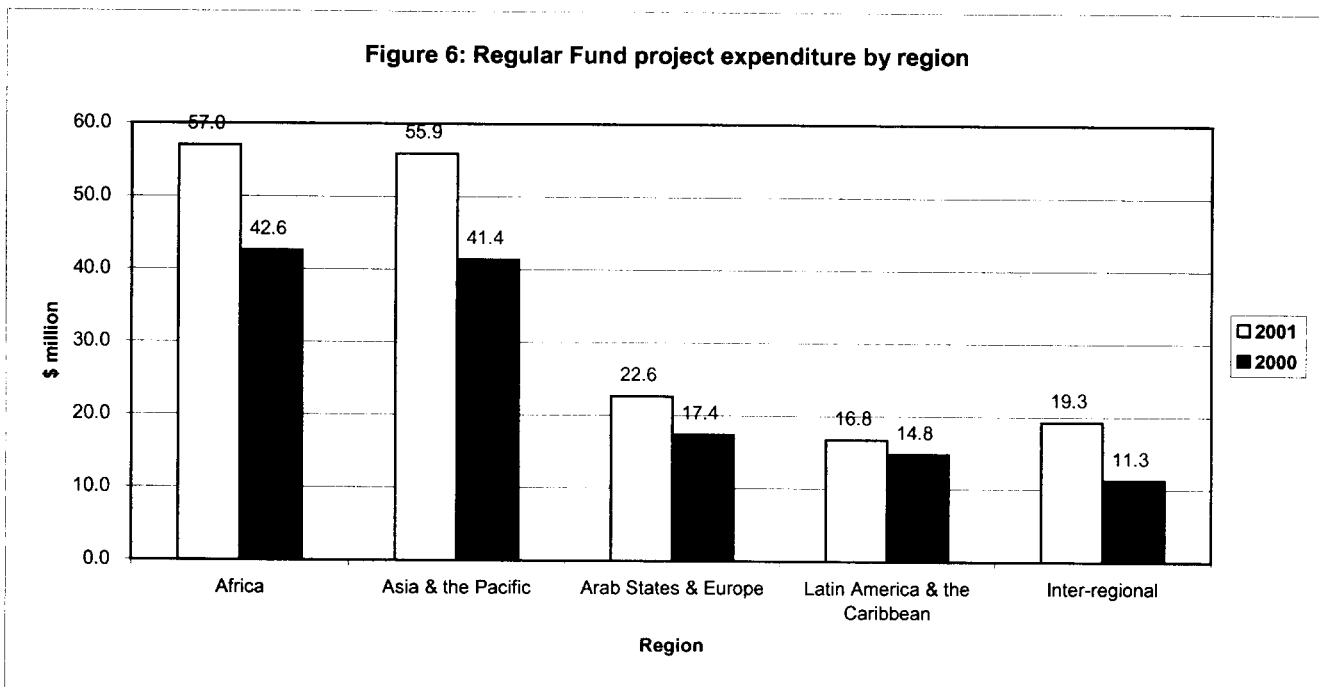
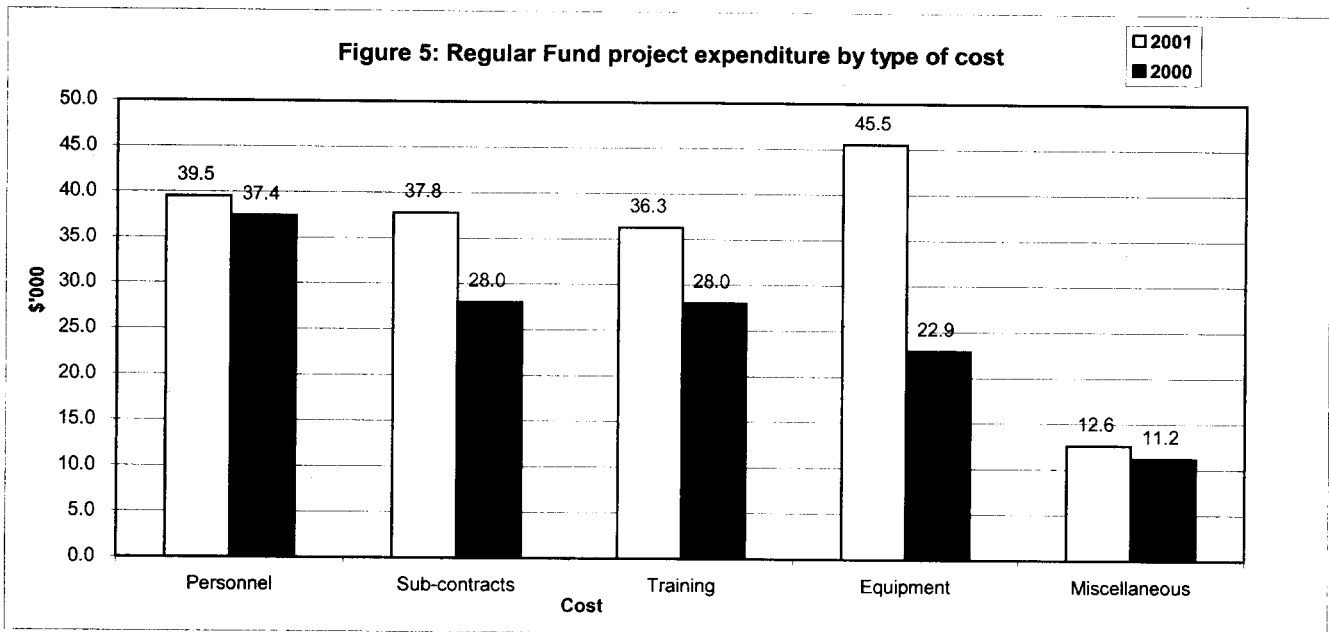


Figure 7: Regular Fund project expenditure by country category
