## Annex to the letter dated 17 September 2002 from the Chargé d'affaires a.i. of the Permanent Mission of Belarus to the United Nations addressed to the Secretary-General

## **President of the Republic of Belarus**

Minsk, 11 September 2002

The tragic events of 11 September 2001 marked the start of efforts by the international community to find new approaches to solving the problem of terrorism.

The spread of international terrorism and its links with transnational organized crime, the illicit drugs trade and illegal arms trafficking have become a threat to the foundations of international relations as enshrined in the Charter of the United Nations.

It is important that precisely the United Nations has taken the lead in establishing a global anti-terrorist coalition. The adoption of Security Council resolution 1373 (2001) and the establishment of the Counter-Terrorism Committee confirmed the fact that the United Nations could be at the heart of the international community's endeavour to find strategies and tactics to deal with terrorism. The international community thus acknowledged that the collective approach was the only possible and effective way to combat the evil of terrorism.

The Republic of Belarus considers itself an integral part of the international anti-terrorist coalition. It wholeheartedly supports the work of the Counter-Terrorism Committee and is actively cooperating with it.

The consistency of the approach adopted by the Republic of Belarus is confirmed by the fact that it is a party to nine international multilateral antiterrorism treaties and will very soon complete the procedures for becoming a party to the remaining three.

Issues relating to counter-terrorism are kept under constant review by all agencies in the State administration of Belarus. In January 2002, the country's Act on combating terrorism entered into force. The National Bank of the Republic of Belarus has taken the decision to freeze the accounts of terrorists, terrorist organizations and persons associated with them.

With its fully effective export-control system and its membership of the Nuclear Suppliers Group, Belarus takes an active part in preventing the proliferation and use by terrorists of nuclear, biological and chemical weapons, conventional weapons and weapon-production technologies.

We welcome your personal efforts to strengthen existing United Nations counter-terrorism structures and to develop, under its auspices, a comprehensive convention on international terrorism. In view of the exceptional importance of joint action in combating international terrorism, Belarus will continue to support in every way the Organization's efforts to confront this contemporary challenge.
