

SUMMARY STATEMENT BY THE SECRETARY-GENERAL OF MATTERS OF WHICH THE SECURITY COUNCIL IS SEIZED AND OF

THE STAGE REACHED IN THEIR CONSIDERATION

Pursuant to rule 11 of the provisional rules of procedure of the Security Council, I submit the following summary statement of matters of which the Security Council is seized and of the stage reached in their consideration on 10 December 1948.

By letter dated 7 December 1948, (S/1110) the Chairman of the Council's Committee on the Admission of New Members informed the President of the Security Council that the Committee had come to the conclusion that it was not at present in possession of the requisite information to enable it to come to any decision. The letter further stated that the Committee considered that it would be for the Security Council to decide at the proper time whether to refer the matter back to the Committee or take a decision

On 8 December the Acting Mediator met with Committee 17, established by the Council's resolution of 4 November, and sought further advice on the implementation of the Council's resolution of 4 November.
