CABLEGRAM DATED 17 JULY 1950 FROM THE MINISTER OF FOREIGN AFFAIRS OF ARGENTINA TO THE SECRETARY-JENERAL IN REPLY TO THE SECRETARY-CENERAL'S CABLEGRAM OF 14 JULY 1950 CONCERNING THE SECURITY COUNCIL RESOLUTIONS OF 25 AND 27 JUNE AND 7 JULY 1950 (S/1501, S/1511, S/1588)

I HAVE THE HONOUR TO ACKNOWLEDGE RECEIPT OF YOUR COMMUNICATION OF 14 JULY IN WHICH YOU STATE: 1. THAT YOU HAVE BEEN INFORMED THAT THE GOVERNMENT OF THE United States which has been made responsible for the unified command under the RESOLUTION OF 7 JULY 1950 IS NOW PREPARING TO ENTER INTO DIRECT CONSULTATION WITH MY COVERNMENT CONCERNING THE CO-ORDINATION OF ANY ASSISTANCE WHICH MY GOVERNMENT MAY PROVIDE IN A GENEVAL PLAN FOR THE ATTAINMENT OF THE OBJECTIVES SET FORTH IN THE SECURITY COUNCIL RESOLUTIONS; 2. THAT THE UNIFIED COMMAND HAS STATED THAT IT HAS URGENT NEED OF ADDITIONAL EFFECTIVE AID; 3. THAT IN CONSEQUENCE YOU WOULD BE CRATEFUL IF THE ARCENTINE GOVERNMENT, IN GIVING CONSIDERATION TO THE QUESTION OF ASSISTANCE. WOULD TAKE INTO ACCOUNT THE POSSIBILITY OF PROVIDING CCMBAT FORCES. IN THIS CONNEXION I HAVE PLEASURE IN INFORMING YOU THAT THE ARGENTINE COVERNMENT HAS NOTED YOUR COMMINICATION AND THAT. IN ACCORDANCE WITH ITS PURFOSE OF FULFILLING THE OBLIGATIONS IT HAS ASSUMED AS A MEMBER OF THE United nations and in particular those contained in the charger of the united NATIONS, IT IS WAITING FOR THE UNIFIED COMMAND TO ENTER INTO DIRECT CONSULTATION WITH THE ARGENTINE COVERNMENT IN CONFORMITY WITH THE CONFENTS OF YOUR TELEGRAM OF 14 JULY.
