~~CABLEGRAMS~~ DATED 18 AUGUST 1950 FROM THE DEPUTY PRIME MINISTER AND
MINISTER OF FOREIGN AFFAIRS OF CZECHOSLOVAKIA ADDRESSED TO
THE PRESIDENT OF THE SECURITY COUNCIL AND TO THE
SECRETARY-GENERAL

AS THE GOVERNMENT OF A MEMBER STATE OF THE UNITED NATIONS ORGANIZATION DULY OBSERVING CHARTER THE GOVERNMENT OF THE CZECHOSLOVAK REPUBLIC PROTESTS AGAINST THE EFFORTS OF THE UNITED STATES OF AMERICA AND OTHER MEMBERS OF THE SECURITY COUNCIL UNDER THEIR INFLUENCE TOWARDS GROSS VIOLATION OF THE PRINCIPLES OF EQUAL RIGHTS BY TRYING TO PREVENT THE REPRESENTATIVE OF THE PEOPLE'S DEMOCRATIC REPUBLIC OF KOREA FROM BEING HEARD IN THE SECURITY COUNCIL. THE UNITED NATIONS ORGANIZATION IS THUS BEING FORCED TO VIOLATE THROUGH ITS PRINCIPAL ORGAN RESPONSIBLE FOR THE MAINTENANCE OF PEACE AND SECURITY THE FUNDAMENTAL LEGAL PRINCIPLE OF CULTURAL MANKIND THAT IN ALL DISPUTES BOTH PARTIES SHOULD BE HEARD. ACCORDING TO THE PRINCIPLE OF ARTICLE 32 THE CHARTER REQUIRES THAT REPRESENTATIVES OF THE PEOPLE'S DEMOCRATIC REPUBLIC OF KOREA BE INVITED. THE PROPOSAL OF THE UNION OF SOVIET SOCIALIST REPUBLICS THAT THE REPRESENTATIVES OF THE KOREAN PEOPLE SHOULD BE HEARD IS THEREFORE NOT ONLY IN ACCORDANCE WITH THESE PRINCIPLES BUT IT REPRESENTS MOREOVER PROTECTION OF THE UNITED NATIONS ORGANIZATION AND ITS CHARTER WHICH IS BEING MISUSED BY THE IMPERIALISTIC AGGRESSIVENESS OF THE UNITED STATES OF AMERICA AND BY THEIR PRESSURE BROUGHT TO BEAR UPON THE MEMBERS OF THE SECURITY COUNCIL. THE CZECHOSLOVAK DELEGATION TO THE GENERAL ASSEMBLY HAS ALWAYS INSISTED ON THE OBSERVATION OF THESE PRINCIPLES. FROM THE VERY BEGINNING SINCE THE KOREAN CASE WAS ILLEGALLY BROUGHT BEFORE THE UNITED NATIONS ORGANIZATION BY THE UNITED STATES OF AMERICA THE CZECHOSLOVAK DELEGATION HAS PROPOSED THE INVITATION OF THE REPRESENTATIVES OF THE PEOPLE'S DEMOCRATIC REPUBLIC OF KOREA. THE CZECHOSLOVAK GOVERNMENT CALLS ON THE SECURITY COUNCIL WHICH HAS TO ACT ON BEHALF OF ALL THE MEMBERS OF THE UNITED NATIONS ORGANIZATION TO OBSERVE ITS DUTIES IN ACCORDANCE WITH THE PURPOSES AND PRINCIPLES OF THE UNITED NATIONS AND TO GIVE HEARING TO THE

THE TELEGRAM OF THE GOVERNMENT OF THE PEOPLE'S DEMOCRATIC REPUBLIC OF KOREA PROTESTING AGAINST THE BARBAROUS BOMBING BY THE AMERICAN ARMED FORCES. THE VICTIMS OF WHICH HAVE BEEN THE INHABITANTS OF KOREAN TOWNS AND VILLAGES HAS AROUSED THE INDIGNATION OF ALL THE PEOPLE OF CZECHOSLOVAKIA. THE CZECHOSLOVAK GOVERNMENT AND PEOPLE PROTEST AGAINST THE INTENTIONAL INACTIVITY OF THE SECURITY COUNCIL WHICH INSTEAD OF FULFILLING ITS OBLIGATIONS AS LAID DOWN BY THE CHARTER HAS DONE NOTHING TO CONDEMN THE CRIMINAL AMERICAN AGGRESSION AND TO PUT AN END TO THE SUFFERINGS OF THE KOREAN PEOPLE. THE CZECHOSLOVAK GOVERNMENT DEMANDS THEREFORE THAT THE SECURITY COUNCIL TAKE ACTION IN THE MATTER OF THE SHOCKING DOCUMENT OF THE GOVERNMENT OF THE PEOPLE'S DEMOCRATIC REPUBLIC OF KOREA BY RESOLUTELY CONDEMNING THESE BARBAROUS ACTS AND ORDERING THEIR IMMEDIATE CESSATION.
