CABLEGIAM DATED 20 AUGUST 1950 FROM THE MINISTER FOR FOREIGN AFFAIRS
OF THE CENTRAL PEOPLE'S GOVERNMENT OF THE PEOPLE'S REPUBLIC OF
CHINA ADDRESSED TO THE SECRETARY-GENERAL

THE UNITED STATES OF AMERICA INSTIGATED THE KOREAN INCIDENT, LAUNCHED SEA, IAND AND ATR FORCES IN A DIRECT ACGRESSION OF KOREA, AND INVADED THE TERRITORY OF THE PEOPLE'S REPUBLIC OF CHINA TAIWAN WITH HER SEVENTH FLEET ATTEMPTING THEREBY TO ENLARGE THE WAR AND ATTAIN HER GOAL OF SUBJUCATING ASIA, THUS SERIOUSLY VIOLATED PEACE IN ASIA AND THE WORLD.

THE PEACE-LOVING PEOPLES ALL OVER ASIA AND THE WORLD EACERLY HOPE THAT
THE UNITED NATIONS SHOULDER UP TO THE RESPONSIBILITY FOR THE MAINTENANCE OF WORLD
PEACE AND SECURITY, AND REGULATE THE KOREAN QUESTION PROPERLY BY EFFECTIVE AND
PEACEFUL METHODS. KOREA IS CHINA'S NEIGHBOURING COUNTRY, THE CHINESE PEOPLE
CANNOT BUT BE MORE CONCERNED ABOUT THE SOLUTION OF THE KOREAN QUESTION. THE
QUESTION OF KOREA MUST AND CAN BE SETTLED PEACEFULLY; BUT SO FAR THE DILIGENT
OBSTRUCTIVE AND DILATORY ACTIONS ON THE PART OF THE UNITED STATES OF AMERICA IN
THE SECURITY COUNCIL MEETINGS HAVE PREVENTED THE REASONABLE PEACEFUL SETTLEMENT
OF THE KOREAN QUESTION IN WHICH THE WHOLE WORLD IS INTERESTED. THE UNITED
STATES GOVERNMENT SHOULD BEAR TOTAL RESPONSIBILITY FOR THE FACT THAT THE KOREAN
QUESTION HAS FAILED TO ATTAIN A PEACEFUL SETTLEMENT.

THE CENTRAL PEOPLE'S GOVERNMENT OF THE PEOPLE'S REPUBLIC OF CHINA FULLY SUPPORTS ALL THE PROPOSALS CONCERNING THE PEACEFUL REGULATION OF THE KOREAN QUESTION SUBMITTED ON 4 AUGUST IN THE UNITED MATIONS SECURITY COUNCIL BY MR. YAKOV MALLI ON BEHALF OF THE UNION OF SOVIET SOCIALIST REPUBLICS GOVERNMENT. THESE PROPOSALS ARE IN COMPLETE ACCORDANCE WITH THE SPERIT OF THE UNITED NATIONS CHARTER AND WITH THE WISHES OF THE INOPIES OF ASIA AND THE WORLD.

THE CENTIAL PROPIE'S COVERMENT OF THE EMOPIE'S REPUBLIC OF CHINA FIRMLY MAINTAINS THAT WEEN THE KORGAN OBTSWION IS BEING DISCUSSED IN THE SECURITY COUNCIL, IT IS NECESSARY THAT THE DETECATE OF THE PEOPLE'S REPUBLIC OF CHINA, A COUNTRY WITH A POPULATION OF FOUR HUNDRED AND SEVENTY-FIVE MILLIONS, SHOULD

/TAKE PART S/1703 TAKE PART AND THE REPRESENTATIVES OF THE KOREAN PEOPLE BE INVITED TO EXPRESS THEIR OPINIONS; THAT THE MILITARY OPERATION IN MOREA MUST BE STOPFED AND ALL FOLEIGN TROOPS BE WITHDRAWN FROM KOREA. CTHEIWISE IT WOULD BE IMPOSSIBLE TO HAVE A READONABLE PEACEFUL SETTLEMENT OF THE KOREAN QUESTION.

THE CENTRAL PEOPLE'S COVERNMENT OF THE PEOPLE'S REPUBLIC OF CHINA FIRMLY OPPOSES THE BARBARCUS BOMBING OF THE TOWNS AND PEACEFUL INHABITANTS CONDUCTED BY AMERICAN AVIATION IN KOREA, FULLY SUPPORTS THE SOLEMN AND RIGHTFUL PROTEST LODGED BY MR. PAK HEN YEN, FOREIGN MINISTER OF THE KOREAN DEMOCRATIC PEOPLE'S REPUBLIC, BEFORE THE UNITED NATIONS SECURITY COUNCIL ON 5 AUGUST, AND DEMANDS THAT THE SECURITY COUNCIL TAKE IMMEDIATE STEPS TO STOP PROMITLY THE ATROCITIES COMMITTED BY THE UNITED STATES FORCES IN VIOLATION OF INTERNATIONAL LAW AND THE RULES OF HUMAN ETHICS. THIS IS A DUTY WHICH CANNOT BE WAIVED BY ANY MEMBER OF THE SECURITY COUNCIL, WHICH IS ENTRUSTED WITH THE RESPONSIBILITY FOR THE MAINTENANCE OF INTERNATIONAL PEACE AND SECURITY.
