INFORMATION FROM NON-SELF-GOVERNING TERRITORIES TRANSMITTED UNDER ARTICLE 73 g OF THE CHARTER OF THE UNITED NATIONS

Report of the Secretary-General

- 1. Under the terms of Article 73 g of the Charter of the United Nations, "Members of the United Nations which have or assume responsibilities for the administration of territories whose peoples have not yet attained a full measure of self-government" undertake to transmit regularly to the Secretary-General information "... relating to economic, social and educational conditions in the territories for which they are respectively responsible other than those territories to which Chapters XII and XIII apply". In addition, the General Assembly in several resolutions, the most recent of which was resolution 42/73 of 4 December 1987, requested the administering Powers concerned "to continue to transmit to the Secretary-General the information prescribed in Article 73 g of the Charter, as well as the fullest possible information on political and constitutional developments in the Territories concerned".
- 2. The table annexed to the present report shows the dates on which information called for under Article 73 g of the Charter was transmitted to the Secretary-General in respect of the years 1986 and 1987 up to 22 September 1988.
- 3. The information transmitted under Article 73 g of the Charter follows in general the standard form approved by the General Assembly and includes information on geography, history, population and economic, social and educational conditions. In the case of Territories under the administration of New Zealand, the United Kingdom of Great Britain and Northern Ireland and the United States of America, the annual reports on the Territories also include information on constitutional matters. Additional information on political and constitutional developments in the Territories under their administration is given by the representatives of New Zealand and the United States during meetings of the Special Committee on the Situation with regard to the Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples. Supplementary information is also made available by New Zealand, the United Kingdom and the United States concerning Territories under their administration.

4. In compliance with the provisions of paragraph 5 of General Assembly resolution 1970 (XVIII) of 16 December 1963 and other relevant resolutions of the Assembly, including in particular resolution 42/73, the Secretariat has continued to use the information transmitted in the preparation for the Special Committee of working papers on each Territory. The Special Committee has taken this information into account in formulating its decisions on these Territories, which are set forth in the relevant chapters of the Committee's report to the General Assembly at its current session (see A/43/23 (Parts VI and VII)). The report also contains an account of the action taken by the Special Committee in implementation of resolution 1970 (XVIII) (A/43/23 (Part IV, chap. VII)).
