

Cooperation between the United Nations and regional and other organizations: cooperation between the United Nations and the Council of Europe

Cooperation between the United Nations and the Council of Europe

The General Assembly,

Recalling the Agreement between the Council of Europe and the Secretariat of the United Nations signed on 15 December 1951 and the Arrangement on Cooperation and Liaison between the secretariats of the United Nations and the Council of Europe of 19 November 1971,

Acknowledging the contribution of the Council of Europe to the protection and strengthening of democracy, human rights and fundamental freedoms, including protection of national minorities, and the rule of law on the European continent, including its activities against racism and intolerance, the promotion of gender equality, social development and a common cultural heritage,

Acknowledging also that, with its significant expertise in the field of human rights, democratic institutions and the rule of law, the Council of Europe is contributing to conflict prevention, confidence-building and long-term post-conflict peace-building through political, legal and institutional reform,

Stressing the importance of adherence to the standards and principles of the Council of Europe and its contribution to the solution of conflicts throughout the whole of Europe,

Acknowledging the contribution of the Council of Europe to the development of international law, international criminal law,

Noting the increasing openness of the Council of Europe, through its legal instruments, to the participation of States of other regions,

- 1. Welcomes the report of the Secretary General;¹
- 2. Reiterates its appreciation for the ongoing fruitful cooperation and coordination between the United Nations and its agencies and the Council of Europe, both at the level of headquarters and in the field;
- 3. Welcomes the further development of close cooperation between the Council of Europe, the Office of the United Nations High Commissioner for Human Rights, the Office of the United Nations High Commissioner for Refugees, the United Nations Children's Fund and the United Nations Economic Commission for Europe;
- 4. Also welcomes the important role the Council of Europe has played in facilitating the entry into force of the Rome Statute of the International Criminal Court² and the Council's readiness to provide States with the appropriate assistance with a view to becoming parties to and implementing the Rome Statute;
- 5. Expresses its appreciation to the Council of Europe for its contribution to the implementation of the conclusions of the World Conference against Racism, Racial Discrimination, Xenophobia and Related Intolerance, and the follow-up action taken by the European Commission against Racism and Intolerance in implementation of the Durban Plan of Action;³
- 6. Also expresses its appreciation on the opening for signature at Vilnius on 3 May 2002 of Protocol No. 13 to the European Convention for the Protection of Human Rights and Fundamental Freedoms concerning the abolition of the death penalty in all circumstances, and notes the support of the Council of Europe for the abolition of the death penalty worldwide;
- 7. Further expresses its appreciation for the substantial contribution of the Council of Europe to the special session of the General Assembly on children, held from 8 to 10 May 2002, and welcomes in this context the Political Message from the Committee of Ministers to the General Assembly at that session,⁴ and the adoption by the Council of Europe of the Convention on the Exercise of Children's Rights, which entered into force in 2000;
- 8. Expresses its appreciation for the Political Message from the Committee of Ministers of the Council of Europe to the World Summit on Sustainable Development,⁵ held at Johannesburg from 26 August to 4 September 2002, as well as for the contributions to the follow-up work concerning education for sustainable

development, carried out by the Council's European Centre for Global Interdependence and Solidarity (the North-South Centre);

- 9. Commends strongly the contribution of the Council of Europe to the international action against terrorism, welcomes the work of the Council of Europe's Multidisciplinary Group on International Action against Terrorism aimed, inter alia, at strengthening legal cooperation in the fight against terrorism, and in this context welcomes the approval of the content of the Draft Protocol amending the European Convention on Suppression of Terrorism (1977) by the Committee of Ministers at its one hundred and eleventh session:
- 10. Welcomes the assessment made by the Committee of Ministers at its one hundred and eleventh session, on 7 November 2002, on each of the three cornerstones they had defined in 2001 for the Council of Europe contribution to a United Nations-led international action against terrorism: intensifying legal cooperation to combat terrorism, safeguarding fundamental values and investing in democracy;
- 11. Commends the work of the Council of Europe in drawing up the "Guidelines on Human Rights and the Fight against Terrorism", adopted by the Committee of Ministers on 3 July 2002;
- 12. Welcomes the accession to the Council of Europe of Bosnia and Herzegovina on 24 April 2002, and expresses its appreciation for the cooperation and assistance the Council of Europe extends to this country in order to facilitate its compliance with the Council's standards of democracy, human rights, and the rule of law;
- 13. Takes note of Opinion No. 239 adopted by the Parliamentary Assembly of the Council of Europe on 24 September 2002, in which the Assembly recommends that the Committee of Ministers, on the basis of a series of commitments accepted by the highest Yugoslav authorities, "invite the Federal Republic of Yugoslavia to become a member of the Council of Europe as soon as the constitutional Charter is adopted by the Parliaments of Serbia and Montenegro";
- 14. *Notes* the fact that the Ministers of the forty-four member States at the one hundred and eleventh session, on 7 November 2002, reiterated their common will to see the Federal Republic of Yugoslavia become a member of the Council of Europe, while at the same time regretting that circumstances at present do not yet permit the adoption of an official invitation to the Federal Republic of Yugoslavia to join the Council of Europe;
- 15. Welcomes the ongoing participation of the Council of Europe in the implementation of Security Council resolution 1244 (1999) of 10 June 1999 and in its cooperation with the United Nations Interim Administration Mission in Kosovo, and commends the role of the Council of Europe in the development of democratic institutions, including in the decentralization process, human rights protection and the rule of law in accordance with the standards of the Council of Europe;
- 16. *Commends* the role of the Council of Europe with regard to the electoral process in Kosovo, Federal Republic of Yugoslavia, in preparation for the municipal elections on 26 October 2002;
- 17. Welcomes the substantial contribution of the Council of Europe to the Stability Pact for South-Eastern Europe, in particular in the fields of

democratization, local democracy, human rights and the rule of law, as well as crossborder cooperation and the fight against corruption, organized crime and moneylaundering;

- 18. *Commends* the wide-ranging efforts of the Council of Europe to foster peace and stability in South-Eastern Europe;
- 19. Welcomes the Vilnius Declaration on Regional Cooperation⁶ and the Consolidation of Democratic Stability in Greater Europe, adopted by the Committee of Ministers of the Council of Europe on 3 May 2002, and the efforts of the Council of Europe to promote cooperation among the regional organizations, initiatives and processes in Europe and between them and the United Nations and other international organizations;
- 20. *Commends* the work of the Council of Europe in relation to the protection of national minorities, in particular, the monitoring by the Committee of Ministers of the implementation of the Framework Convention for the Protection of National Minorities;
- 21. Reiterates its appreciation for the active role of the Council of Europe in the tripartite meetings between the United Nations, the Organization for Security and Cooperation in Europe and the Council of Europe;
- 22. *Requests* the Secretary-General to continue exploring, with the Secretary General of the Council of Europe, possibilities for further enhancement of cooperation, information exchange and coordination between the United Nations and the Council of Europe;
- 23. Decides to include in the provisional agenda of its fifty-ninth session the sub-item entitled "Cooperation between the United Nations and the Council of Europe", and requests the Secretary-General to submit to the General Assembly at its fifty-ninth session a report on cooperation between the United Nations and the Council of Europe in implementation of the present resolution.
