MEMORANDUM DATED 15 APRIL 1951 FROM THE MINISTER FOR FOREIGN AFFAIRS OF THE KOREAN PEOPLE'S DEMOCRATIC REPUBLIC ADDRESSED TO THE PRESIDENT OF THE SECURITY COUNCIL

THE GOVERNMENT OF THE KOREAN PEOPLE'S DEMOCRATIC REPUBLIC HAS REPEATEDLY PROTESTED TO THE UNITED NATIONS AGAINST THE ARMED INTERVENTION OF THE UNITED STATES AND THE MONSTROUS ATROCITIES COMMITTED IN KOREA BY THE AMERICANS AND SYNGMAN RHEE FOLLOWERS. SO FAR THE UNITED NATIONS HAS IGNORED THE PROTESTS OF THE GOVERNMENT OF THE K.P.D.R. AND HAS TAKEN NO STEPS TO PUT A STOP TO THE CRIMES OF THE AMERICAN INTERVENTIONISTS WHICH ARE AROUSING THE JUST INDIGNATION NOT ONLY OF THE KOREAN PEOPLE BUT OF DEMOCRATIC PUBLIC OPINION THROUGHOUT THE WORLD. MEANWHILE EACH FURTHER DAY OF THE WAR IN KOREA IS BRINGING FRESH SUFFERING TO THE KOREAN PEOPLE AND IS CREATING FRESH VICTIMS OF THE ODIOUS MISDEEDS OF THE AMERICAN INTERVENTIONISTS AND THEIR ACCOMPLICES WHO ARE BECOMING MORE AND MORE SAVAGE AND INHUMAN IN THEIR VAIN ATTEMPTS TO SUBDUCE THE FREEDOM-LOVING KOREAN PEOPLE. THE GOVERNMENT OF THE K.P.D.R. IS RECEIVING FROM THE AREAS LIBERATED FROM ENEMY OCCUPATION NUMEROUS REPORTS OF ATROCITIES COMMITTED BY THE AMERICAN INTERVENTIONISTS IN THOSE AREAS. ACCORDING TO INCONTROVERTIBLE DATA CONTAINED IN THESE REPORTS, THE AMERICAN INTERVENTIONISTS AND THE SYNGMAN RHEE BANDS UNDER THEIR CONTROL ARE CARRYING OUT A POLICY OF MASS EXTERMINATION OF THE PEACEFUL POPULATION IN THE REGION OF KOREA WHICH THEY OCCUPY. THEY ARE MOREOVER RESORTING TO THE MOST FANATICAL METHODS OF MALTREATING THEIR VICTIMS, TO BARBAROUS MEDIEVAL TORTURES, VIOLATION OF WOMEN AND OTHER ATROCITIES. A LARGE NUMBER OF INSTANCES HAVE BEEN NOTED IN WHICH THE OCCUPIERS HAVE KILLED KOREANS BY GOUGING OUT THEIR EYES, CUTTING OFF THEIR NOSES, HEWING OR SAWING THEIR LIVING BODIES INTO PIECES, BURNING THEM WITH RED-HOT IRONS, THROWING THEM UNDER TANKS OR BURYING THEM ALIVE. THESE TERRORISTIC ACTS OF UNPARALLELED SADISM ARE BEING COMMITTED PRIMARILY AGAINST MEMBERS OF THE LABOUR PARTY AND OTHER DEMOCRATIC SOCIAL ORGANIZATIONS, PERSONS WORKING FOR THE LOCAL DEMOCRATIC ORGANS OF SELF-GOVERNMENT AND ALL PATRIOTIC KOREANS. THE VICTIMS OF THE SAVAGE FANATICISM OF THE AMERICANS AND SYNGMAN RHEE FOLLOWERS HAVE ALSO INCLUDED THOUSANDS OF KOREAN WOMEN, CHILDREN AND AGED PERSONS. THE FOLLOWING ARE A FEW FACTS RELATING TO THE

BESTIAL EXTERMINATION OF THE PEACEFUL POPULATION BY AMERICANS AND SYNGMAN RHEE FOLLOWERS IN THE AREAS TEMPORARILY OCCUPIED BY THEM. AT THE BEGINNING OF OCTOBER 1950 THE AMERICANS ARRESTED 135 EMPLOYEES OF THE PEOPLE'S COMMITTEES, MEMBERS OF THE DEMOCRATIC PARTIES AND PUBLIC BODIES AND MEMBERS OF THEIR FAMILIES IN THE KOKHA DISTRICT, PKHADJIU REGION, KENGI PROVINCE, BOUND THEM, LAID THEM ON THE ROAD AND CRUSHED THEM WITH TANKS. ON 28 OCTOBER 1950 IN THE TOWN OF SONDZIN, NOW KIMSCHAK, NORTHERN KHAMGEN PROVINCE, SYNGMAN RHEE FOLLOWERS ARRESTED 30 INHABITANTS ON THE CHARGE OF SYMPATHIZING WITH THE REDS. THEY SUBJECTED THEM TO ELECTRIC SHOCKS AND THEN SHOT THEM ALL IN FRONT OF THE MUNICIPAL THEATRE. ON 23 NOVEMBER SYNGMAN RHEE SOLDIERS IN THE KHAKNAM DISTRICT, KHAIXEN REGION, NORTHERN KHAMGEN PROVINCE, ARRESTED 28 PARTY ACTIVISTS, INCLUDING THE CHAIRMAN OF THE DISTRICT PEOPLE'S COMMITTEE KIM DONG KHU. THEY TOOK THEM ALL TO THE MOUNTAINS, POURED PETROL OVER THEM AND BURNED THEM ALIVE. ON 9 OCTOBER 1950 SYNGMAN RHEE FOLLOWERS KILLED SIN GI SIU, CHAIRMAN OF THE PEOPLE'S COMMITTEE OF THE VILLAGE OF KHINSINNI, YANCON DISTRICT, KIMPKHO REGION, AFTER FIRST CUTTING OFF HIS ARMS AND LEGS, DECAPITATING HIM AND CUTTING HIS BODY TO PIECES. IN OCTOBER 1950 THE OCCUPIERS ARRESTED THE WIFE OF LIN DEN I, DEPUTY CHAIRMAN OF THE LEAGUE OF DEMOCRATIC YOUTH IN VOLGOK DISTRICT, KIMPKHO REGION, KENGI PROVINCE, STRIPPED HER NAKED AND DROVE A (word illegible) STAKE INTO HER GENITALS. WHEN THE WOMAN FAINTED AWAY SHE WAS MURDERED TOGETHER WITH OTHER MEMBERS OF THE DEMOCRATIC YOUTH UNION. ON 5 OCTOBER 1950 LI CHE UN, THE LEADER OF THE ORGANIZING SECTION OF THE DEMOCRATIC YOUTH UNION OF ENDURI VILLAGE, SINDO DISTRICT, KOYAN REGION, KENGI PROVINCE, WAS ARRESTED. HE WAS TORTURED TO DEATH BY INSERTING RED-HOT NEEDLES IN HIS NECK, CHEST, ABDOMEN AND OTHER PARTS OF HIS BODY. AT THE BEGINNING OF OCTOBER 1950 THE POLICE ARRESTED SIX CHILDREN IN KOKHA DISTRICT, PKHADJIU REGION, KENGI PROVINCE, FOR SINGING THE KIM IR SEN SONG AND MURDERED THEM AFTER FIRST CUTTING OFF THEIR LIPS AND TEARING OUT THEIR TONGUES WITH PINCERS. THEY THEN LAID OUT THE BODIES OF THESE CHILDREN ON THE ROAD, HERDED ALL THE CHILDREN OF THE NEIGHBOURING VILLAGE TO THE SPOT, SHOWED THEM THE BODIES AND THREATENED TO KILL THEM IN THE SAME WAY IF THEY SANG THE KIM IR SEN SONG. ON 10 OCTOBER 1950 THE FOLLOWERS OF SYNGMAN RHEE ARRESTED THE WIFE OF THE INSTRUCTOR OF THE PEOPLE'S COMMITTEE OF KHVASEN DISTRICT, KIMPKHO REGION, STRIPPED HER, PIERCED HER GENITALS WITH A KNIFE AND KILLED HER BY RIPPING UP HER STOMACH. THEY THEN MURDERED HER TWO SONS BY BEATING IN THEIR HEADS

/WITH STONES.

WITH STONES. THEY MURDERED THE PEASANT COI CU VON OF SAURI VILLAGE IN THE SAME DISTRICT BY BREAKING HIS BACK WITH A WEDGE, BECAUSE HIS SON HAD JOINED THE PEOPLE'S ARMY. ON 29 OCTOBER 1950 SYNGMAN RHEE FOLLOWERS SHUT UP TYAN DU KHEN, CHAIRMAN OF THE CONSUMERS ASSOCIATION OF BONSCHEN DISTRICT, SINSCHEN REGION, KHVANKHE PROVINCE, IN A WAREHOUSE TO BE TORN TO PIECES BY A SAVAGE DOG, WITH THE RESULT THAT HE DIED. AT THE BEGINNING OF NOVEMBER 1950, IN KHIANJIU VILLAGE, DZUNE DISTRICT, PKHADJIU REGION, KENGI PROVINCE, SYNGMAN RHEE FOLLOWERS MURDERED SEVENTY WIVES OF DEMOCRATS AND BURIED ALIVE THEIR CHILDREN WHEN THEY WEPT AT THE LOSS OF THEIR MOTHERS. IN NOVEMBER 1950 THE AMERICANS DROVE 479 PATRIOTS AND MEMBERS OF THEIR FAMILIES INTO THE AIR-RAID SHELTER OF THE SINSCHEN REGION POLICE STATION AND BLOCKED UP THE EXIT WITH EARTH SO THAT THEY ALL SUFFOCATED. ANOTHER 104 MEMBERS OF THE COMMITTEE OF THE SINSCHEN REGION LABOUR PARTY WERE PUT TO DEATH BY THE AMERICANS IN AN AIR-RAID SHELTER IN THE SAME WAY. IN VONNAMI VILLAGE SYNGMAN RHEE FOLLOWERS SHUT UP MORE THAN 300 PEOPLE IN A WAREHOUSE AND BURNED THEM TO DEATH. THEY SHUT UP MORE THAN 80 CHILDREN UNDER TEN YEARS OLD IN ANOTHER WAREHOUSE AND BEAT THEM TO DEATH WITH STICKS OR STARVED THEM. IN NOVEMBER 1950 THE AMERICANS LANDED ON THE SMALL ISLAND OF CHANDO, LINPHUN DISTRICT, HONDZEU REGION, NORTH FYONGYANG PROVINCE AND BESTIALLY MURDERED MORE THAN 580 INHABITANTS OF THE ISLAND. WHEN THEY ADVANCED INTO THE TKHESCHEN REGION THE AMERICANS AND SYNGMAN RHEE FOLLOWERS MURDERED LI NI DZUN, A MEMBER OF THE LABOUR PARTY AND CHAIRMAN OF THE REGIONAL COMMITTEE OF THE PEASANTS UNION, RESIDING IN YIUNNI VILLAGE, SOMEN DISTRICT, AFTER FIRST CUTTING OFF HIS EARS AND NOSE, COUGING OUT HIS EYES AND FLAYING HIM. IN THE MIDDLE OF NOVEMBER 1950, IN BONGENNI VILLAGE, SANDZOYMMEN DISTRICT, KHAMDJU REGION, SOUTH KHAMGEN PROVINCE, THEY BOUND MORE THAN TWENTY PERSONS BELONGING TO THE FAMILIES OF MEMBERS OF THE LABOUR PARTY, HACKED THEM TO PIECES WITH AXES AND BURNED THEIR BODIES.

ON 20 DECEMBER SYNGMAN RHEE FOLLOWERS ARRESTED SIN YAK SHEN, ACTIVIST OF THE LEAGUE OF DEMOCRATIC YOUTH LIVING IN THE DANSON SECTION OF THE TOWN OF WONSAN, KONWON PROVINCE; THEY STRIPPED, BOUND AND TORTURED HER, BURNING HER GENITALS WITH A CANDLE-FLAME, AS A RESULT OF WHICH SHE LOST CONSCIOUSNESS: THEY THEN KILLED HER. ON 25 DECEMBER 1950 SYNGMAN RHEE FOLLOWERS BURNED AT THE STAKE KIM DZIN SON, DEPUTY PRESIDENT OF THE LABOUR PARTY ORGANIZATION OF THE VILLAGE OF DZINUR, ONCHEN DISTRICT, SINSCHEN REGION. ON 25 DECEMBER 1950 AMERICANS AND SYNGMAN RHEE FOLLOWERS ARRESTED A PREGNANT WOMAN NAMED SO DO DZO LIVING IN THE VILLAGE OF OKTON, SOMEN DISTRICT, PHENGLAN REGION, PROVINCE OF KANWON, BECAUSE

HER HUSBAND HAD JOINED THE PEOPLE'S ARMY. THEY STRIPPED HER NAKED, LED HER THROUGH THE VILLAGE, AND THEN STABBED HER WITH BAYONNETS. ON 5 JANUARY 1951 SYNGMAN RHEE FOLLOWERS SEIZED A MEMBER OF THE LABOUR PARTY CALLED GON KHI DU LIVING IN KANKHEM DISTRICT, YANYAN REGION AND KILLED HIM, SAWING HIM INTO THREE PARTS. INNUMERABLE EXAMPLES EXIST OF SUCH BESTIAL EXTERMINATION OF THE KOREAN PEOPLE. IN THE ONCHEN DISTRICT ALONE, SINCHEN REGION, PROVINCE OF KHVANKHE, ON 2 FEBRUARY 1951 THE NUMBER OF PEACEFUL INHABITANTS FOUND AMOUNTED TO 1392; IN THE WHOLE OF THE SINCHEN REGION OVER 25,000 PERSONS WERE KILLED, AND THE NUMBER KILLED IN THE WHOLE OF KHVANKHE PROVINCE EXCEEDS 100,000. WHEN THE AMERICANS WITHDREW, THREATENING TO USE ATOMIC BOMBS, THEY DROVE OFF TO THE SOUTH A CROWD OF INHABITANTS, MOST OF WHOM THEY SLEW EN ROUTE. THUS, WHEN THEY WITHDREW FROM THE YANYAN REGION IN KANWON PROVINCE, THE AMERICANS AND SYNGMAN RHEE FOLLOWERS CARRIED OFF BY FORCE 25,380 PERSONS AND SLEW MOST OF THEM WITH FIRE FROM MACHINE-GUNS AND BOMBS DROPPED FROM THE AIR. FROM THE VILLAGE OF SIKHORA, DISTRICT OF KHEAP, REGION OF CHUNKHA, PROVINCE OF SOUTHERN PYONGYONG, THE OCCUPIERS DROVE OFF BY FORCE OVER 800 PERSONS, AND EN ROUTE NEAR THE TOWN OF SARIWON KILLED MORE THAN 400 PERSONS, WITH MACHINE-GUN FIRE FROM FOUR AIRCRAFT. THE AMERICAN INTERVENERS AND SYNGMAN RHEE'S BANDITS, LOSING ALL MORAL SEMBLANCE OF HUMANITY, HAVE IN THE AREAS OF THEIR TEMPORARY OCCUPATION COMMITTED CRIMINAL ASSAULT ON INNUMERABLE WOMEN, GIRLS AND FEMALE CHILDREN, AND EXTERMINATED MOST OF THEM THEREAFTER. THUS, ACCORDING TO THE EVIDENCE OF THE PEASANT KIM KHIN GUK, LIVING IN THE VILLAGE OF KHINSIN, DISTRICT OF YANCHO, REGION OF KIMPKHO, WHO HAD BEEN EMPLOYED ON COMPULSORY LABOUR AT THE KIMPKHO AIRFIELD THE AMERICAN FLIERS KEPT IN THE UNDERGROUND PREMISES OF THE AIRFIELD OVER 800 YOUNG KOREAN WOMEN AND SUBMITTED THEM TO INDIGNITIES AT ALL HOURS OF THE DAY AND NIGHT. IN THE DISTRICT OF DANCHEN, PROVINCE OF SOUTHERN KHAMGEN, AMERICANS AND SYNGMAN RHEE FOLLOWERS VIOLATED 42 FEMALE TEACHERS AND STUDENTS OF THE GIRLS' SCHOOL. ON 5 NOVEMBER 1950, IN THE TOWN OF KESON, TWO AMERICAN SOLDIERS MET A WOMAN WALKING WITH HER HUSBAND: THEY KILLED THE HUSBAND AND VIOLATED HER. IN NOVEMBER 1950, IN THE VILLAGE OF CHUESUR, DISTRICT OF YANSAN, REGION OF YANBEN, PROVINCE OF NORTHERN PYONGYANG, AMERICANS VIOLATED A GIRL OF THIRTEEN. ON 20 NOVEMBER 1950, IN PYONGYANG, AMERICAN SOLDIERS VIOLATED THREE NURSES OF THE PEOPLE'S ARMY WHOM THEY HAD MADE PRISONER AND THEN SHOT THEM. ON 27 NOVEMBER 1950 EIGHT AMERICANS VIOLATED M.DAMT LI, PRESIDENT OF THE WOMEN'S UNION OF THE VILLAGE OF KIMBAN, DISTRICT OF TENNANEN, REGION OF KIVASEN, PROVINCE

OF KENGI AND THEN KILLED HER. FOR SEVERAL DAYS HER NAKED BODY LAY BY THE
ROADSIDE. AT THE END OF DECEMBER 1950 THREE AMERICAN OFFICERS, AT A BANQUET
GIVEN BY THE MINISTER OF CULTURE AND ENLIGHTENMENT OF THE PUPPET GOVERNMENT
OF SYNGMAN RHEE, VIOLATED IN HIS AIR-RAID SHELTER A TEACHER OF THE GIRLS'
SECONDARY SCHOOL WHO DURING THE BANQUET HAD COME ON BUSINESS TO SEE PEK NAK TIUN,
AND THEN KILLED HER. IN THE VILLAGE OF SAN, DISTRICT OF YANGU, PROVINCE OF KANWON,
A PLATOON OF AMERICAN SOLDIERS IN CHARGE OF AN OFFICER VIOLATED AN INHABITANT
OF THE VILLAGE NAMED KIM KI UN, A GIRL OF 22. THESE DEPRAVED SADISTS, THE
AMERICAN INTERVENERS AND THEIR ACCOMPLICES, ARE TORTURING, VIOLATING AND SHOOTING
THE PEACEFUL INHABITANTS, LOOTING THEIR PROPERTY, DESTROYING THEIR HOUSES, AND
DESTROYING THE NATIONAL WEALTH OF KOREA AND THE MONUMENTS OF ITS MANY CENTURIES
OF CULTURE. IN REVENGE UPON THE KOREAN PEOPLE FOR ITS STAUNCH AND HEROIC
RESISTANCE TO THE HATED INVADERS, THEY DESIRE TO EXTERMINATE IT AND TO TURN
ITS HOMELAND INTO A LIFELESS DESERT. IN PREVIOUS STATEMENTS OF THE GOVERNMENT
OF THE KOREAN PEOPLE'S DEMOCRATIC REPUBLIC ADDRESSED TO THE UNITED NATIONS
NUMEROUS EXAMPLES HAVE BEEN CITED OF THIS BESTIAL POLICY OF THE TOTAL DEVASTATION
OF KOREA CARRIED OUT BY THE AMERICAN INTERVENERS.

IN MY PRESENT STATEMENT I WILL CONFINE MYSELF TO A NUMBER OF STILL UNPUBLISHED
FACTS. DURING THEIR RETREAT IN DECEMBER AND JANUARY THE AMERICAN TROOPS
COMPLETELY DEVASTATED AND DESTROYED THE VILLAGES AND PEASANTS' HOUSES SITUATED
ON THEIR ROUTE. THUS, WHEN THE AMERICANS AND SYNGMAN RHEE'S FOLLOWERS
WITHDREW FROM THE YAMAK DISTRICT, KANWON PROVINCE, ON 2 JANUARY 1951, SPECIALLY
FORMED FIRE-RAISING DETACHMENTS SET FIRE TO THE VILLAGES. IN THE KANKHEN
DISTRICT THEY BURNT DOWN 503 HOUSES, IN THE YANYAN DISTRICT 1,003 HOUSES, IN
THE SONYAN DISTRICT 720 HOUSES AND IN THE SOMEN DISTRICT 776 HOUSES. ALTOGETHER,
3,991 HOUSES WERE BURNT IN THE YANYAN REGION. DURING THEIR RETREAT AT THE END
OF DECEMBER 1950 THE AMERICANS DESTROYED WITH TANKS MORE THAN 60 PEASANTS'
HOUSES IN THE MUNSAN AREA. ON 30 DECEMBER 1950 THE RETREATING AMERICAN TROOPS
SET FIRE TO EVERY SINGLE HOUSE ALONG THE ROADS LEADING FROM SEOUL TO KHANDZHU.
IN THEIR RETREAT FROM THE VILLAGE OF VOITENNA, YEUNG DISTRICT, KHERVON REGION,
KANWON PROVINCE, THE ENEMY BURNT TO THE GROUND MORE THAN 30 HOUSES IN THAT
VILLAGE AND REDUCED THE STACKS OF CORN TO ASHES. ON 16 NOVEMBER 1950 THE
AMERICANS AND SYNGMAN RHEE FOLLOWERS BURNT DOWN 11 HOUSES IN THE VILLAGE OF
SAERI, KHERVON DISTRICT, KHERVON REGION, AND ON 19 NOVEMBER THEY SET FIRE TO
66 PEASANTS' HOUSES AND RICE STACKS IN THE VILLAGE OF CALMA IN THE SAME DISTRICT.

THE AMERICAN BARBARIANS DESTROYED A LARGE NUMBER OF VALUABLE CULTURAL OBJECTS AND HISTORICAL MONUMENTS OF OUR PEOPLE. DURING THE EVACUATION OF KESON THEY BLEW UP THE FAMOUS MONUMENT OF ANCIENT KOREAN ARCHITECTURE - THE SOUTH GATES OF KESON, AS WELL AS THE KESON MUSEUM AND OTHER CULTURAL INSTITUTIONS OF THE TOWN. THEY BURNT THE NAKSANSK BUDDHIST TEMPLE IN YANYAN, AN HISTORICAL MONUMENT KNOWN THROUGHOUT THE WORLD. THEY RAZED TO THE GROUND THE ARCHITECTURALLY MAGNIFICENT ANCIENT GVANKHVAMUN GATES IN SEOUL AND THE SOUTH GATES IN SUVON. BY PERPETRATING MONSTROUS CRIMES, DEVASTATING KOREA AND DESTROYING THE POPULATION WHOLESALE, THE AMERICAN INTERVENTIONISTS ARE TRYING TO FRIGHTEN THE KOREAN PEOPLE, BREAK THEIR WILL TO RESIST AND CRUSH THEIR ASPIRATION TOWARD THE COMPLETE LIBERATION OF THEIR COUNTRY. THE INTERVENTIONISTS WILL NOT ACHIEVE THEIR AIMS. THEIR ATROCITIES MERELY AROUSE THE WRATHFUL INDIGNATION AND HATRED OF THE KOREAN PEOPLE TOWARDS THE AMERICAN IMPERIALISTS. THE WHOLE COURSE OF EVENTS IN KOREA BEARS WITNESS TO THE FACT THAT THE WILL OF THE KOREAN PEOPLE IS INFLEXIBLE. IN REPLY TO THE AMERICAN ATROCITIES THEY UNITE MORE CLOSELY THAN EVER UNDER THE BANNER OF THE KOREAN PEOPLE'S DEMOCRATIC REPUBLIC, FIRMLY RESOLVED TO DRIVE THE HATED FOREIGN INVADERS OUT OF THEIR NATIVE COUNTRY. THE KOREAN PEOPLE ARE FIRMLY CONVINCED OF THEIR ULTIMATE VICTORY. IN ENERGETICALLY PROTESTING AGAINST THE ABOVE-MENTIONED ATROCITIES, THE GOVERNMENT OF THE KOREAN PEOPLE'S DEMOCRATIC REPUBLIC DECLARES THAT THE RESPONSIBILITY FOR THE CRIMES COMMITTED IN KOREA BY THE AMERICAN INTERVENTIONISTS IS ALSO SHARED BY THOSE WHO, USING THE UNITED NATIONS ORGANIZATION AS A SCREEN, ARE COVERING UP AMERICAN AGGRESSION, CO-OPERATING IN THE DISPATCH TO KOREA OF THE ARMED FORCES OF THE FOREIGN INTERVENTIONISTS, THUS ASSISTING IN THE SAVAGE EXTERMINATION OF THE KOREAN PEOPLE AND THE DESTRUCTION OF ITS NATIONAL HERITAGE. IF THE UNITED NATIONS ORGANIZATION REALLY WISHES TO SERVE THE CAUSE OF PEACE AND SECURITY AMONG THE PEOPLES, IT MUST IMMEDIATELY PUT AN END TO THE EVIL DEEDS OF THE AMERICAN IMPERIALISTS IN KOREA AND CONDEMN THE WAR CRIMINALS WHO ORGANIZED OR INSTIGATED THOSE EVIL DEEDS. IT MUST ENSURE THE SETTLEMENT OF THE KOREAN QUESTION IN CONFORMITY WITH THE WILL OF THE PEACE-LOVING PEOPLES EXPRESSED IN THE RESOLUTIONS OF THE FIRST SESSION OF THE WORLD PEACE COUNCIL. THE GOVERNMENT OF THE KOREAN PEOPLE'S DEMOCRATIC REPUBLIC INSISTENTLY DEMANDS THIS.
