LETTER DATED 9 MARCH 1951 FROM THE REPRESENTATIVE OF THE UNION OF SOVIET SOCIALIST REPUBLICS ADDRESSED TO THE PRESIDENT OF THE SECURITY COUNCIL CONCERNING A REPORT FROM THE COMMISSION OF THE CENTRAL COMMITTEE OF THE UNITED DEMOCRATIC NATIONAL FRONT OF KOREA

Dear Mr. President,

The USSR delegation to the United Nations has learned from the press of the cablegram sent to the President of the Security Council from Pyongyang on 1 March 1951, by the Commission of the Central Committee of the United Democratic Fatherland Front of Korea. The cablegram quotes report No. 4 of the said Commission on the atrocities committed and destruction wrought by American troops at Seoul and Inchom.

May I request you, Mr. President, to have this cablegram published as a document of the Security Council and circulated to delegations.

REPORT NO. 4 FROM THE COMMISSION OF THE CENTRAL COMMITTEE OF THE UNITED DEMOCRATIC NATIONAL FRONT OF KOREA

PRESIDENT OF THE GENERAL ASSEMBLY OF THE UNITED NATIONS LAKE SUCCES (1 EW YORK)

I HAVE THE HONOUR TO REQUEST YOU TO BRING TO THE NOTICE OF THE MEMBERS OF THE UNITED NATIONS REPORT NO. 4 DATED 1 MARCH 1951 FROM THE COMMISSION OF THE UNITED DEMOCRATIC NATIONAL FRONT OF KORFA FOR THE INVESTIGATION OF ATROCITIES COMMITTED BY THE AMERICAN INTERVENTIONISTS AND THE TROOPS OF SYNGMAN RHEE IN THE TOWNS OF SEOUL AND INCHON AND THEIR ENVIRONS:

REPORT NO. 4 DATED 1 MARCH 1951 FROM THE COMMISSION OF THE UNITED DEMCCRATIC NATIONAL FRONT OF KOREA FOR THE INVESTIGATION OF ATROCITIES COMMITTED BY AMPRICAN AND SYNGMAN RESE TROOPS IN THE TOWNS OF SEOUL AND INCHON AND THEIR ENVIRONS.

THE COMMISSION OF THE UNITED DEMORRATIC NATIONAL FRONT OF KOREA IS CONSTANTLY RECEIVING FURTHER INFORMATION TO THE SEFECT THAT THE BLOODTHIRSTY AMERICAN MONSTERS AND SYNCMAN THEE FOILCASTS ARE DESTROYING TOWNS AND VILLAGES AND PLUNDERING AND EXTERMINATING THE PRACETUL RUMBAN POPULATION. EVERY DAY AND EVERY HOUR FIRES BLAZE UP. PEOPLE PERISH AND THE EARTH TREMBLES FROM THE EXPLOSION OF BOMBS. WITHOUT THE SLIGHTEST REASON AND IN VIOLATION OF THE ELEMENTARY RULES OF INTERNATIONAL LAW AMERICAN AIR PIRATES ARE DOMBING AND ANNIHILATING THE PEACEFUL POPULATION OF KOREA. IN THE TOWNS AND VILLAGES OCCUPIED BY THE AMERICANS THESE ATROCITIES ARE BEING PERPETRATED ON THE KOREAN POPULATION BY SPECIAL SQUADS OF TORCH-BEARERS AND MURDERERS FROM OVERSEAS. UNDER THE THREAT OF USING THE ATOM WEAPON THEY ARE FORCIBLY EVACUATING THE PEACEFUL POPULATION AND SHOOTING THEM DOWN ON THE ROADS OF RETREAT AND SETTING FIRE TO THEIR DWEILINGS. THE AMERICAN ROBBERS NOT ONLY BURN AND KILL BUT VIOIATE WOMEN, AND DEPRIVE THE PEOPLE OF THEIR HOMES AND HOUSEHOLD EFFECTS. THE PIACES THAT WERE OCCUPIED BY THE AMERICAN VANDALS REMIND ONE OF A WILDERNESS. THE COMMISSION OF THE UNITED DEMOCRATIC NATIONAL FRONT CONSIDERS IT ITS DUTY TO ERING TO THE NOTICE OF THE WHOLE OF PEACE LOVING HUMANITY AND ALL HONEST PEOPLE THROUGHOUT THE WORLD FRESH FACTS FROM THE COUNTLESS NUMBER AT ITS DISPOSAL WHICH NOT ONLY CONFIRM THE NATURE OF THE UNPRECEDENTED ATROCITIES PREVIOUSLY PUBLISHED IN REPORTS NO. 1 OF 18 AUGUST, NO. 2 OF 26 SEPTEMBER AND NO. 3 OF 19 NOVEMBER 1950, AND AISO THE FACT THAT THE AMERICAN MONSTERS AND SYNGMAN RHEE'S FOLLOWERS HAVE

REACHED THE LIMITS OF CRUEITY AND MORAL DECLINE IN THEIR BLOODTHIRSTY AND CRIMINAL ATTACK ON THE FREEDOM AND LIFE OF THE KOREAN PEOPLE AND IN PERPETRATING ATROCITIES AND OUTRAGES ON THE PEACEFUL POPULATION IN SEOUL AND INCHON. BY DIRECT ORDER OF THE CANNIBAL MAC ARTHUR THE AMERICAN ARMY IS SUBJECTING THE PEACEFUL KOREAN POPULATION TO UNPRECEDENTED EXTERMINATION BY MEANS OF GRUESOME VIOLENCE AND MASS MURDERS OF KOREAN PATRIOTS REGARDLESS OF SEX OR AGE. THEY ARE CARRYING OUT THEIR BLOODY WORK WITH THE GOLDBLOODEDNESS OF PROFESSIONAL CRIMINALS. OF LATE THESE DEEDS HAVE BECOME PARTICULARLY NUMEROUS AND OUTRAGEOUS IN CHARACTER, THUS EXPOSING ONCE AGAIN THE AMERICAN IMPERIALISTS AND AMERICAN GOVERNMENT AS A GANG OF MISCREANTS HAVING NO RESPECT FOR THE LAWS OF HUMAN MORALITY.

THE ATROCIVIES COMMITTED BY THE AMERICAN CRIMINALS IN THE TOWNS TEMPORARILY OCCUPIED BY THEM ARE DESCRIBED IN THE ACCOUNTS GIVEN BY MANY INHABITANTS OF LIBERATED SECUL. WHEN THE AMERICANS CAPTURED SECUL THEY ORGANIZED MASS MURDERS THERE. THEY CONCOCTED A SPECIAL IAW ON REACTIONARIES. UNDER THIS IAW THE AMERICANS AND SYNGMAN RHEE'S FOLLOWERS SHOT THE ACTIVE MEMBERS OF THE PEOPLE'S COMMITTEES AND THEIR FAMILIES, MEMBERS OF THE LABOUR PARTY AND DEMOCRATIC ORGANIZATIONS, MEMBERS OF THE FAMILIES OF FIGHTERS IN THE PEOPLE'S ARMY AND PARTISANS. IN SECUL A STAFF HEADQUARTERS WAS SET UP TO HUNT DOWN THE REDS AND A SPECIAL IDENTITY CARD WAS INTRODUCED FOR THE INHABITANTS, BUT NOBODY WENT TO OBTAIN IT. THEN THE AMERICANS ORGANIZED IN EVERY STREET CHECK POINTS WHERE THEY ARRESTED EVERYBODY WHO DID NOT HAVE AN IDENTITY CARD. IN ORDER TO KILL OR ARREST PEOPLE, THE TWO-LEGGED BEASTS PUT ANY HONEST MAN ON THE LIST OF REDS. THEY ARRESTED, IMPRISONED, CRUEILY TORTURED AND KILLED ALL PERSONS WHOSE RELATIVES HAD GONE INTO THE PEOPLE'S MILITIA AND PEOPLE WHO HAD IN ANY WAY HELPED THE NATIONAL ARMY. ALL THE AFOREMENTIONED ATROCTTIES WERE PERFETRATED UNDER THE PRETEXT THAT THESE PERSONS WERE, AS ALLEGED, TRAITORS. AT THE TIME OF THE LIBERATION OF SEOUL BY THE NATIONAL ARMY AND CHINESE VOLUMPEERS THE AMERICAN BUTCHERS KILLED, HANGED AND TORTURED 390 KOREAN PATRIOUS. DURING THE OCCUPATION OF SEOUL THE AMERICANS ARRESTED AND IMPRISORED 75,000 INHABITANTS OF THE CLEY. ALL THE PRISONS, CELLS AND ALSO FACTORY WASTESOUSES AND CHURCH CRYPTS WEST FIFTED WITH ARRESTED PERSONS IN THE PRISONS OF SECUL THERE WERE SOME 300 YOUNG CHIEDREN AND INFANCE WHO MAD THROWN INTO THE CELLS ENGERGER MEAN WHELP PARENTS. AT THE TIME OF THE EVACUATI OF SECUL 30,000 PERSONS WERE TAKEN FROM THE PRISONS OF SECUL AND CARRIED AWAY TO THE SOUTH ON THE PRETEXT OF TRANSFER TO ANOTHER PRISON, AND ON THE WAY MORE THAN 10,000 PERSONS WERE SHOT.

ON 16 SEPTEMBER THE AMERICANS LANDED IN THE PORT OF INCHON AND OCCUPIED THE TOWN. A CROWD OF REFUGEES ESCAPING FROM THE TOWN WERE MERCILESSLY FIRED UPON. THE BANDITS PICKED UP INDISCRIMINATELY ALL THE YOUNG PEOPLE THEY MET, LABELLED THEM AS COM INISTS AND SHOT THEM. MORE THAN 10,000 PEACEFUL INHABITANTS WERE SHOT BY THEM. ACCORDING TO THE STATEMENT OF AN INHABITANT OF THE KYMGOKTAN DISTRICT, THE MERCHANT KIM SON SIK, THE AMERICANS KILLED IN THIS DISTRICT OF THE TOWN ALONE, 2,700 REFUGEES, INCLUDING 1,500 WOMEN AND CHILDREN, ON 17 SEPTEMBER THE AMERICANS SEIZED THE WOMAN KAN KE SUN WHO WAS ABOUT TO LEAVE WITH HER FAMILY FOR A NEIGHBORING VILLAGE. THEY KILLED HER TWO SONS AGED 4 AND 7 AND WOUNDED HER. SHORTLY AFTER THEY IANDED AT THE PORT OF INCHON IN THE BEGINNING OF OCTOBER 1950, SOME AMERICAN BUDD-SUCKERS WHO WERE DRIVING ALONG A STREET IN THE DISTRICT OF SONKHEDON WHILE DRUNK OPENED FIRE WITH A MACHINE GUN ON SOME CHILDREN WHO WERE. RUNNING IN FRIGHT TO AN AIR-RAID SHETTER. SEVEN INNOCENT CHILDREN WERE RUTHLESSLY KILLED BY THEM. THIS ODIOUS CONDUCT OF THE AMERICAN AGGRESSORS WAS REPORTED TO THE COMMISSION BY AN EYEWITNESS LI HEN KUG. A WORKER. ON 30 SEFTEMBER THE americans arrested more than 600 workers of the secul trams carace and subjected THEM TO THREE ROUNDS OF TORTURE. ACCORDING TO THE EYEWITNESS SO BEN EM. AN employee of the carage. The american butchers first beat each worker with sticks. THE BELTING WENT ON UNTIL NOTHING REMAINED OF THE STICK. THEN THEY HUNG THE VICTIM UP BY HIS LEGS AND POURED HOT WATER OVER HIM. AFTER WHICH THEY STABBED THE HALF-DEAD BODY WITH BAYONETS IN THE ABDOMEN, CHEST, HEAD AND EYES. ON 30 SEPTEMBER 1950 SYNGMAN RHEE'S FOLLOWERS ARRESTED OVER 600 EMPLOYEES OF THE SEOUL ELECTRICITY COMPANY AS TRAITORS. A NUMBER OF THE ARRESTED FERSONS WERE KILLED ON THE SPOT WITH BESTIAL TORTURES AND THE TRADE UNION CHAIRMAN THE GYN POK WAS KILLED BY INNUMERABLE BAYONET STABS IN THE CHEST AND FACE. AFTER CUTTING OFF HIS FINGERS AND TOES. THEY SHOWED HIS BODY TO ALL THE EMPLOYEES OF THE ELECTRICITY COMPANY. THEY SEIZED A WOMAN TRAM CONDUCTOR NO. 123 ON THE SECOND STOREY OF A HOUSE, BOUND HER WITH A ROPE AND DRAGGED HER DOWN THE STAIRS FROM THE UPPER STOREY TO THE LOWER. INFLICTED SERIOUS INJURIES UPON HER AND KILLED HER BY STABBING HER IN THE BREAST WITH A BAYONET. ON 30 SEPTEMBER 1950 ON A HILL BEHIND ENHANDON A NUMBER OF SYNCMAN RHEE'S FOLLOWERS SHOT PEN DU SEN THE CHIEF OF THE GROUP COMMITTEE OF THE DISTRICT NATIONAL COMMITTEE. THREE MEMBERS OF THE UNION OF DEMOCRATIC YOUTH AND TWENTY PRISONERS OF WAR FROM THE NATIONAL ARMY. ON 1 OCTOBER 1950 MEMBERS OF THE REACTIONARY ORGANIZATION TEHAN TOOK AWAY SIN HO BOM (461) RESIDENT AT 68 LITKHEVONDON STREET BECAUSE HIS SON SIN DZE HUA WAS A MEMBER OF THE UNION OF /DEMOCRATIC

DEMOCRATIC YOUTH. FOR A WHOLE WEEK THEY BEAT HIM TILL THE BLOOD FLOWED AND THEN KILLED HIM BY CUTTING OFF HIS HEAD WITH A "SICKIE". ON 1 OCTOBER 1950 TERRORISTS ATTACKED THE SEOUL ELECTRICITY COMPANY AND BEAT TO DEATH 48 WORKERS. ON 2 OCTOBER 1950 THE TONDEMUN POLICE SECTIONS TORTURED TO DEATH 12 ARRESTED PERSONS AND THREW THEIR CORPSES ONTO THE PANK OF THE RIVER HAN AT SOBINKO. ACCORDING TO AN EYE-WITNESS, MUN DAR HO, OF SEOUL, ON 3 OCTOBER 1950 THE DZONNO POLICE SECTIONS THREW THE BODIES OF MORE THAN 30 PERSONS WHO HAD BEEN KILLED BY BARBAROUS TORTURES INTO THE RIVER AT MAPKHO. ON 3 OCTOBER 1950 MEMBERS OF THE TEHAN YOUTH ORGANIZATION KILLED WITH STICKS KIN SU DIN. A MEMBER OF THE UNION OF DEMOCRATIC YOUTH, RESIDING AT KARVORTOM, AND DRAGGED HIS BODY THROUGH THE STREETS OF THE TOWN. ON 6 OCTOBER 1950 TERRORISTS OF THE YOUTH DEFENCE DETACHMENT BEAT LI SEN GYUNA TO DEATH IN BROAD DAYLIGHT ON DZONNO STREET. ON 7 OCTOBER 1950 BARBARIANS OF THE HWARYANDAN ORGANIZATION BEAT TO DEATH IN HYOCHAN PARK THE SECRETARY OF THE KONDEN DISTRICT NATIONAL COMMITTEE, SIN MEN GYUNA, AND HIS BROTHER SIN SEN SYUNA. ON 9 OCTOBER 1950 THE SAME PUBLIC SECURITY DETACEMENT ARRESTED 16 INNOCENT INHABITANTS AND KILLED THEM, AFTER CUTTING OFF THE HANDS, FEET, TONGUES, EARS AND NOSES OF OF THEM. THEY ALSO CUT OFF THE BREASTS OF TWO WOMEN AND GOUGED OUT THE EYES SEVERAL OTHERS. ON 10 OCTOBER 1950 ON A HILL BEHIND THE DONAMDON ELEMENTARY SCHOOL SYNGMAN RHEE'S FOLLOWERS SHOT 24 MEN AND WOMEN OF THE TOWN, AMONG WHOM A PREGNANT WOMAN, A FIFTEEN-YEAR-OLD HIGH SCHOOL GIRL AND AN INFANT. IN THE MIDDLE OF OCTOBER 1950 SYNGMAN RHEE'S FOLLOWERS KILLED THREE BROTHERS TEN VAN RESIDING AT 59 DONGEDON STREET BECAUSE HE HAD SERVED IN STATE INSTITUTIONS AT TIME OF THE LIBERATION OF SEOUL. IN THE LATTER PART OF DECEMBER 1950 SYNGMAN RHEE'S FOLLOWERS SHOT AN EMPLOYEE OF THE NATIONAL COMMITTEE OF THE MAPKHO DIS KIM ENN. HWAN TYO SI (561) AND HIS SISTER KIM YAN DZA (191), RESIDING IN HOU NO. 117 AT AHENDON. ON 2 JANUARY 1951 AMERICAN SOLDIERS MACHINE-GUNNED AN RAID SHELTER NEAR THE DONAMDON HILL IN WHICH REFUGEES WERE LIVING. AS A REA 12 PERSONS WERE KILLED, MOST OF THEM WOMEN AND CHILDREN. ON 2 JANUARY A GRO AMERICAN CRIMINALS ON LEAVING SEOUL FIRED ON A DUG-OUT IN WHICH SEVERAL FAMI WHICH HAD LOST THEIR HOMES WERE LIVING. 12 PERSONS WERE KILLED AMONG THEM A BORN INFANT. ON THE SAME DAY BRUTAL AMERICAN BANDS SEIZED IN THE TOWN KIM E A MEMBER OF THE UNION OF DEMOCRATIC YOUTH OF KOREA AND HAVING BEATEN HIM TO DRACCED HIS BODY BY THE FEET FOR SEVERAL HOURS THROUGH THE MAIN STREETS OF S ON 13 JANUARY 1951 THERE WERE FOUND IN A CESSPOOL NEAR THE POLICE SECTION OF DZONNO THE BODIES OF 9 WOMEN FROM THE CITY OF SEOUL WHO HAD BEEN KILLED BY

SYNGMAN RHEE'S FOLLOWERS DURING THEIR RETREAT. IT WAS FOUND THAT THREE OF THEM HAD HAD THEIR BREASTS CUT OFF AND TWO OF THEM THEIR LIPS. EARLY IN OCTOBER THE AMERICANS ARRESTED A TWENTY-SEVEN YEAR OLD WOMAN, KIM PU TIN, THE WIFE OF A PORT LABOURER, SIN SAN GYUN, MERELY BECAUSE SHE WAS A MEMBER OF THE WOMENS UNION. AFTER SUBJECTING HER TO EVERY KIND OF TORTURE AND INSULTS, THEY STRIPPED HER AND BURNED HER BREASTS AND PRIVATE PARTS WITH A RED-HOT WIRE.

WHEN THE NATIONAL ARMY AND THE CHINESE VOLUNTEERS CAME NEAR THE TOWN OF INCHON THE EXECUTIONERS BEFORE FLEEING COMMITTED INDESCRIBABLE ATROCITIES. FOR EXAMPLE. ON 17 JANUARY 1951 THE COMMISSION OF THE UNITED DEMOCRATIC NATIONAL FRONT FOUND AT THE CATES OF THE NATIONAL SCHOOL OF CHANEM WHERE THE SO-CALLED POLICE DEPARTMENT OF THE PROVINCE OF KENGIDO WAS HOUSED 48 BODIES WHICH WERE THOSE OF PERSONS KILLED BY THE AMERICAN SAVAGES ON 4 JANUARY JUST BEFORE THEIR FLIGHT FROM THE TOWN. HOW SON GUAN AN INHABITANT OF THE KYMGAKTON DISTRICT. RELATED THAT THE AMERICAN MURDERERS PIACED THEIR VICTIMS IN FOUR ROWS AND THEN SHOT THEM DOWN WITH MACHINE GUNS. THE MOUNTAIN OF DEAD BODIES PRESENTED SUCH A TERRIBLE SIGHT THAT THE INHABITANTS OF THE TOWN WERE FORCED TO USE OTHER STREETS IN ORDER TO AVOID IT. ON 18 JANUARY IN A SHED OF THE POLICE STATION IN EASTERN INCHON SITUATED IN A BUILDING OF THE SOYA FACTORY IN THE CHANENDON DISTRICT 127 BODIES WERE FOUND BY THE COMMISSION LYING IN HEAPS IN THE CORNERS OF THE SHED. THE PRISONERS HAD APPARENTLY BEEN BURNED ALIVE WHILE TRYING TO TEAR DOWN THE WALL IN AN EFFORT TO ESCAPE FROM THE BURNING BUILDING. IN ANOTHER SHED THE COMMISSION DISCOVERED 30 MORE CHARRED BODIES. HAVING BOUND AND COVERED THEIR VICTIMS WITH MATS AND POURED PETROL OVER THEM THE BARBARIANS SET FIRE TO THEM. THE UPPER PARTS OF THE DEAD BODIES WERE COMPLETELY CHARRED. THE COMMISSION FURTHER DISCOVERED IN THE BUILDING OF THE POLICE STATION AND ITS ENCLOSURE SOME 300 MORE BODIES OF PERSONS WHO HAD BEEN inhumanly murdered. On 18 January in the building of the police station at inchon THE COMMISSION DISCOVERED 18 BODIES. IN ADDITION TO THESE THE BODIES OF 10 MORE YOUNG DEMOCRATIC WORKERS WERE FOUND IN THAT STATION'S SHED. FOR EIGHT DAYS THE VILLAINS HAD GIVEN THE VICTIMS NO FOOD WHATSOEVER THUS DOOMENG THEM TO A DEATH OF TORTURE. UP TO 20 JANUARY IN THE KIMPKHO DISTRICT (A SUBURB OF THE TOWN OF INCHON) IN FOUR OF THE 9 ADMINISTRATIVE DIVISIONS A LARGE NUMBER OF KILLED WERE DISCOVERED. IN THE DIVISIONS OF YANDON, YANSEN, KIMPKHO AND YANCHON MORE THAN 400 PERSONS WERE KILLED ALL OF THEM MEMBERS OF THE FAMILIES OF DEMOCRATIC LEADERS. AMONG THOSE KILLED WAS PAK SYN AN, THE FORMER CHAIRMAN OF THE REGIONAL COMMITTEE OF THE LABOUR

PARTY, CHEN SUN HAK, A WORKER IN THE PERSONNEL SECTION OF THE PARTY'S REGIONAL COMMITTEE, LI CHON GUEN, A WORKER IN THE ORGANIZATION SECTION OF THE PARTY'S REGIONAL COMMITTEE, CHEN, AND OTHERS. THE AMERICAN GANGSTERS IN KOREA ARE REVIVING A SAVAGE CUSTOM BY SCALPING KOREAN PATRIOTS. IT HAS BEEN ESTABLISHED IN SECUL THAT 12 KOREAN PATRIOTS WERE SCALPED BY THE AMERICAN EXECUTIONERS. THE SCALPE WERE KEPT BY THE AMERICANS AS SOUVENIRS.

ODIOUS ACTS OF VIOLENCE AGAINST WOMEN AND GIRLS

THE SAVAGE HORDES OF AMERICANS TREATED THE KOREAN WOMEN WITH UNBELIEVABLE CRUELTY. THEY MADE SPECIAL RAIDS ON WOMEN WHOM THEY PUT INTO BROTHEIS, KEEPING HUNDREDS OF THEM IN DAMP CELIARS WITHOUT WATER OR FOOD. THEY STRIPPED THEM, TIED THEM BY THEIR HANDS AND FEET TO POSTS AND THEN SHOT AT THEM OR INDUIGED IN BAYONET PRACTICE. IN SECUL THE AMERICAN BEASTS IN HUMAN GUISE VIOLATED AND THEN KILLED MORE THAN 875 WOMEN, INCLUDING SOME MIDDLE-AGED WOMEN. AN INHABITANT OF SEOUL, KIM IN SU. STATED THAT LATE IN THE NIGHT OF 15 DECEMBER 3 AMERICANS BROKE INTO HIS HOUSE. THEY SNATCHED FROM THE ARMS OF A NEIGHBOUR HER TWO-WEEKS OLD CHILD, THREW IT ON THE FLOOR AND THEN VIOLATED THE UNFORTUNATE MOTHER. THAT HOWEVER WAS APPARENTLY NOT ENOUGH FOR THE VILLAINS. THEY WENT OFF TO ANOTHER HOUSE AND VIOLATED, A YOUNG GIRL IN THE PRESENCE OF HER MOTHER. ON THE FOLLOWING DAY THESE SAME 3 SOLDIERS BROKE DOWN THE DOOR OF THE HOME OF ONE KIM, AN OLD WOMAN, AND TRIED TO VIOLATE HER GRAND-DAUGHTER KO DE WON, A YOUNG CHIED. KIM PREVENTED THE CRIME, WHEREUPON THE ENRAGED SADISTS BEAT THE OLD WOMAN WITH THEIR REVOLVER BUTTS AND SLASHED HER FACE AND HEAD WITH A KNIFE. AT THE END OF DECEMBER SEVERAL AMERICAN SOIDIERS CAUGHT A YOUNG CIRL IN THE VILLAGE OF SAMCANDON AND CARRIED HER AWAY INTO A FOREST. ON THE SECOND DAY HER MUTILATED BODY WAS FOUND BY A PEASANT AT THE EDGE OF THE FOREST. IN JANUARY THE BODY OF A YOUNG WOMAN WAS FOUND IN THE YARD OF THE FOLICE DEPARTMENT IN SECUL. HER HEAD HAD BEEN PIERCEDE BY A BULLET. HER DRESS WAS TORN. THERE WAS AN ENORMOUS POOL OF BLOOD AROUND THE PRIVATE PARTS. O KYM SUN. AN INHABITANT OF THE CHANMYNDON DISTRICT. STATED THAT ALL THE TIME THE TOWN WAS OCCUPIED BY THE AMERICANS SHE HAD LIVED IN THE MOUNTAINS IN ORDER TO HIDE FROM THEM. ON 18 SEPTEMBER HER NEIGHBOUR. THE WIFE OF KUON PAK NO, A BANK EMPLOYEE, FEIL INTO THE HANDS OF THE AMERICANS. THE UNHAPPY VICTIM OF THESE BEASTS RETURNED HOME ONLY ON THE THIRD DAY THE TORTURED WOMAN IS STILL UNABLE TO RECOVER FROM THE ILL-TREATMENT INFLICTED UPON HER. KIM SAN GER A WORKER FROM THE SONRIMDON DISTRICT STATED THAT AT THE END OF OCTOBER LAST YEAR TWO YOUNG GIRLS. THE 14-YEAR OLD DAUGHTER OF HIS NEIGHBOUR TSOI MO AND THE 15-YEAR OLD DAUGHTER OF HIS NEIGHBOUR MAN MO.

nan mo. Who were drawing water from a well. Were seized and carried away by some AMERICANS IN A JEEP. A WEEK LATER THE BODIES OF THESE UNFORTUNATE GIRLS WERE DISCOVERED IN ONE OF THE HARBOUR WAREHOUSES. THEIR PRIVATE PARTS WERE INJURED AND THEY HAD DIED FROM SEVERE HEMORRHAGE. AT THE BEGINNING OF OCTOBER 3 AMERICANS BURST INTO THE APARTMENT OF A 40-YEAR OLD WIDOW, KIM, WHO LIVED IN THE KYMKOKTON DISTRICT AND AFTER SENDING HER TWO 16 AND 12 YEAR OLD SONS OUT OF THE AFARTMENT AT THE POINT OF A GUN. PROCEEDED TO VIOIATE HER THE WHOLE NIGHT THROUGH. SONBUKTON AND YNDINRI DISTRICTS MORE THAN 300 WOMEN WERE VIOLATED AMONG THEM HOUSEWIVES GIRL STUDENTS AND PEASANT GIRLS WHO HAD BEEN BROUGHT IN FROM THE NEIGHBOURING VILLAGES. INNUMERABLE OTHER CASES OF RAPE AND ABUSE OF WOMEN'S HONOUR ARE ALSO KNOWN. THUS ON 25 DECEMBER IN THE VILLAGE OF KVANJCKZHANRI IN THE OUTSKIRTS OF SECUL 3 AMERICAN SOLDIERS AT THE POINT OF A GUN VIOLATED A 50-YEAR OLD WOMAN IN A SEXUALLY PERVERTED MANNER. THIS FOUL ACTION PROVOKED A WRATHFULLY INDICNANT REACTION ON THE PART OF THE VICTIM AND IN STRUGGLING WITH THE ASSATIANTS SHE MUTILATED THE PRIVATE PARTS OF ONE OF THE SOLDIERS. AS A RESULT OF THIS THE AMERICAN MONSTER DIED AND THE OTHER TWO CUTTHROATS SHOT THE WOMAN.

PLUNDERING OF THE INHABITANTS PROPERTY

THE VANDALISM AND CRIMES COMMETTED BY THE AMERICAN BANDITS IN SECUL. INCHON AND THEIR ENVIRONS AND IN OTHER KOREAN TOWNS ARE NOT CONFINED TO MURDERING THE POPULATION AND VIOLATING WOMEN. THEY SYSTEMATICALLY RORBED AND CARRIED AWAY VALUABLE PROPERTY BELONGING TO THE STATE AND PRIVATE INDIVIDUALS, AND DESTROYED EVERYTHING THAT WAS VITAL TO THE LIFE OF THE PEOPLE. ON 30 SEPTEMBER 1950 5 Syngman Rhee men from the public security detachment of sonbuk district searched OVER 30 HOUSES IN THE ANAMDON DISTRICT AND CARRIED AWAY ALL THE FURNITURE AND OTHER PROPERTY. THE SYNGMAN RHEE MEN ARRESTED P HEN SEN CHIR (YE L) WHO WAS LIVING IN HOUSE 303 IN CHENCUDON AND DROVE HIM FROM HIS HOME BECAUSE HIS SON HAD BEEN A MEMBER OF THE NATIONAL MILITIA. AND HIS HOUSE AND ALL HIS PROPERTY WERE CONFISCATED. THE SYNGMAN RHEE MEN ARRESTED AND THEN KILLED KIN TA BIN WHO LIVED IN HOUSE NO 15 IN DONVODON BECAUSE HE HAD PREVIOUSLY WORKED FOR THE PEASANTS UNION AND CARRIED AWA: ALL HIS PROPERTY. BETWEEN 1 AND 20 OCTOBER 1950 IN THE LITEMEVON DISTRICT AMERICANS AND SYNGMAN RHEE'S FOLLOWERS LOOTED 21 HOUSES OF THE WORKERS OF VARIOUS INSTITUTIONS AND 5 HOUSES BELONGING TO MEMBERS OF THE NATIONAL MILITIA AND CARRIED AWAY A QUANTITY OF BEDDING AND HOUSEHOLD ARTICLES AND FOOD. IN THE MIDDLE OF DECEMBER 1950 IN THE THIRD SIDE-STREET OF NAMDEMUN STREET 3 AMERICAN SOLDIERS IN BROAD DAYLIGHT ROBBED AN OFFICIAL. TAKING FROM HIM 250 THOUSAND WON IN CASH WHICH HE WAS

HE WAS BRINGING FROM THE BANK. ON 26 DECEMBER 1950 IN THE THIRD SIDE-STREET OFF
CHUMMURO STREET 2 AMERICAN SOLDIERS RELIEVED IM EN DO, WHO LIVED IN GALVOITON, C?
300 THOUSAND WON IN CASH. ON 27 DECEMBER 1950 2 AMERICAN SOLDIERS ROTBET AL
OFFICIAL OF THE DZI N BON COMPANY, AT THE POINT OF A REVOLVER AND IN BROAD DAYLIGHA
IN MENDO STREET OF 400,000 WON. ON 2 JANUARY 1951 AMERICAN SOLDIERS ARRIVED IN 20
LORRIES AT DONAMDON AND CARRIED AWAY EVERYTHING OF ANY VALUE FROM PRIVATE DWELLINGS
IN THAT DISTRICT.

DESTRUCTION AND PLUNDER OF CULTURAL INSTITUTIONS

AMERICAN AND PUPPET SYNGMAN RHEE TROOPS DESTROYED OR SET FIRE TO MOST OF THE CULTURAL INSTITUTIONS OF THE TOWN OF SEOUL. THEY COMPLETELY DESTROYED OR BURNED DOWN 76 OF THE EXISTING SECUL SCHOOLS AND COMPLETELY DESTROYED THE INDOOR EQUIPMENT OF 179 SCHOOLS. 38 HOSPITALS AND OTHER MEDICAL ENSTITUTIONS WERE EITHER COMPLETELL DESTROYED AND BURNT DOWN. 2 RADIO STATIONS. 6 THEATRES. 1 MUSEUM AND 4 NEWSPAPER OFFICES WERE ALSO DESTROYED -- IN ADDITION TO THIS THEY BURNED THE BELL TOWER IN SZONUO STREET. DESTROYED AND BURNT DOWN A STONE MANSION IN THE DOKSU PALACE. THEY DESTROYED MONUMENTS IN FOUR STREETS NEAR THE KVANUWA GATES AND MANY OFFICE HISTORICAL MONUMENTS AND LOOTED MANY TREASURES. THEY CARRIED AWAY INNUMERABLE VALUABLE EXHIBITS FROM THE KEBOKKUN PALACE MUSEUM INCLUDING A GOLDEN CROWN OF THE SILIA PERIOD. THEY ALSO COMPLETELY LOCTED OR DESTROYED ARTICLES OF THE GREATEST VALUE FROM THE NATIONAL MUSEUM ON MT. NAMSAN. THE CHANGEVON MUSEUM AND THE MUSEUM OF THE UNIVERSITY OF SECUL. THEY ALSO COMPLETELY LOCKED THE FAMOUS CLASSICAL PICTURES IN THE DOKSU PALACE PICTURE CALLERY. THE HISTORICAL AND VERY VALUABLE LITERATURE IN THE STATE: TOWN, SEOUL UNIVERSITY AND OTHER LIBRARIES WAS COMPLETELY LOCTED OR BURNT. ALMOST ALL THE CULTURAL INSTITUTIONS AND EQUIPMENT IN INCHON HAVE BEEN DAMAGED AND DESTROYED. THE NUNKHVACVAN THEATRE HAS BEEN BURNED TO THE GROUND. CINEMATOGRAPHIC AND OTHER THEATRICAL EQUIPMENT IN EKUAN. Inchon, enkinagvan, tonban and other places has been carried away or destroyed.

DESTRUCTION OF WORKS, FACTORIES, GOVERNMENT AND OTHER INSTITUTIONS AND DWELLINGS

THE AMERICAN IMPERIALIST INVADERS HAVE DESTROYED ALMOST ALL THE WORKS,

FACTORIES, COVERNMENT AND PUBLIC CULTURAL AND OTHER INSTITUTIONS AND MOST OF THE

DWELLING HOUSES IN THE TOWNS OF SEOUL AND INCHON. THUS 785 CONCERNS AND OVER

118,000 DWELLING HOUSES HAVE BEEN COMPLETELY DESTROYED BY ARSON AND BOMBING. AS

A RESULT OF THEIR BARBAROUS AND CRIMINAL ACTIONS NEARLY ALL THE BUILDINGS IN

ENDYUPKHO HAVE BEEN ALMOST ENTIRELY DESTROYED. IN THE DZONNO, SODEMUNTKHON,

IDYNKHON, KVANKIAVANUNTKHON, FIJTIRO, NAMDEUMTKHON, KANKANTKHON STREETS IN SEOUL WHICH IS A MODERN AND IARGE CITY WITH A POPULATION OF 15 MILLION AND THE HISTORICAL CAPITAL OF KOREA 80-% OF THE BUILDINGS HAVE BEEN DESTROYED OR BURNED TO THE GROUND. THE CITY HAS COMPLETELY LOST ITS FORMER APPEARANCE AND HAS BECOME A RUIN AND A WILDERNESS OF RUBBLE AND CHARRED COLUMNS. IN INCHOIN PRINTING PRESSES AND OTHER EQUIPMENT IN THE TOWN OF IZDALJSTU HAVE BEEN CARRIED AWAY WHILE LARGE PRINTING PRESSES HAVE BEEN PARTIALLY DESTROYED AS FOR EXAMPLE IN CHUKCHI, TWALPANSO, HAMI, JENENSA, TAIRYUK AND OTHERS HAVE BEEN RENDERED USELESS. ALL MOTOR VEHICLES, SHIPS AND OTHER MEANS OF TRANSPORT INCLUDING EVEN WHEELBARROWS HAVE BEEN REMOVED OR RENDERED USELESS.

THIS CRIMINAL AND BASE DESTRUCTION OF OUR TOWNS AND VILLAGES AND THE EXTERMINATION OF THE PEACEFUL POPULATION IS THE EXPRESSION OF THE INSANE HATRED OF THE AMERICAN INVADERS FOR OUR COUNTRY AND THE ACHIEVEMENTS OF THE KOREAN PEOPLE WHICH WERE BROUGHT ABOUT BY THE PEOPLES GOVERNMENT OVER A PERIOD OF FIVE YEARS TO IMPROVE THE LIFE OF THE WORKERS IN THE PEOPLE'S DEMOCRATIC REPUBLIC. THE CRIMES OF THE AMERICAN AGGRESSORS WHICH HAVE MANIFESTED THEMSELVES IN INNUMERABLE INHUMAN ACTS OF VIOLENCE AND ROBBERY AGAINST THE PEACEFUL KOREAN POPULATION IN THE DESTRUCTION OF FACTORIES AND WORKS, GOVERNMENT INSTITUTIONS AND DWEILINGS IN THE CITIES OF SEOUL, INCHON AND THEIR ENVIRONS DEFY DESCRIPTION, AND IT WOULD AISO BE IMPOSSIBLE AT THIS MOMENT TO LIST ALL THE VICTIMS. IN BRINGING ALL THESE FACTS TO THE NOTICE OF ALL HONEST PEOPLE AND OF WORLD PUBLIC OPINION THE COMMISSION OF THE UNITED DEMOCRATIC NATIONAL FRONT EXPRESSES THE CONVICTION THAT ALL THE FREEDOM-LIVING PEOPLES ARE UNANIMOUS IN HOLDING THAT THE AMERICAN ACCRESSORS AND THEIR SYNGMAN RHEE ACCOMPLICES AND FOREMOST AMONG THEM SUCH ACCURSED ORGANIZERS AND INSTIGATORS OF ARMED INTERVENTION IN KOREA AS MAC ARESUR AND DULLES. THE BUTCHERS OF THE KOREAN PEOPLE. MUST BEAR FULL RESPONSIBILITY AND RECEIVE THE STERNEST PUNISHMENT FOR ALL THEIR UNPRECEDENTED CRIMES AND FOR THE ENTIRE MATERIAL loss which they have caused to korean citizens, Public organizations. Government ENTERPRISES AND INSTITUTIONS OF THE PEOPLE'S DEMOCRATIC REPUBLIC OF KOREA.
