TELEGRAM DATED 6 MAY 1951 FROM THE PERMANENT REPRESENTATIVE OF ISRAEL TO THE PRESIDENT OF THE SECURITY COUNCIL REQUESTING A MEETING OF THE SECURITY COUNCIL

I HAVE THE HONOUR TO REQUEST THAT A MEETING OF THE SECURITY COUNCIL BE CONVENED WITH THE UTMOST URGENCY FOR THE PURPOSE OF INSCRIBING ON ITS AGENDA AND IMMEDIATELY DISCUSSING THE FOLLOWING THEM "ISPAEL COMPLAINT OF SYRIAN AGGRESSION AGAINST ISRAEL TERRITORY SINCE MAY 2ND 1951 AND FESSISTENT STRIAN ATTACKS ON THE DEMILITARIZED ZONE". SINCE MY URGENT APPEAL TO THE SECURITY COUNCIL ON MAY 2ND SYRIAN REGULAR AND IRREGULAR FORCES HAVE CONTINUED BOTH TO CONSOLIDATE THEIR MILITARY POSITIONS WITHIN THE MILITARIZED\* ZONE AND TO MAKE REPEATED ASSAULTS ON TEL-EL-MUTILLEH IN THE NON-DEMILITARIZED AREA OF ISRAEL TERRITORY. MY COVERNMENT NOW HAS CONCLUSIVE PROOF OF THE OPERATION OF SYRIAN FORCES ON ISRAEL TERRITORY AND ALSO HOLD SYRIA RESPONSIBLE FOR THE IRREGULAR FORCES WHICH HAVE TAKEN UP POSITIONS IN THE DEMILITARIZED ZONE AND BEYOND. WHILE CONTINUING TO DEFEND ITSELF VIGOROUSLY IN ACCORDANCE WITH ARTICLE 51 OF THE CHARTER AND TO MAKE ALL EFFORTS TO REPULSE SYRIAN FORCES WHICH ARE USING THE DEMILITARIZED ZONE AS A BASE FOR ACCRESSION AGAINST ISRAEL TERRITORY. ISRAEL PERSONNEL AND LEGITIMATE ISRAEL INVERESTS. MY GOVERNMENT ONCE AGAIN CALLS UPON THE UNITED NATIONS TO SECURE A CESSATION OF THIS FLACRANT SYRIAN ACCRESSION.
