SUMMARI STATEMENT BY THE SECRETARY-GENERAL OF MATTERS OF WEICH TIE STOURITY COUNCIL IS SEIZED AND OF THE STAGE REACHED IN THEIR CONSIDERATION

By letter dated 10 December 1951 (8/2435) the Secretary-General transmitted the text of the General Assembly resolution adopted at the 352nd-meeting held on 7 December 1951 requesting the Security Council to give urgent consideration to that resolution with a view to recommending the immediate admission of Italy to membership in the United Nations.

At the 568th meeting on 18 December 1951 the Council decided by a vote of 8 in favour, 1 against, and 2 abstentions, to include the above mentioned letter (8/2435) as an item on the agenda.

At the same meeting, the representative of France submitted a draft resolution (S/2443) which would have the Security Council, after taking into consideration the General Assembly resolution of 7 December 1951, recommend the admission of Italy to membership in the United Nations.

At the 569th meeting on 19 December 1951, the USSR representative submitted a draft resolution recommending the following States for admission to membership in the United Nations: Albania, Bulgaria, Hungary, Mongolian People's Republic, Romania, Austria, Jordan, Ceylon, Finland, Italy, Ireland, Nepal and Portugal (S/2449).
