LETTER DATED 29 JUNE 1951 FROM THE PRESIDENT OF THE SECURITY COUNCIL TO THE SECRETARIAT OF THE UNITED NATIONS

Further to the cablegram published in document S/2201/Rev.1 of 19 June 1951, I would ask you also to issue as a Scurity Council document for the information of members of the Council the following correspondence concerning the receiving of the delegation of the World Peace Council by the President of the Security Council of the United Nations.

On 21 June 1951 a cablegram was received by the President of the Security Council from the President of the World Peace Council, Mr. F. Joliot-Curie, as follows:

On 21 June 1951 the President of the Security Council sent the following cablegram to Mr. Joliot Curie:

DAVIES PARTICIPATE WORLD FEACE COUNCIL DELECATION IN RESPONSE YOUR INVITATION STOP US CONSULATE HERE STATE THEY ARE INFORMING WASHINGTON BUT CONSULATE CLOSED DURING VLEKEND ANSWER THEREFORE MAY BE DELAYED SEVERAL DAYS STOP PLEASE ADVISE WHETHER ANY MEANS EXPEDITING THIS MATTER STOP AIR PASSAGES BOOKED CLASGOW NEW YORK SUNDAY 24th JUNE

On 23 and 25 June 1951 the President of the Security Council received the following telegraphic communications from members of the delegation of the World Peace Council: Mrs. Jessie Street (Australia), Mr. Nenni (Italy), Mr. Atal (India) and Mr. Paul Robeson (United States of America).

Mrs. Jessie Street's cablegram reads as follows:

"YACCB MALIK PRESIDENT SECURITY COUNCIL UNITED NATIONS NEW YORK THANKS CABLE APPLIED FOR VISA YESTERDAY AND AGAIN TODAY STOP UNITED STATES AUTHORITIES SAY PARTICULARS SENT WASHINGTON WHERE DECISION RESTS STOP REFERRED THEM TO ARTICLE 4 SECTION 5 AGREEMENT GUARANTEEING ACCESS TO HEADQUARTERS UNITED NATIONS STOP AUTHORITIES STATE THEY HAVE NO KNOWLEDCE OF SUCH AGREEMENT

Mr. Pietro Nenni's cablegram reads as follows: "MALIK PRESIDENT SECURITY COUNCIL UNITED NATIONS LAKE SUCCESS YOUR MESSAGE THAT YOU WOULD RECEIVE ON 25-27 JUNE DELEGATION OF WORLD PEACE COMMITTEE APPOINTED BY WORLD PEACE COUNCIL BERLIN RECEIVED SATURDAY TOO LATE TO ARRANGE JOURNEY STOP AMERICAN EMBASSY HAS SO FAR NOT REPLIED TO REQUESTS FOR VISAS STOP HOPE OTHER MEMBERS OF DELEGATION MAY BE ABLE TO REACH NEW YORK STOP TASK ENTRUSTED TO US BY WORLD PEACE COUNCIL IS

Mr. Atal's cablegram reads as follows: "LT MANSIEUR JACOB MULLICK PRESIDENT SECURITY COUNCIL NEW YORK /SUSPECTED DUPLICATE/ YOUR REDIRECTED CABLE REACHED ME LAST NIGHT STOP REGRET IMPOSSIBLE REACHING THERE BY 27TH

Mr. Paul Robeson's telegram reads as follows: "YAKOV A MALIK CHAIRMAN SECURITY COUNCIL OF UN 580 PARK AVENUE DEAR MR. MALIK DOCTOR WILLARD UPHAUS AND I HAVE RECLIENT WORD FROM DOCTOR FREDERIC JOLIOT-CURIE PRESIDENT FOR THE WORLD COUNCIL FOR PEACE THAT WE WILL BE RECEIVED BY YOU BETWEEN JUNE 25TH AND JUNE 27TH. OUR DEEPEST THANKS FOR YOUR COURTESY SINCERELY

On 26 June 1951, the President of the Security Council received a second cablegram from the British National Peace Committee reading as follows: "MR MALIK FRESIDENT SECURITY COUNCIL UNITED NATIONS MY FOLLOWING CABLE TODAY SENT TO TRYGVE LIE STOP QUOTE ON 22ND JUNE 1951 MRS S O DAVIES AND MRS JESSIE STREET IN RESPONSE TO INVITATION FROM PRESIDENT OF SECURITY COUNCIL MALIK APPLIED US CONSULATE HERE FOR VISAS FOR USA UNDER ACREEMENT."

In connexion with this cablegram the President of the Security Council sea the following urgent telegram to the Secretary of State of the USA:

Mr. Acheson, Secretary of State of the USA, Washington, D.C.

On 16 June Mr. Joliot-Curie, Chairman of the World Peace Council, addressed to me in my capacity as President of the Security Council a request to receive a delegation of the WPC. I replied to Mr. Joliot-Curie informing him that I would receive the delegation of the Peace Council in New York on 25-27 June, and I cabled the members of the delegation to that effect.

I have now received a communication from the National Peace Committee in England informing me that Mrs. S.O. Davies and Mrs. Jessie Street, the British delegates, have so far not received American visas in spite of repeated applications to the US Embassy in London. The situation is such that as a result of the non-receipt of American visas by the members of the WPC delegation the meeting of the delegation of the World Peace Counci with the President of the United Nations Security Council may be prevented unless immediate steps are taken to issue visas to the WPC delegates, who have submitted formal applications for visas to the appropriate embassies and consulates of the USA.

In connexion with the delay in issuing visas to the above-mentioned members of the WPC delegation, I sent on 23 June an urgent telegram to Mr. Austin, head of the US Mission to the UN, asking him to take all possible steps to expedite the issue of visas. I have not yet, however, received any answer from Mr. Austin to that telegram, and judging from the communication of 26 June from the British National Peace Communication, the situation is still unchanged and delegates Davies and Street have not yet received visas.

I would ask you, Mr. Secretary of State, to arrange for these members of the delegation of the World Peace Council to be immediately provided with visas for their journey to New York as members of the delegation of the WPC appointed to meet the President of the United Nations Security Council. It goes without saying that this is a matter the settlement of which is urgent.

The text of the telegram dated 27 June 1951 from the President of the Security Council to United States Secretary of State Acheson was also sent on 28 June to Mr. Jolict Curie, President of the World Peace Council.

Some time after the dispatch of the telegram to Mr. Acheson, the following letter from Mr. Gross was received in reply to the telegram sent to Mr. Austin on 23 June 1951:

On 27 June 1951 the President of the Security Council received the followin cablegram from Mr. Joliot-Curie, President of the World Peace Council:

"Jacob Malik 680 Park Avenue New York

Visas not granted for World Council Delegation.

Please receive delegation members Robeson and Uphaus who are on the spot. Joliot-Curie"

On 28 June 1951 the President of the Security Council cabled the following reply to Mr. Joliot-Curie:

"I have received your cablegram of 27 June informing me that WPC delegation has not been granted United States visas and hence unable to come to New York to meet the President of the United Nations Security Council.

"In accordance with your request I will receive WPC delegation members Robeson and Uphaus, who are on the spot, at 4 p.m. on 28 June.
