Item 2. Information on the preparations for the Spring Seminar and for the 58th session of the Economic Commission for Europe

Item 4. Environmental assessment and reporting

The Chairman of the Working Group on Environmental Monitoring reported to the Committee on Environmental Policy at its ninth session, and the ECE secretariat together with the European Environment Agency (EEA) reported to the Working Group of Senior Officials at its fourth meeting, on progress in the preparation of the Kiev Assessment report and on other contributions on environmental assessment and reporting. The Committee on Environmental Policy and the Working Group of Senior Officials welcomed the progress made and stressed the importance of assessment and monitoring. Some delegations suggested that this issue should be included as a separate item in the Kiev agenda.

The Chairman of the Working Group on Environmental Monitoring and the European Environmental Agency will report on further preparations related to environmental assessment and reporting.

Item 5. Environmental education for sustainable development

Further to suggestions made at the third meeting of the Working Group of Senior Officials, a drafting group was established to develop a strategy for environment and education, under the leadership of Sweden and the Russian Federation. It met for the first time on 9 September. The results of this meeting and further consultation were presented to the Committee on Environmental Policy, at its ninth session, and the Working Group of Senior Officials, at its fourth meeting.

Delegations stressed that a strategic view on environment for sustainable development required coordination between Environment Ministers and Education Ministers and other bodies concerned. It was therefore decided to explore with the Council of Europe, which was currently organizing a discussion by Education Ministries on this issue, the feasibility of developing a joint process for education on sustainable development.

The Working Group requested the United Nations Economic Commission for Europe to take up this question at its session in March as part of the debate on sustainable development.

With respect to the future work of the above-mentioned drafting group on environmental education for sustainable development and its upcoming meeting scheduled for 22 November 2002 in Moscow, the Working Group directed it to provide to the Executive Committee at its meeting in January a short document on environmental education for sustainable development, examining the key issues and suggesting possible future actions, that could be the basis for decisions by the Ministers in Kiev.

The Working Group may, at its meeting in February, review the possibility of organizing a seminar on best practices in environmental education for sustainable development as a side event in Kiev.

Item 2. Future of the "Environment for Europe" process

At its third meeting, the Working Group established a drafting group on the future of the "Environment for Europe" process. The drafting group met in Geneva on 12 September and on 2 October 2002. Its draft paper was considered by the Working Group of Senior Officials during its fourth meeting. The paper was well received and valued as an important contribution to the preparations for the Kiev Conference.

The third meeting of the drafting group is scheduled for 3 December, also in Geneva. Participants in the Working Group of Senior Officials were requested to provide their written comments to the ECE secretariat by 18 November 2002 for the further revision of the document by the drafting group. The revised paper will be available for consideration by the Working Group at its fifth meeting.

Item 3. Drafting of the Ministerial Declaration

The Working Group of Senior Officials, at its fourth meeting, decided that the Chair would prepare the first draft of elements that might be included in the Ministerial Declaration in consultation with a small drafting group, which would meet on 4 December, in Geneva. It also decided that the Executive Committee, which should be responsible for further drafting the Ministerial Declaration, would review and revise the first draft at its meeting in January 2003 and submit it to the Working Group at its fifth meeting.

Item 4. Partnerships

(a) EECCA environmental strategy

At its fourth meeting, the Working Group of Senior Officials was informed about the main outcomes of the third meeting of the Steering Group and expert meetings for the drawing-up of

an environmental strategy for the countries of Eastern Europe, the Caucasus and Central Asia (EECCA) held in Tbilisi on 13-17 October 2002.

It was agreed that the first draft of the strategy would be sent out to States for comment by 10 December 2002, followed by further discussion at the national level and further revision and finalization at the fourth meeting of the Steering Group (Tbilisi, 8-9 February 2002).

The Working Group agreed that the strategy should be on the agenda of the Kiev Conference and looked forward to having an opportunity to review the final text at its fifth meeting, in February 2003. Possible issues concerning institutional or other arrangements for implementation would be viewed also in the context of the Working Group's discussion on the future of the "Environment for Europe" process.

The Working Group invited the secretariat to prepare proposals regarding the procedure for the endorsement of the strategy, for consideration by the Executive Committee at its meeting in January 2003 and, subsequently, by the Working Group in February 2003.

(b) Environment, water and security in Central Asia

The secretariat reported to the Working Group of Senior Officials at its fourth meeting on the High-level meeting of the representatives from the Ministries of Environment of countries of Central Asia (Khoudjand, Tajikistan; 1-2 October 2002). The countries of Central Asia had proposed to include an item on "Environment, water and security – basis for sustainable development" in the Kiev Agenda. This item should be based on the Central Asian initiative on sustainable development launched at the Johannesburg Summit. The development of a legal document on regional cooperation could be started after the Conference.

The countries of Central Asia proposed that, for the Kiev Conference itself, they could prepare a note of commitment, for example, a regional declaration or charter, for adoption. The delegation of Kazakhstan, speaking on behalf of the countries of Central Asia, offered to host another meeting to consider this issue.

The Working Group considered the issue to be of high importance, and it was agreed that it would be taken up again at its fifth meeting.

(c) Business partnerships for environmental management

At its fourth meeting, the Working Group discussed the possible organization of an agenda item or side event during the Conference on the role of the business community in environmental management. It requested the Task Force for the Environmental Action Programme (EAP) and the Project Preparation Committee (PPC) to prepare concrete proposals on this issue for consideration at its fifth meeting.

Further to the discussions at the fourth meeting of the Working Group, it was agreed that the Chair would provide a revised proposal for the agenda and organization of work for the Kiev Conference.

Item 7. Update on other preparatory activities

(a) Biodiversity-related issues

The Council of the Pan-European Biological and Landscape Diversity Strategy (PEBLDS) will meet in January 2003 to decide on the draft commitments that are to be put forward to the Kiev Conference for discussion and decision. The PEBLDS secretariat will provide an update to the Working Group on the results of this meeting, including a resolution on the regional implementation of biodiversity targets and the integration of biodiversity into sectoral policies.

The representative of the Ministerial Conference on the Protection of Forests in Europe will report further on its plans to submit a background document on a framework for cooperation between PEBLDS and the Ministerial Conference on the Protection of Forests in Europe.

(b) Regional mountain initiatives

At its third meeting, the Working Group of Senior Officials was informed about progress in the development of legal instruments for the protection of the ecosystems in the Carpathian and Caucasian mountains. It was confirmed that the Carpathian convention should be available in time for the Conference. A legal instrument on the Caucasian mountains will not be ready.

The United Nations Environment Programme will provide a progress report on the Carpathian convention.
