INFORMATION CIRCULAR N° 52 Rev.1 **

Subject: Salary Rates Applicable to General Services Staff Engaged for Conference and other Short-Term Service

- 1. This circular is issued to revise the effective date of the salary rates of General Şervice staff engaged for conference or other short-term service announced in Information Circular IC/Geneva/2002/52 of 4 October 2002, from 1 October 2002 to 1 January 2002. Such revision which is based on a further review of this matter including, inter-alia, past precedents is without prejudice to any future action.
- 2. The salary rates effective 1 January 2002 are reproduced in Annex I.
- 3. The rates shown in Annex I shall be payable retroactively for the period from 1 January to 30 September 2002 to staff members who were on board on 13 December 2002. Those staff who left the Organization prior to that date and those staff who were employed on 13 December 2002 but had one or more break in service during the period from 1 January to 30 September 2002 will be eligible to receive retroactive payments upon submission of a written claim to the Payroll Unit. Such claims must be made within one year of the date of this circular.
