### **General Notes**

1. The fifty-eighth session of the Commission (4-6 March 2003) will be preceded by a seminar on 3 March on "Sustainable development in the ECE Region". Debate under the session's agenda item 2. will draw upon the seminar's discussion.
2. In accordance with the Commission's Rules of Procedure, the documents referred to in the Provisional Agenda will, wherever possible, be transmitted to Governments in the Commission's three official languages (English, French, Russian) not less than forty-two days before the opening of the session, i.e. not later than 21 January 2003. For reasons of economy, delegates are requested to bring copies of the documents mentioned in the provisional agenda to the meeting.
3. As part of the ongoing efforts of all concerned to revitalize the sessions of the Commission, and in keeping with the previous sessions of the Commission, the Bureau recommends that delegations, PSB Chairpersons and representatives from other organizations/initiatives should refrain from general statements and limit themselves to specific observations and proposals for action. Any delegation wishing to provide a text for distribution is requested to provide the secretariat, preferably in advance of the session, with sufficient copies (approximately 75).
4. It is anticipated that the Gunnar Myrdal Lecture will be held on Wednesday, 5 March, at 4.30 in the afternoon. The formal meeting of the Commission will adjourn at 4:30 p.m. with the lecture to be held in the same meeting room.

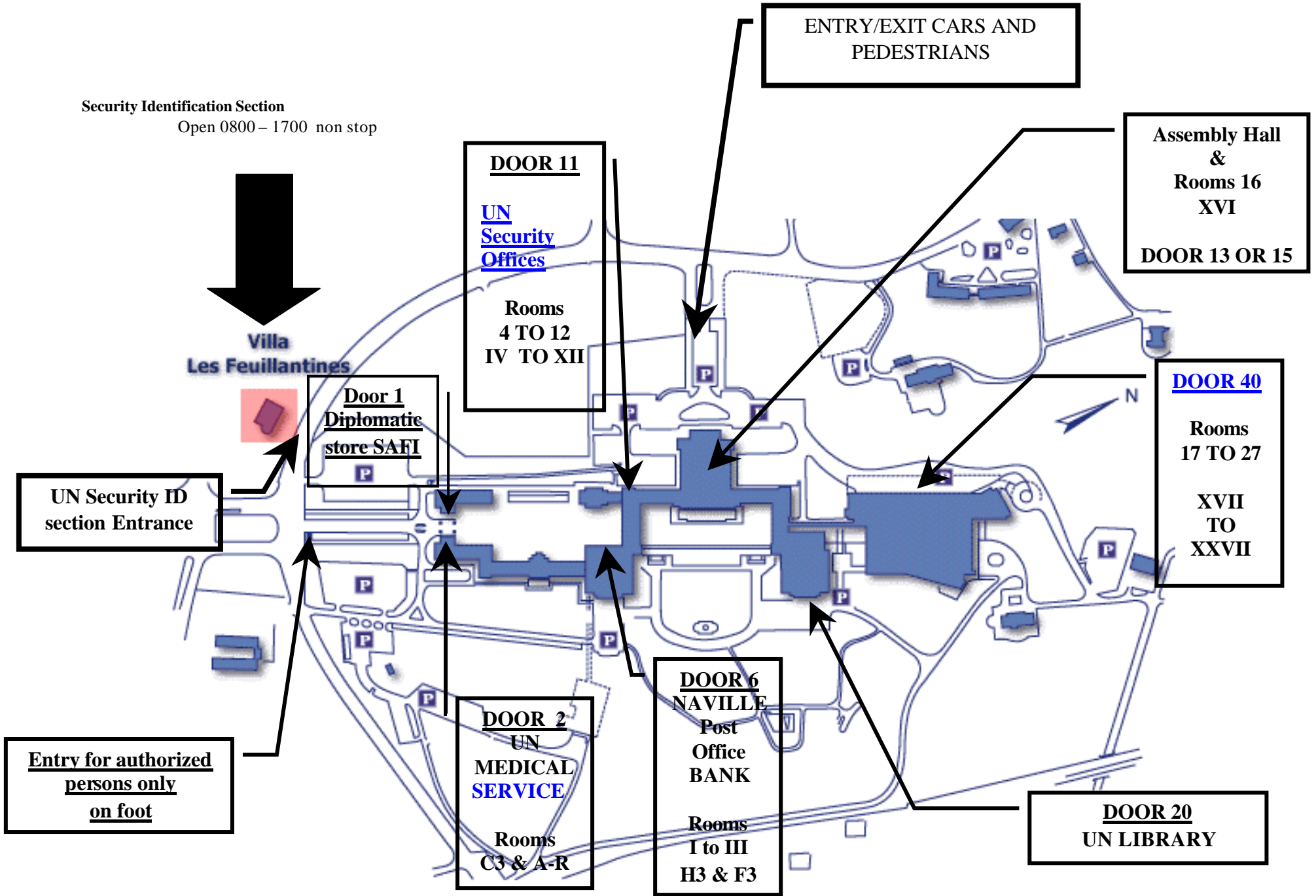
