CO-OPERATION BETWEEN THE UNITED NATIONS AND THE LATIN AMERICAN ECONOMIC SYSTEM

The General Assembly,

<u>Recalling</u> resolution 42/12 of 28 October 1987 on co-operation between the United Nations and the Latin American Economic System,

<u>Having considered</u> the report of the Secretary-General on co-operation between the United Nations and the Latin American Economic System, 1/

Taking into account decision 282 of 20 September 1988 on co-operation between the United Nations and the Latin American Economic System, adopted at the fourteenth regular session of the Latin American Council, in which the conviction was expressed that General Assembly resolution 42/12 represents an important step towards further development of co-operation between the Latin American Economic System and the United Nations system,

<u>Considering</u> that the Economic Commission for Latin America and the Caribbean has developed close ties of co-operation with the Latin American Economic System and that, in the course of the last year, efforts have been successfully made at co-ordinating and mutually strengthening their activities,

<u>Considering also</u> that since 1976 the Permanent Secretariat of the Latin American Economic System has carried out various programmes with the support of the United Nations Development Programme in areas that are considered priority for the economic development of the region,

<u>Considering further</u> that the Latin American Economic System is developing joint activities with specialized agencies and other bodies and programmes of the United Nations system, such as the United Nations Conference on Trade and Development, the United Nations Organization for Education, Science and Culture, the United Nations Industrial Development Organization, the World Meteorological Organization, the World Health Organization, the World Intellectual Property Organization, the United Nations Environment Programme, the United Nations Centre on Transnational Corporations, the Office of the United Nations Co-ordinator for Disaster Relief and the United Nations Institute for Training and Research,

1. <u>Takes note with satisfaction</u> of the report of the Secretary-General;

2. <u>Expresses satisfaction</u> with decision 282 of the Latin American Council of the Latin American Economic System;

3. <u>Expresses its gratitude</u> for the constant efforts made by the Latin American Economic System in promoting co-operation among the countries of Latin America and the Caribbean, and consultation and co-ordination of their positions on subjects of vital importance to the region, as well as in enhancing their economic and social development;

4. <u>Welcomes with satisfaction</u> the dialogue which the Ministers for Foreign Relations of Latin American and Caribbean countries are holding on the occasion of the ordinary sessions of the Latin American Council of the Latin American Economic System;

5. <u>Urgas</u> the Economic Commission for Latin America and the Caribbean to broaden and deepen its co-ordination and mutual support activities with the Latin American Economic System, as well as its participation in common efforts to harmonize action among the various regional and subregional entities in the economic field;

6. <u>Urges</u> the United Nations Development Programme to strengthen and broaden its support to the programme that the Permanent Secretariat of the Latin American Economic System is carrying out within the framework of the 1989-1991 work programme approved by the Latin American Council;


7. <u>Urges</u> the specialized agencies and other organizations and programmes of the United Nations system to continue to intensify their co-operation with the activities of the Latin American Economic System;

8. <u>Requests</u> the Secretary-General of the United Nations to promote, in close collaboration with the Permanent Secretary of the Latin American Economic System, the holding of a meeting in 1989 between their respective secretariats, with the aim of identifying those areas in which it will be possible to broaden co-operation between the United Nations system and the Latin American Economic System;

9. <u>Requests</u> the Secretary-General to continue to take the necessary measures to st agthen and intensify co-operation between the United Nations system and the Latin American Economic System, and to inform the General Assembly at its forty-fourth session of the implementation of the present resolution.
