SUMMARY STATEMENT BY THE SECRETARY-GENERAL ON MATTERS OF WHICH THE SECURITY COUNCIL IS SEIZED AND ON THE STAGE REACHED IN THEIR CONSIDERATION

Addendum

Pursuant to rule 11 of the provisional rules of procedure of the Security Council, the Secretary-General is submitting the following summary statement.

The complete list of items of which the Security Council is seized is contained in document S/11185 of 7 January 1974 and the pertinent addenda. During the week ending 30 November 1974, the Security Council took action on the following item:

The Security Council resumed its consideration of the question at its 1809th meeting, held on 29 November 1974, and included in its agenda the report of the Secretary-General on the United Nations Disengagement Observer Force (S/11563).

The President, with the consent of the Council, invited the representatives of Israel and the Syrian Arab Republic, at their request, to participate in the discussion without the right to vote.

The representative of Peru introduced a draft resolution (S/11565) sponsored by Austria, Indonesia, Kenya, Mauritania, Peru and the United Republic of Cameroon.

The Security Council adopted the draft resolution (S/11565) as resolution 363 (1974) by 13 votes to none, with no abstentions. China and Iraq did not

participate in the vote. In its operative paragraphs, resolution 363 (1974) reads as follows:

## Decides:

(a) To call upon the parties concerned to implement immediately Security Council resolution 338 (1973);

(b) To renew the mandate of the United Nations Disengagement Observer Force for another period of six months;

(c) That the Secretary-General will submit at the end of this period a report on the developments in the situation and the measures taken to implement Security Council resolution 338 (1973).
