Further report on the status of the cease-fire in the Middle East

The Chief of Staff of UNTSO has reported that, in addition to the recurrent incursions near border pillars 11, 19 and 33 (S/11057/Add.424, para. 2), the following developments took place in the Israel-Lebanon sector on 30 April 1974:

1. Reports on ground activity:

OP Khiam: 1/ Between 0300 2/ and 0315, between 1304 and 1455 and between 1520 and 1523 mortar fire by Israel forces into Lebanon.

2. Reports on air activity:

- (a) OP Hin: Between O611 and O613 two Israel forces jet aircraft, flying south-west to north-east, crossed the armistice demarcation line (ADL) south-east of OP and were last observed north-east of OP. Between O618 and O619 one unidentified jet aircraft, flying south-west to north-east, crossed the ADL south-east of OP and was last observed north-east of OP. Between O626 and O627 two Israel forces jet aircraft, flying north-east to south-west, were first observed north-east of OP and recrossed the ADL south-west of OP. Between O932 and O933 two Israel forces jet aircraft, flying south-south-west to north-north-east, crossed the ADL west-south-west of OP and were last observed north-east, was first and last observed north-east of OP. Between O956 and O957 two Israel forces jet aircraft, flying west to east, then north-east, were first and last observed north-east of OP. Between loll and lol2 two Israel forces jet aircraft, flying south-west to north-east then south, were first observed north-east of OP and recrossed the ADL east-south-east of OP.
- (b) OP Khiam: Between 0611 and 0613 two Israel forces jet aircraft, flying south-south-east to north-north-west, then west, crossed the ADL south-south-east of OP and were last observed north-west of OP. Between 0619 and 0621 one Israel forces jet aircraft, flying south to north, crossed the ADL south-east of OP and was last observed north of OP. Between 0624 and 0625 one Israel forces jet aircraft, flying

south to north, then north-west, was first observed west of OP and last observed north-west of OP. Between 0656 and 0658 two Israel forces jet aircraft, flying south to north, turning north-west and west, then south, crossed the ADL south-south-east of OP and were last observed west-south-west of OP. Between 0935 and 0936 two Israel forces jet aircraft, flying south-west to north-east then east, were first observed north-west of OP and last observed north-north-east of OP. Between 0943 and 0944 two Israel forces jet aircraft, flying south to north, then north-east, were first observed west of OP and last observed north-east of OP. Between 0948 and 0959 two Israel forces jet aircraft, flying south- to north, turning east, then south, crossed the ADL south of OP and were last observed north of OP (three overflights).

- (c) OP Lab: Between 0700 and 0701 two Israel forces jet aircraft, flying north-east to south-west, were first observed east of OP and recrossed the ADL south of OP. Between 1000 and 1001 and between 1003 and 1004 one unidentified jet aircraft, flying south to north, crossed the ADL south of OP and was last observed north of OP.
- (d) OP Mar: Between 0948 and 0949 one Israel forces jet aircraft, flying north-north-east to south-west, was first observed over OP and last observed south-south-west of OP. Between 0953 and 0954 one Israel forces jet aircraft, flying south to north, was first observed north of OP and last observed northnorth-west of OP. Between 0956 and 0957 one Israel forces jet aircraft, flying south to north, was first observed north-west of OP and last observed south-southwest of OP. Between 1003 and 1004 two Israel forces jet aircraft, flying west to east, were first observed south-south-west of OP and last observed south of OP. Between 1012 and 1013 two unidentified jet aircraft, flying north-east to south-west, were first observed west of OP and last observed south west of OP. Between 1338 and 1339 two Israel forces jet aircraft, flying south to north, turning east, then south, were first observed west of OP and recrossed the ADL north-north-east of OP. Between 1351 and 1352 two Israel forces jet aircraft, flying south-west to north-east, then south, were first observed south west of OP and recrossed the ADL east-south-east of OP. Between 1406 and 1435 two Israel forces jet aircraft, flying south to north, turning east, then south, were first observed west-south-west of OP and recrossed the ADL east-south-east of OP (five overflights).

3. Complaints by the parties:

Complaints have been received from Lebanon alleging that on 30 April:

- (i) From 0340 two Israel forces mechanized patrols penetrated Lebanese territory in the vicinity of Chebaa (AMR 2200-3060) 3/ and, after firing several automatic weapon bursts, occupied the positions at AMR 2183-3038 and AMR 2200-3042.
- (ii) Between 0615 and 0830 Israel forces jet aircraft overflew Lebanese territory in different regions in several passes of from two to four aircraft per overflight.

(iii) Between 0945 and 1030 two Israel forces jet aircraft overflew the Lebanese territory in different regions in different passes.

Complaints (ii) and (iii) were confirmed by United Nations observation (see paragraphs 2 (a), (b), (c) and (d) above). Complaint (i) was not confirmed; the area of the alleged incident is not within the range of United Nations observation.
