LETTER DATED 13 SEPTEMBER 1983 FROM THE REPRESENTATIVE
OF NICARAGUA ON THE SECURITY COUNCIL ADDRESSED TO THE
PRESIDENT OF THE SECURITY COUNCIL

I have the honour to transmit to you herewith documentary proof which clearly demonstrates the extraordinary facilities given by the United States authorities to the pilots who bombed Augusto César Sandino International Airport at Managua on 8 September 1983. This confirms once again the decision of the present Government of the United States to destroy the Sandinist People's Revolution and to overthrow the Government of Nicaragua.

I should be grateful if you would have this note and its annexes circulated as a Security Council document.

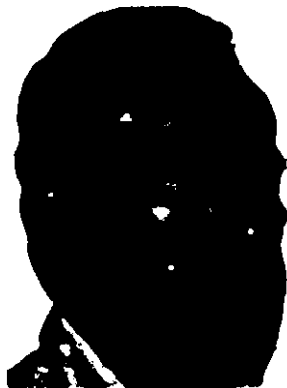

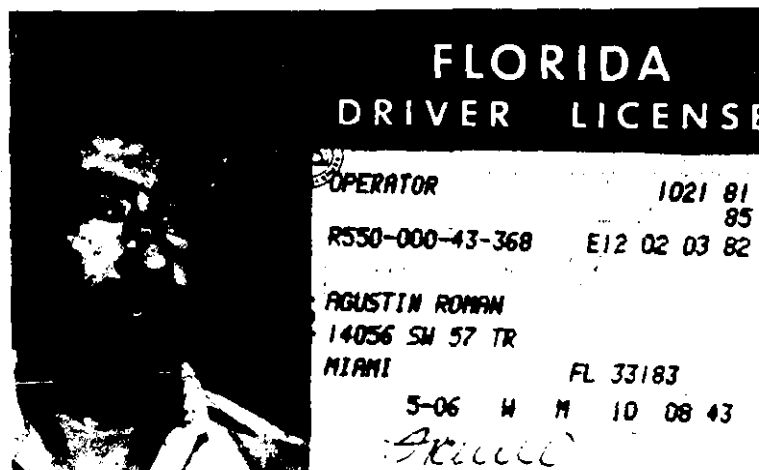

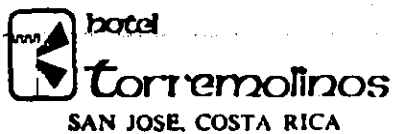
