REPORT BY THE SECRETARY-GENERAL IN PURSUANCE OF RESOLUTION 246 (1968)
ADOPTED BY THE SECURITY COUNCIL AT ITS 1397TH MEETING ON 14 MARCH 1968

Addendum

Since the submission of the Secretary-General's report of 31 March 1968 and the first two addenda on 3 and 16 April 1968 (S/8506 and Add.1-2), additional replies have been received to his note of 18 March from Ghana, Jordan, the Philippines and Poland. The substantive parts of these replies are reproduced in the annex to this document.

ANNEX

GHANA

[Original: English]
16 April 1968

"As regards the implementation of operative paragraph 3 of the resolution [246 (1968)]; the Ghana Government will support the Security Council in taking effective and drastic measures including enforcement measures under Chapter VII of the Charter in order to obtain compliance by the apartheid régime of South Africa with the relevant resolutions of the Security Council. In this connexion the Ghana Government is convinced that South Africa's blatant refusal to comply with the resolutions of the Security Council calls for the institution of total mandatory sanctions under Chapter VII of the Charter against the racist régime of South Africa. Such action is the only alternative course now open to the Security Council if it is to guarantee the international status of the territory of South West Africa and to ensure the right of self-determination of the indigenous people of the territory.

"As regards operative paragraph 4 Ghana's position remains as stated in its previous note of 25 January 1968, on the same subject, addressed to the Secretary-General.* It is the view of the Government of Ghana that the intent of operative paragraph 3 of resolution 246 (1968) was to request the Western Powers and the major trading partners of South Africa to exert their influence on the régime of South Africa to desist from its illegal action in respect of South West Africa. It is clear that without the support of these trading partners, South Africa will not persist in its flagrant defiance of United Nations resolutions."

JORDAN

"... the Government of Jordan does not maintain any relations whatsoever with the Government of South Africa. The Government of Jordan is ready to co-operate

with the Security Council in any manner the Council deems fit in order to obtain compliance by the Government of South Africa with the provisions of the afore-mentioned resolution." [246 (1968)]

THE PHILIPPINES

23 April 1968

"... inasmuch as the Philippines has no diplomatic or consular relations with the Republic of South Africa, it is unable to communicate directly with the Government of South Africa in order to obtain its compliance with the provisions of Security Council resolution 246 (1968). However, the Philippine Government has expressed at every opportunity its serious concern over the action taken by the Government of South Africa regarding the South West Africans concerned."

POLAND

"The Permanent Mission of Poland by its note of 29 February 1968, No. 44(DEK)-18-68,* has reaffirmed the unconditional support of Poland for the people of South West Africa in their struggle for freedom and independence.

"The Polish People's Republic has repeatedly expressed its full support for appropriate steps in the international arena aimed at the elimination of the system of colonialism and racial discrimination pursued by the régime of South Africa. In accordance with this basic stand Poland expressed its support for the Security Council resolution 245 (1968) and fully supports resolution 246 (1968) adopted by the Security Council on 14 March 1968. In view of the fact that the Polish People's Republic has no relationship of any kind whatsoever with the Republic of South Africa, it cannot exert any direct influence on the South African Government in order to obtain its compliance with the provisions of the Security Council resolution 246 (1968).

"Nevertheless, Poland will continue to make every effort in the international sphere and particularly in the United Nations in order to compel the racist régime

of South Africa to implement the pertinent resolutions of the General Assembly and the Security Council. Poland will also continue to support the just struggle of the people of South West Africa for their liberation from the colonial yoke."
