Note by the Secretary-General

1. By a communication dated 1 February 1972, the Secretary-General, in accordance with Article 5 of the Statute of the International Court of Justice, invited national groups to undertake the nomination of candidates for the election, to be held during the twenty-seventh regular session of the General Assembly, to fill the five vacancies in the International Court of Justice which will occur on 5 February 1973 when the terms of office of the following five members of the Court expire:

Sir Muhammad Zafrulla Khan (Pakistan)

Sir Gerald Fitzmaurice (United Kingdom of Great Britain and Northern Ireland)

L. Padilla Nervo (Mexico)

I. Forster (Senegal)

A. Gros (France)

In his communication the Secretary-General drew attention, <u>inter alia</u>, to the provision of Article 5, paragraph 1, of the Statute of the Court that nominations should be undertaken "within a given time", and he requested that nominations should be sent so as to reach him not later than 1 August 1972.
