Guinea, Somalia and Sudan: draft resolution

The Security Council,

<u>Recalling</u> resolution 314 (1972) in which the Security Council requested the Committee established in pursuance of Security Council resolution 253 (1968) to consider ways and means by which the implementation of sanctions might be ensured and to submit a report containing recommendations in this respect, including any suggestions that the Committee might wish to make concerning its terms of reference and any other measures designed to ensure the effectiveness of its work,

Having considering the special report of the Committee established in pursuance of Security Council resolution 253 (1968) (S/10632),

<u>Mindful</u> of the need to strengthen the machinery established by the Security Council in order to ensure proper implementation of the Council's relevant resolutions,

<u>Recalling further</u> that, as stated in previous resolutions of the Security Council, the present sanctions against Southern Rhodesia shall remain fully in force until the aims and objectives set out in resolution 253 (1968) are completly achieved,

<u>Gravely concerned</u> that certain States have not complied with the provisions of Security Council resolution 253 (1968), contrary to their obligations under Article 25 of the Charter of the United Bations,

1. <u>Reaffirms</u> the inalienable right of the people of Southern Rhodesia to self-determination and independence;

2. <u>Recognizes</u> the legitimacy of the struggle of the people of Southern Rhodesia to secure the enjoyment of their rights as set forth in the Charter and in conformity with the objectives of General Assembly resolution 1514 (XV);

3. <u>Takes note with appreciation</u> of the special report of the Committee established in pursuance of Security Council resolution 253 (1968);

4. <u>Approves</u> the recommendations and suggestions contained in section III of the special report;

5. <u>Calls upon</u> all States continuing to have economic and other relations with Southern Rhodesia to end such relations immediately;

6. <u>Demands</u> that all Member States should scrupulcusly carry out their obligations to implement fully Security Council resolutions 253 (1968), 277 (1970) and 314 (1972);

7. Condemns all acts violating the provisions of Security Council resolutions 253 (1968), 277 (1970) and 31h (1972);

8. <u>Calls upon</u> all States to co-operate fully with the Security Council in the effective implementation of sanctions and to give the Council all the necessary assistance that may be required of them towards the fulfilment of this task;

9. Again draws the attention of all States to the need for increasing vigilance in all matters relating to sanctions and, accordingly, urges them to review the adequacy of the legislation and the practices followed so far and, if necessary, to take more effective measures to ensure full implementation of all provisions of Security Council resolutions 253 (1968), 277 (1970) and 314 (1972);

10. <u>Requests</u> the Secretary-General to provide all appropriate assistance to the Security Council Committee established in pursuance of resolution 253 (1966) concerning the question of Southern Rhodesia in the discharge of its responsibilities.
