**Provisional calendar of conferences and meetings for 2004
and 2005 in the economic, social and related fields**

Note by the Secretariat**

Summary

In the present note, the Economic and Social Council is invited to approve the calendar of conferences and meetings for 2004 and 2005 in the economic, social and related fields. Information on meetings of related bodies and conferences and meetings of governing bodies of specialized agencies and the International Atomic Energy Agency is also provided. The attention of the Council is drawn to the relevant provisions of General Assembly resolutions 45/264, 46/235 and 50/227 on the restructuring and revitalization of the United Nations in the economic, social and related fields, which have been taken into account in the preparation of the calendar.

The Council is invited to consider further the biennialization of the sessions of its subsidiary bodies, in accordance with paragraph 2 (f) (ii) of its resolution 1988/77 and General Assembly resolution 50/206 A.

Attention is drawn to Council decision 1988/103, in which the Council decided to invite the Committee on Conferences to review the Council's draft calendar of conferences and meetings and submit, as appropriate, its recommendations thereon to the Council.

1. The provisional calendar of conferences and meetings in the economic, social and related fields for 2004 and 2005, contained in the annex to the present document, has been prepared in accordance with the relevant General Assembly resolutions, in particular resolutions 37/14 C, 39/68 B and D, 40/243, 41/177, 41/213, 42/207 B, 45/264, 46/235 and 50/227, and the relevant decisions and resolutions of the Economic and Social Council. Attention is drawn to the following decisions of the Council and the General Assembly:

(a) That the Council should hold an organizational session not to exceed four days' duration to be held in early February and a resumed organizational session at the end of April for one or two days, and that the Council should hold one substantive session of four weeks to take place in alternate years in New York and Geneva in July (Assembly resolutions 45/264 and 50/227);

(b) That all meetings of subsidiary and associated organs should conform to the Council's schedule of meetings and not vice versa (decision adopted at the Council's 1837th meeting, on 28 July 1972, at the fifty-third session);

(c) That the subsidiary bodies of the Council, with the exception of the regional commissions, may not create either standing or ad hoc intersessional subsidiary bodies without prior approval of the Council (rule 24, para. 2, of the rules of procedure of the Council);

(d) That the regular sessions of the Economic and Social Commission for Asia and the Pacific, the Economic Commission for Latin America and the Caribbean, the Economic Commission for Africa and the Economic and Social Commission for Western Asia, as well as meetings of their subsidiary bodies, may be held away from their headquarters when the commission concerned so decides, subject, in the case of regular sessions of the commissions, to the approval of the Economic and Social Council and the General Assembly (Assembly resolution 40/243, sect. I, para. 4 (f));

(e) To adopt, on a regular basis, a biennial cycle of meetings which would correspond to the programme budget cycle, for better administrative control (Council decision 281 (LXIII), para. (b));

(f) That (i) the regular sessions of the functional commissions and standing committees of the Council should normally have a duration of not more than eight working days; and (ii) once the calendar of meetings had been adopted by the Council, no additional meetings involving departures from the biennial cycle of meetings would be authorized during the biennium (Council decision 1979/81, paras. (b) to (d), and Assembly resolution 34/50) and that the waiver to the headquarters rule contained in Assembly resolution 40/243 is discontinued in the case of the functional commissions (Assembly resolution 49/221 A);

(g) That the Secretary-General should ensure that meetings of the subsidiary bodies of the Council would end at least eight weeks before the session of the Council at which their reports were to be considered (Council resolutions 1982/50, para. 1 (l), and 1988/77, para. 2 (f) (i)).

2. The Council's attention is drawn to the decision taken by the Committee on Conferences at its 154th meeting, on 11 March 1981, that in future, requests for intersessional departures from the calendar of conferences should only be submitted to the Committee for its consideration if accompanied by a presentation of detailed

substantive arguments supporting a proposed change in or an addition to the calendar. The Committee also decided to request the Secretariat to inform the Committee, as far in advance as possible, of the need for a postponement of sessions of United Nations bodies, together with a presentation of the substantive reasons necessitating a delay.

3. The Council may recall that in its decision 1992/214 of 7 February 1992 it decided to grant authority to its Bureau to approve intersessional departures from its approved calendar of conferences and meetings in respect of its subsidiary bodies when the Council was not in session and after consultation with the Committee on Conferences.

4. The Council may also recall that in paragraph 2 (f) (ii) of its resolution 1988/77, it decided to further continue to consider the biennialization of the sessions of its subsidiary bodies. The subsidiary bodies of the Council have biennialized their meeting schedules, with the exception of:

(a) Commission on Human Rights and one of its working groups; and the Subcommission on the Promotion and Protection of Human Rights and its four working groups;

(b) Commission on the Status of Women;

(c) Commission on Narcotic Drugs and the Subcommission on Illicit Drug Traffic and Related Matters in the Near and Middle East;

(d) Commission on Crime Prevention and Criminal Justice;

(e) Commission on Sustainable Development;

(f) Commission on Population and Development;

(g) Commission for Social Development;

(h) Commission on Science and Technology for Development;

(i) Statistical Commission;

(j) United Nations Forum on Forests;

(k) Economic Commission for Africa;

(l) Economic and Social Commission for Asia and the Pacific;

(m) Economic Commission for Europe;

(n) Committee for Programme and Coordination;

(o) Committee on Non-Governmental Organizations;

(p) Committee for Development Policy;

(q) Committee on Economic, Social and Cultural Rights and its pre-sessional working group;

(r) Permanent Forum on Indigenous Issues.

5. The Council may wish to take the opportunity of its review of the provisional calendar to consider further the question of the biennialization of its subsidiary bodies in the context of its review of the mandates, composition, functions and

working methods of its functional commissions and expert groups and bodies (see Council resolution 1996/41 and Assembly resolution 50/227).

6. The Council's attention is drawn to Council decision 1988/103, in which the Council decided to invite the Committee on Conferences to review the Council's draft biennial calendar of conferences and meetings, beginning with the calendar for 1990-1991, and submit, as appropriate, its recommendations thereon to the Council. Such recommendations as the Committee on Conferences may have will be placed before the Council.

7. The Council will consider the following request of its subsidiary body for a change in their normal pattern of sessions, not listed in the annex, at its current session:

A request from the Committee of Experts on Public Administration to meet annually from 2005.

8. The mandates of the following working groups, not listed in the annex, are to be renewed by the Economic and Social Council at its current session:

(a) Working Group on Arbitrary Detention (see Council decision 2000/263 for the most recent mandate);

(b) Working Group on Enforced or Involuntary Disappearances (for sessions in 2005, see Council decision 2001/221 for the most recent mandate);

(c) Working Group on a draft United Nations declaration on the rights of indigenous people;

(d) Working Group on Structural Adjustment;

(e) Working Group on the Right to Development;

(f) Working Group on People of African Descent;

(g) Working Group on Implementation of the Durban Declaration and Programme of Action;

(h) Working Group on a draft optional protocol to the International Convention on Economic, Social and Cultural Rights.

9. In the preparation of the provisional calendar, due regard has been taken of General Assembly resolution 53/208 A, in particular paragraph 11, whereby it was decided that United Nations bodies should be invited to avoid holding meetings on Orthodox Good Friday and that this arrangement should be taken into account when drafting future calendars and meetings. For the next biennium, Orthodox Good Friday occurs on 9 April 2004 and 29 April 2005.
