Annotations

1. Opening of the Conference

In its decision 2002/229 of 23 July 2002, the Economic and Social Council decided to accept the offer of the Government of Japan to host the Sixteenth United Nations Regional Cartographic Conference for Asia and the Pacific. The Conference will be held in the Okinawa Convention Centre, Okinawa, Japan, from 14 to 18 July 2003.

2. Election of the President and other officers of the Conference

Rule 5 of the provisional rules of procedure of the Conference (E/CONF.95/2) provides that the Conference shall elect a President, two Vice-Presidents and a Rapporteur from among the representatives of the States participating in the Conference.

3. Objectives of the Conference

The primary objective of the Conference is to provide a regional forum where governmental decision-makers, planners, scientists and experts from Asia and the Pacific and other regions may meet to report on the efforts being accomplished in the development and implementation of national spatial data infrastructures in Asia and the Pacific, and to address the common needs, problems and experiences in the field of surveying and mapping, remote sensing, land and geographic information systems, and other geo-spatial technologies and applications, including educational and training aspects, scientific and technological requirements, implementation issues and benefits.

4. Organizational matters

(a) Consideration and adoption of the rules of procedure

The Conference will have before it for consideration and adoption the provisional rules of procedure, as contained in document E/CONF.95/2.

(b) Adoption of the agenda

The Conference will have before it for approval the provisional agenda for the Sixteenth United Nations Regional Cartographic Conference for Asia and the Pacific, as contained in document E/CONF.95/1, which was adopted at the Fifteenth United Nations Regional Cartographic Conference for Asia and the Pacific, held in April 2000 in Kuala Lumpur, as well as annotations to the provisional agenda and proposed organization of work, as contained in the present document.

(c) Establishment of technical committees and election of chairmen and rapporteurs

Rule 37 of the provisional rules of procedure (E/CONF.95/2) provides that the Conference may establish such committees as may be necessary for the performance of its functions. It is proposed that the Conference establish three technical committees (technical committees I, II and III) to consider various issues and submit draft proposals to the Conference for consideration and adoption.

In accordance with rule 38 of the provisional rules of procedure and the established practice of past United Nations Regional Cartographic Conferences for Asia and the Pacific, the Conference shall elect chairmen of the three technical committees, and shall authorize the committees to elect their vice-chair and rapporteur, as may be required. It is recommended that the Sixteenth United Nations Regional Cartographic Conference should, like previous Conferences, follow the standard practice of United Nations conferences whereby an agreement is reached on the slate of candidates for the posts prior to the opening of the Conference in order that the candidates may be elected without a vote, by acclamation.

(d) Organization of work

The proposed organization of work for the Conference, which is set out in the present document, should be regarded as indicative. The Conference may make adjustments to it, as required.

The Conference shall meet from Monday, 14 July, to Friday, 18 July 2003. The interpretation resources and meetings facilities will be available for two formal meetings each day, one in the morning and one in the afternoon. The meeting hours

will normally be from 9 a.m. to 12 p.m. and from 2 p.m. to 5 p.m. In order to ensure the most efficient use of available resources, it is essential that all meetings start promptly at the time scheduled.

(e) Credentials of representatives to the Conference

Rule 3 of the provisional rules of procedure provides that the President and the Vice-Presidents shall examine the credentials of the representatives to the Conference and shall report to the Conference without delay. It had been the practice for previous Conferences to establish a Credentials Committee, which examined the credentials of the representatives and reported to the plenary.

8. Technical committees of the Conference

It is proposed that the Conference establish three technical committees: technical committee I: Development needs and institutional capacity-building; technical committee II: Fundamental data: their collection and management in an integrated approach; and technical committee III: Spatial data infrastructures and their development in Asia and the Pacific. The committees should discuss various issues and submit proposals to the Conference for consideration and action.

In accordance with the proposed organization of work, the committees are scheduled to meet on Thursday, 17 July, in the afternoon, in parallel sessions.

9. Reports and resolutions

(a) Reports of the technical committees of the Conference

The technical committees should report to the plenary on their work.

(b) Adoption of reports and action plans

Following its adoption of the reports prepared by the technical committees, the Conference should propose action plans for their future work.

(c) Adoption of resolutions

The Conference will consider for adoption draft resolutions recommended by the technical committees.

10. Review of the achievements of the Conference

The Conference will review the achievements accomplished during its session.
