List with commentaries of possible studies to be undertaken by members of the Working Group in the immediate and near future, submitted by Miguel Alfonso Martínez

- 1. In its resolution 2002/21, the Sub-Commission on the Promotion and Protection of Human Rights invited Mr. Alfonso Martínez to prepare a list with commentaries on possible studies to be undertaken by members of the Working Group on Indigenous Populations in the immediate and near future, to be submitted to the twenty-first session of the Working Group. The list contained in the present document includes the proposals recorded in the reports of the Working Group at its fifteenth to twentieth sessions (1997-2002), as well as those received directly by the Office of the High Commissioner for Human Rights.
- 2. The author is of the opinion that priority should be given to the undertaking of studies on the following general issues:
- (a) Obstacles to the promotion, actual implementation and effective protection of the rights of indigenous peoples, including their human rights;

- (b) The impact of the process of globalization (including the activities of transnational corporations) on the lives of indigenous peoples;
- (c) Actual performance of existing national and international monitoring mechanisms in matters relating to the promotion, implementation and protection of indigenous peoples' rights;
- (d) Ways and means of establishing or further developing effective national mechanisms of conflict prevention and conflict resolution on issues or actual situations affecting indigenous peoples.
